**Hong Kong Ethnic-Pakistani Residents Being Refused to Establish Bank Accounts**

Thank you for your letter addressed to our Chairman Mr Benjamin Hung dated 9 February 2010.

Please note that banks in Hong Kong will follow applicable guidelines and international best practices in developing their account opening policies. When establishing any new customer relationship, banks will conduct due diligence checks to better understand the background of the prospective customer. Whether or not a new account is to be opened is the commercial decision of individual banks.

In light of the Race Discrimination Ordinance (RDO), Cap 602, which came into operation on 10 July 2009, we have written to all member banks to remind them to review their business practices to ensure they comply with the RDO and other anti-discrimination legislation. In particular, we have encouraged members to provide guidelines to their staff in applying equal treatment to customers of all races.

We trust that our member banks should put in place an equal opportunities policy and have today circulated copies of our exchange of correspondence to all member banks for information. For specific cases of account opening by individual customers, please follow up with the banks concerned and we trust that they would handle such cases fairly and promptly.


