5. The Bills Committee noted that by the definition of "road" in the Bill, the proposed idling prohibition would apply to all motor vehicles on private roads as

Admin well as on other roads, including any car parks. The Bills Committee requested the Administration to clearly explain to the public the areas covered by the Bill (in particular car parks wherein posters and notices should be posted to remind drivers of the idling prohibition) after enactment of the Bill. The Administration agreed to follow up.

Admin 6. The Bills Committee considered that Schedule 1 to the Bill, which set out the circumstances in which the idling prohibition did not apply, was most important and any amendments to Schedule 1, after enactment of the Bill, should be subject to scrutiny by the Legislative Council (LegCo) under the positive vetting procedure. The Administration agreed to consider the request and revert at the next meeting.

7. Some members urged the Administration to grant further exemptions from the idling prohibition as follows:

- (a) To all drivers on days when the "Thunderstorm Warning" was issued;
- (b) To all drivers during the hot months of a year; and
- (c) To all drivers during days of heavy rain (though not up to the triggering point for the issue of a rainstorm warning signal).

8. The Administration responded that a wide range of exemptions had already been proposed in the Bill, such as a three-in-sixty-minute grace period as well as an extensive list of exemptions, to cater for the specific operational requirements of different transport trades. At recent meetings, the Administration had further proposed to grant exemption to all taxi stands, and to all drivers on days when the "Very Hot Weather Warning" or the "Amber, Red or Black Rainstorm Signal" were issued. The Administration explained that there was also difficulty in defining circumstances that would be regarded as heavy rain, whereas the current proposal of granting exemption when an Amber, Red or Black Rainstorm warning signal was in force would facilitate enforcement and avoid disputes. The Administration also reminded members to note that the number of days with rain amounted to some two-thirds of a year based on past records. As regards the suggestion of granting exemption to all drivers when the "Thunderstorm Warning" was issued, the Administration explained that this was not proposed as there might not be rain when there was a thunderstorm.

9. The Administration also explained that the proposed exemption during hot months, say, from July to October, was not preferred because some of the

days during these months were not very hot and granting a blanket exemption was not justifiable. On the other hand, if this exemption was adopted in place of the proposed "Very Hot Weather Warning" exemption, the blanket exemption could not be applied on any hot day even with the "Very Hot Weather Warning" issued if such a day fell outside the exempted months. The Administration considered that the targeted approach currently proposed by the Administration in drawing up exemption arrangements would better help deliver the objectives of the Bill and cater to the specific needs of the transport trades.

10. Some members including Hon CHAN Kam-lam and Hon Miriam LAU opined that many of the exemptions were for professional drivers only. They pointed out that drivers of general private cars might be aggrieved if there was insufficient flexibility in implementing the idling prohibition, and that the exemption of a three-in-sixty-minute grace period, though applicable to all drivers, might be too short to cater for their practical needs in real-life situations (e.g. the medical needs of a pregnant woman in the car).

Follow-up actions required of the Administration

- Admin 11. The Administration was requested to take the following actions to address concerns raised by members at the meeting –
- (a) To consider amending clause 32 to provide that Schedule 1 to the Bill would be amended under the positive vetting procedure. If the negative vetting procedure was to be adopted, the Administration was required to ensure that (i) the commencement date for any amendment should take place after the expiry of its vetting period, (ii) the relevant Panel(s) be thoroughly consulted on any proposed amendments to Schedule 1, and (iii) the Bill should clearly provide that LegCo would have the power to repeal or amend the relevant subsidiary legislation where necessary;
 - (b) To consider amending the proposed new section 1(2) of Schedule 1 to put it beyond doubt that exemption would apply in the following situations: vehicles queuing up for entry into a car park, a container terminal, a landfill or a petrol filling station. Consideration might be given to amending section 1(2) along the lines that "traffic conditions that may include" instead of quoting examples. The examples given in section 1(2) should, instead, be included in the relevant publicity materials;
 - (c) To consider amending section 2(1) of Schedule 1 to provide that

section 5 would not apply to a driver of a taxi that was stationary in a queue of taxis into a taxi stand or within the designated area of a taxi stand;

- (d) To consider amending section 2(4)(a) of Schedule 1 by deleting the phrase ",other than a franchised bus";
- (e) To consider members' request for the Secretary for the Environment to include in his speech at the resumption of the Second Reading debate on the Bill an explanation of the vehicles intended to be covered under proposed section 7 of Schedule 1 to the Bill, including trucks installed with the tail-board. Information on the vehicles to be covered under proposed section 7 of Schedule 1 should also be included in the relevant publicity materials;
- (f) To consider some members' suggestions of granting further exemption as follows:
 - (i) To all drivers on days when the "Thunderstorm Warning" was issued; and
 - (ii) To all drivers during hot months;
- (g) To address some members' concerns that private car drivers had expressed the view that the proposed exemption arrangements had failed to take into account their practical needs in real-life situations, e.g. picking up children on rainy days and the waiting time exceeded three minutes; and
- (h) To provide details of the arrangements planned for dissemination of real-time information to drivers on the issue of the "Very Hot Weather Warning" or "Amber, Red or Black Rainstorm Signal".

Date of next meeting

12. Members agreed to cancel the meeting originally scheduled for 22 December 2010 and to hold the next meeting on Thursday, 13 January 2011, at 8:30 am.
