The estimated expenses under Head 21 relating to the upkeep of existing energy-saving devices and the installation of new energy-saving devices for Government House and Fanling Lodge are \$119,500 for 2009-10 (revised estimate) and \$37,000 for 2010-11.

Question:

What are the reasons for the reduced requirements for expenses under special appointments?

Asked by: Hon. LAU Wai-hing, Emily

Reply:

The estimated provision for special appointments is \$8.913 m for 2010-11, lower than the revised estimate of \$10.001 m for 2009-10. The drop relates to –

- (a) end-of-contract gratuities – these were due in 2009-10 in relation to three officers (namely, Information Coordinator, Senior Special Assistant and Personal Assistant to the Director of the Chief Executive's Office). We have not set aside like provision for 2010-11; and
- (b) provision for salaries – the estimated provision for 2010-11 is lower than the estimate for 2009-10 to reflect the 5.38% pay cut applicable to officers above the Master Pay Scale 33.
