The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. The Administration and Tate's Cairn Tunnel Company Limited (TCTC) briefed members on TCTC's decision that it would not be able to provide promotional discounts for public buses as requested by members. Mr WONG Kwok-hing and Mr CHEUNG Hok-ming expressed disappointment at the response, and urged TCTC to reconsider members' request in the light of the following –

- (a) Similar to public light buses which would be exempted from the toll increase, buses were providing a mass transport service;
- (b) TCTC was making a profit; and
- (c) The income foregone for TCTC if promotional discounts were offered to public buses was estimated to be \$1.7 million, which was insignificant when compared to the possible bus fare increase consequent to the toll increases.

3. TCTC responded that its decision was made after carefully weighing TCTC's financial position against those of franchised bus operators, and emphasized that while the average toll increase rate was 5.9%, the toll increase rate for double-decker bus was only 3%. In fact, the toll increase had in general already been minimized after taking into due consideration the interests of all parties concerned, in particular public interest.

Examination of the Notice

4. The Subcommittee noted the content of the Notice.

The way forward

5. The Subcommittee completed its deliberations on the Notice and agreed to report its deliberations to the House Committee at its meeting on 2 July 2010. The Chairman advised that since the scrutiny period of the Notice would expire on 23 June 2010 if not extended, she would move a motion at the Council meeting on 23 June 2010 to extend the scrutiny period to 14 July 2010. She further advised that the deadline for giving notice of minor technical amendments to the Notice, if any,
