I. Consultation Document on Methods for Selecting the Chief Executive and for Forming the Legislative Council in 2012

[Consultation Document on Methods for Selecting the Chief Executive and for Forming the Legislative Council in 2012 and Statement by the Chief Secretary for Administration on "Consultation Document on Methods for Selecting the Chief Executive and for Forming the Legislative Council in 2012" at the Council meeting on 18 November 2009]

Oral presentation by deputations/individuals

Members noted that this was the last special meeting scheduled by the Panel to receive views from the deputations/individuals which/who had requested to make submissions on the Consultation Document on Methods for Selecting the Chief Executive ("CE") and for Forming the Legislative Council ("LegCo") in 2012 ("Consultation Document"). A summary of the views given by deputations and individuals on the Consultation Document is in the **Appendix**.

Administration's response to the views of deputations/individuals

Issues regarding universal suffrage

2. Secretary for Constitutional and Mainland Affairs ("SCMA") expressed disagreement with the views of Mr WONG Kai-hing of Hong Kong Polytechnic University Students' Union and Ms LEUNG Yuk-fung that the Administration's proposals for the two electoral methods for 2012 were retrogressive. Neither did he subscribe to Mr LAU Chun-yip's view that the Administration had not tried its utmost to advance Hong Kong's democratic development. He pointed out that the Administration had succeeded in securing a timetable for implementation of universal suffrage. According to the decision made by the Standing Committee of the National People's Congress ("NPCSC") on 29 December 2007 on issues

relating to the methods for selecting CE and for forming LegCo in 2012 and on issues relating to universal suffrage ("the 2007 NPCSC Decision"), universal suffrage for CE and LegCo could be implemented in 2017 and 2020 respectively. Furthermore, when compared with the package of proposals put forth in 2005, the Administration had further enhanced the democratic elements of the two elections by proposing to exclude appointed District Councils ("DC") members' participation in the election of representatives of DCs to the Election Committee ("EC") and LegCo.

3. Noting the call for the implementation of dual universal suffrage in 2012 from the representatives of the students unions of various universities and the Civil Human Rights Front, SCMA said that in the light of the 2007 NPCSC Decision, there was no constitutional basis for further pursuing the implementation of universal suffrage in 2012. He elaborated that the report submitted by CE to NPCSC on 12 December 2007 on the two electoral methods for 2012 ("the CE Report") had reflected faithfully the views of different sectors of the community on the issue of universal suffrage received during the public consultation period, including that more than half of the public supported the implementation of universal suffrage for CE and LegCo in 2012. At the same time, about 60% of the public accepted the implementation of universal suffrage for CE in 2017 and more than half of the public accepted the implementation of universal suffrage for LegCo in 2016 or thereafter, if universal suffrage for the two elections could not be attained in 2012. Having considered the CE Report, NPCSC made a decision on 29 December 2007 that universal suffrage for CE and LegCo could be implemented in 2017 and 2020 respectively. Under Article 62 of the Constitution of the People's Republic's of China, it was for the National People's Congress to determine systems to be practised in a Special Administrative Region. Thus, when NPCSC made the Decision in 2007 that CE could be returned through universal suffrage in 2017 and LegCo in 2020, the Decision had constitutional status and had legal effect. He further said that the timetable for universal suffrage provided in the 2007 NPCSC Decision had provided a clear basis and direction for the constitutional development of Hong Kong. While some people might not consider 2017/2020 to be the most ideal timetable, there was only a difference of one term between the years 2012 and 2017. He hoped that the whole community would take this timetable as the basis for rolling forward democracy in Hong Kong.

4. On the comment made by Mr LEE Yiu-kee of the Civil Human Rights Front that the implementation of universal suffrage should accord with paragraph (b) of Article 25 of the International Covenant on Civil and Political Rights ("ICCPR"), SCMA said that while the Basic Law ("BL") provided that provisions of ICCPR as applied to Hong Kong should remain in force, the Central People's Government had notified the United Nations Secretary-General in clear terms in June 1997 that the reservation entered into by the United Kingdom Government in 1976 in respect of paragraph (b) of Article 25 of ICCPR would

continue to apply to the Hong Kong Special Administrative Region ("HKSAR") after the establishment of the SAR. Nevertheless, the Administration had made clear that in attaining universal suffrage for CE and LegCo, the principles of universality and equality must be complied with.

5. Referring to Mr Rock CHEN's comment that Hong Kong's constitutional development should not stall, SCMA said that had the package of proposals put forth by the Administration in 2005 been implemented, the two electoral methods for 2007/2008 would have progressed democratically. The Administration sincerely hoped that there would be progress in the two electoral methods for 2012. However, even if no progress could be made for the electoral methods for 2012, universal suffrage for CE could still be implemented in 2017.

6. Noting Mr NG Hi-on's agreement with the Administration that it should focus on dealing with the two electoral methods for 2012 in the Consultation Document, SCMA said that the Administration was aware that some political parties and some individuals and organisations in the community hoped that discussion on universal suffrage models for 2017/2020 could commence as soon as possible. The current-term HKSAR Government would summarise and conclude any views relating to universal suffrage received during the current public consultation exercise for the consideration of the Fourth-term and Fifth-term HKSAR Government.

Method for electing CE in 2012

7. In response to the view expressed by Miss CHOW Ching of the Hong Kong Federation of Students that the Administration's proposal of increasing the number of members of EC from 800 to 1 200 would not inject any democratic elements into the CE election, SCMA said that the Administration's proposal of expanding the membership size of EC to 1 200 and increasing the number of members of the four sectors of EC by the same proportion would help uphold the principle of balanced participation. As the composition of EC might be used as the basis for that of the nominating committee when universal suffrage for CE was implemented in 2017, the Administration's proposal would ensure that the CE elected through universal suffrage would have the broad support of different sectors of the community.

8. Referring to the views of Mr CHEUNG Yan-hong and Mr SIU Yu-ken that all the proposed new seats for the fourth sector of EC should be allocated to DC members, SCMA clarified that under the Administration's proposal for the 2012 CE election, most, and not all, of the 100 new seats for the fourth sector should be allocated to DC members. The remaining seats could be allocated to other subsectors within the fourth sector, such as Heung Yee Kuk and the Chinese People's Political Consultative Conference.

9. On Mr CHEUNG Yan-hong's proposal of replacing "corporate votes" with "director's/ executive's/ association's/ individual votes" in the two electoral methods for 2012, SCMA said that the Administration was inclined not to adopt such a proposal as there were divergent views on the issue and it would be difficult to forge consensus both within and outside LegCo.

10. Noting that Ms POON Wai-fong of 惠妍芳婦女會 was supportive of the Administration's proposal of maintaining the existing requirement that CE should not have any political affiliation, SCMA said that the proposal reflected the public's views that the requirement could ensure that CE would maintain impartiality when dealing with requests from different political parties. He added that while CE did not have any political affiliation, he would continue to be the most important political figure in Hong Kong, as he would have to work with different political parties and organisations in handling political matters in Hong Kong.

11. As regards the view of Mr FONG Chi-fai that consideration should be given to lowering the nomination threshold for the CE election from one-eighth to one-tenth of the total membership of EC, SCMA said that the Administration considered it appropriate to maintain the current threshold as it already could allow sufficient competition. Should the membership size of EC be expanded to 1 200 as proposed by the Administration, the Administration believed that persons from different political backgrounds, including those from the pan-democratic camp, would be able to secure the required support from 150 EC members (i.e. one-eighth of 1 200 members).

Method for forming LegCo in 2012

12. SCMA disagreed with the view of Miss So Pui-man of the Lingnan University Students' Union that the Administration's proposal of increasing the number of LegCo seats from 60 to 70 would not bring about any democratic progress. He pointed out that the Administration's proposal aimed at freezing the 29 "traditional" functional constituency ("FC") seats, while expanding the number of the DC FC seat which had the broadest electorate base among existing FCs. The Administration reckoned that such a proposal could have a higher chance of being accepted by two-thirds of LegCo Members.

13. On Ms LAM Yau-han's proposal that all the 10 new LegCo seats be returned by geographical constituencies ("GCs") through direct elections, SCMA said that the proposal did not comply with the 2007 NPCSC Decision that the half-and-half ratio for Members returned by FCs and Members returned by GCs through direct elections should be maintained.

14. Regarding the comment made by Mr WONG Chun-kin of the City University of Hong Kong Students' Union on the narrow electorate base of FCs, SCMA said that the Administration had strived to expand the electorate base of FCs by proposing to increase the number of DC FC seats from one to six and to have all such seats returned through election by elected DC members from among themselves. Such a proposal would expand the electorate base of FCs as elected District Councillors had a broad electorate base of over 3.3 million registered voters.

15. SCMA noted that Mr LAI Yan-ho of the Student Union of the Chinese University of Hong Kong had queried why the Administration proposed to retain FCs in its proposals for the 2012 LegCo election even though it had acknowledged that the FC system in its present form did not comply with the principles of universal and equal suffrage. SCMA pointed out that it was required by the NPCSC Decision that there should be a half-and-half ratio for Members returned by FCs and Members returned by GCs through direct elections. Under the framework of the NPCSC Decision, the Administration had strived to enhance the democratic elements of the 2012 LegCo election so that close to 60% of the seats in LegCo would be returned by GCs through direct or indirect elections. Further progress could be made in the 2016 LegCo election, paving way for the implementation of universal suffrage in 2020. SCMA further explained the constitutional arrangements for amending the two electoral methods in Hong Kong. He pointed out that although Hong Kong was not an autonomous state, it enjoyed a high degree of autonomy and could take certain initiatives to advance Hong Kong's constitutional development. Under the relevant constitutional arrangements, CE could make a report to NPCSC as to whether there was a need to amend the two electoral methods. After a determination had been made by NPCSC, the HKSAR Government could introduce motions on amendments to the two electoral methods to LegCo. Should such amendments be endorsed by a two-thirds majority of all LegCo Members and subject to the consent of CE, the relevant bill should be reported to NPCSC for approval or for the record.

16. Noting that Mr WONG Kwan and Mr Gary LUNG of 善為扶貧助學會 had indicated support for the Administration's proposal of having all the five new FC seats returned through election by elected DC members from among themselves in 2012, SCMA pointed out that should such a proposal be adopted, 41 of the 70 seats in LegCo would be returned by GCs through direct or indirect elections. SCMA further said that while some deputations/individuals attending the meeting including Ms YUNG Wing-sheung and Mr KWOK Chung-man of 逸東社區網絡協會 had expressed objection to the proposal, it was indisputable that elected DC members had a very broad electorate base of over 3.3 million registered voters. He also stressed that when the next DC election was held in 2011, voters would know clearly then that the DC members they voted for could be elected to join EC or LegCo. As regards the election method for returning

elected DC members to the six DC FC seats, SCMA said that the Administration had not put forth any proposal in this regard and would welcome the views of different political parties and members of the public.

17. Referring to Ms TAM Miu-fan's view that FCs should be retained, SCMA said that in accordance with the 2007 NPCSC Decision, the half-and-half ratio between Members returned by FCs and Members returned by GCs through direct election should remain unchanged for the 2012 LegCo election. However, the community should continue to discuss the future of FCs beyond 2012.

18. As regards the view of Ms CHENG So-ngor and Ms CHIU Fung-yi that the five new GC seats should be allocated on the basis of seat-to-population ratio, SCMA said that should the Administration's proposal of expanding the number of LegCo seats be approved, detailed arrangements on the delineation of GCs would be discussed in the context of the amendments to be made to the Legislative Council Ordinance (Cap. 542) and other relevant legislation.

19. Noting that the Kowloon City District Resident Association had expressed support for the Administration's proposal of maintaining the existing arrangement of allowing permanent residents of Hong Kong who were not of Chinese nationality or who had the right of abode in foreign countries to stand in the elections for 12 FC seats, SCMA said that the Administration had proposed to maintain the existing arrangement as it reflected Hong Kong's cosmopolitan and pluralistic nature and allowed LegCo to attract talents from different backgrounds.

Other issues

20. While noting Ms Yung Wing-sheung's objection to the ex-officio DC membership of chairmen of the Rural Committees, SCMA said that in considering the membership of the New Territories DCs, it was necessary to take into account the historical background of the New Territories. He added that a democratic election system was in place for the election of village representatives in the New Territories.

21. On the proposals made by Mr KWOK Chung-man of 逸東社區網絡協會 to change the existing "single seat, single vote" election system of DCs, SCMA said that the existing election system had been used for many years. He believed that it would be very difficult to forge consensus on proposals which sought to introduce significant changes to the existing election system of DCs.

22. In response to CHAN Chung-kit's question as to whether the Administration had taken stock of the experience in constitutional development since the handover, SCMA said that in the report on the Green Paper on Constitutional Development and the CE Report published in 2007, the

Administration had summarised the constitutional development in Hong Kong since the handover. In the recently released Consultation Document, the Administration had also given a summary of the views received over the past few years on the two electoral methods for 2012.

23. SCMA said that he shared the view of Ms CHAU Chuen-heung that it was important to roll forward democratic development in the 2012 elections so as to pave the way for the implementation of universal suffrage for CE in 2017. He further said that the CE elected in 2012 and the LegCo formed in 2012 would work together to address the issues regarding the specific model for implementing universal suffrage for CE in 2017. As for the model for implementing universal suffrage for LegCo in 2020, the CE returned by universal suffrage in 2017 would work with the LegCo formed in 2016 to deal with the matter.

Discussion

Functional constituencies

24. Noting the proposal of Mr CHAU ON Ta-yuen of the Hong Kong Federation of Fujian Associations to allocate two of the five new FC seats to the Hong Kong Federation of Guangdong Associations and the Hong Kong Federation of Fujian Associations respectively, Ms Cyd HO sought clarification from Mr CHAU ON as to whether it was his view that FC seats should also be allocated to people of other provincial origins such as Shanghai. Mr CHAU ON responded that he had so proposed having regard to the significant contributions to the Hong Kong community made by these two Associations in their long history. The same criterion could be used in considering whether FC seats should be allocated to associations representing people of other provincial origins.

25. Ms Cyd HO further said that Mr CHAU ON Ta-yuen's proposal of creating FC seats for people of certain provincial origins followed the logic of FCs which sought to divide Hong Kong people into different groups. She invited SCMA to respond to Mr CHAU ON's proposal.

26. SCMA said that while he appreciated that the Hong Kong Federation of Guangdong Associations and the Hong Kong Federation of Fujian Associations had a long history and sizeable memberships, the Administration had made clear its position that no new traditional FCs would be created. The Administration welcomed the two Associations to field candidates to participate in the 2012 LegCo election through FCs or GC direct elections. The Associations could also field candidates to stand for the DC elections. Under the Administration's proposals, elected DC members could elect among themselves representatives to fill the six DC FC seats.

27. Mr Paul TSE considered it unfair to deny altogether the value of the FC system merely on account of the unsatisfactory performance of certain FC Members. He pointed out that many FC Members had discharged their duties conscientiously and made significant contributions to the community. He criticised the Administration for not having reformed the FC system earlier to make it better able to meet the needs of the community

Methods for selecting CE in 2012

28. In response to Mr WONG Ting-kwong's invitation to elaborate his views, Mr CHAN Chi-ho of Hong Kong Youth Think-Tank said that more progressive proposals should be put forth for the CE election in 2012 so as to pave way for the implementation of universal suffrage for CE in 2017. For instance, to make EC more broadly representative, its composition should include representatives from the elderly, women, students, persons with disabilities and ethnic minorities. SCMA said that the Administration welcomed views on the composition of EC. Noting that Mr SZE Wine-him had also proposed to create a subsector for youths in EC, SCMA said that the Administration would consider the views of Mr CHAN Chi-ho and Mr SZE Wine-him and see whether there was any room for expanding the subsectors in the third sector of EC.

29. Ms Emily LAU opined that only one-person-one-vote could ensure genuine balanced participation. She invited Mr SZE Chin-hung of the Fukienese Association Ltd. to elaborate his views on balanced participation. Mr SZE Chin-hung said that in respect of the CE election, given that the EC in 2012 might be transformed into the nominating committee when universal suffrage for CE was implemented, it was important to uphold the principle of balanced participation in the composition of EC. It was for that reason that he had expressed reservation about the Administration's proposal of allocating most of the 100 new seats in the fourth sector of EC to DC members.

Other issues

30. In response to Mr WONG Ting-kwong's invitation to elaborate his views, Mr Rock CHEN said that many opinion polls had revealed that the majority of the public wanted to break the stalemate in constitutional development and roll forward the electoral system towards universal suffrage. He urged the Administration to listen to views expressed by different sectors of the community with a view to forging consensus.

31. Mr LEUNG Kwok-hung noted that Mr CHOY Chak-man had expressed disappointment at the Members who had planned to resign in order to bring about a "de-facto referendum" to demand for universal suffrage ("mass resignation plan"), as these Members by doing so would no longer be able to represent members of the public who had voted them into LegCo. Mr LEUNG said that

his voters had asked him to fight for the implementation of genuine dual universal suffrage in 2012, the drawing up of the timetable and roadmap for universal suffrage as soon as practicable and the abolition of FCs, and had expressed support for his resignation. In resigning, he was being accountable to his voters. In contrast, CE was only accountable to the 800 members of EC who elected him and did not have public mandate. SCMA, however, said that in expressing objection to the mass resignation plan, Mr CHOY Chak-man had reflected a prominent view of members of the public.

32. The meeting ended at 6:02 pm.
