1. Revitalization review of industrial estate and its admission criteria

At the Panel meeting held on 6 July 2004, the Administration was requested to conduct a review on the policy and procedures concerning the admission of industries into the industrial estates and the measures to ensure a level playing field and equitable treatment for interested parties seeking entry into the industrial estates. Members requested the Administration to report the outcome of the review to the Panel in due course. The Administration advised in June 2008 that the Hong Kong Science and Technology Parks Corporation (HKSTPC), which managed the industrial estates, was progressing with a strategic study on the revitalization of the industrial estates. The study would review, amongst other things, the admission criteria to the industrial estates and the admission mechanism. The study would be completed in February 2010. The Administration would revisit relevant issues and provide a comprehensive report to the Panel after HKSTPC's consultancy study was completed.

2. Three-year development plan for the testing and certification industry by the Hong Kong Council for Testing and Certification (HKCTC)

The Administration will brief members on the three-year development plan for the testing and certification industry proposed by the HKCTC and the Administration's response.

The Administration will report to the Panel the progress made in encouraging early migration to ROCARS.
