To introduce subsidiary legislation under the Waste Disposal Ordinance (Cap. 354), namely, the Waste Disposal (Clinical Waste) (General) Regulation and the Waste Disposal (Charges for Disposal of Clinical Waste) Regulation, plus two sets of Code of Practice on clinical waste management for the implementation of the Clinical Waste Control Scheme.
