## Land Registry statistics for July 2010

\*\*\*\*\*

The Land Registry today (August 3) released its statistics for July 2010.

### Land Registration

- The number of sale and purchase agreements for all building units received for registration in July 2010 was 14,885 (+33.8% compared with June 2010 and +6% compared with July 2009)
- The 12-month moving average for July 2010 was 12,770 (this was 0.6% above the 12-month moving average for June 2010 and 50.4% above that for July 2009)
- The total consideration of sale & purchase agreements in July 2010 was \$60.4 billion (+40.3% compared with June 2010 and +12.8% compared with July 2009)
- Among the sale & purchase agreements, 12,957 were for residential units (+41.9% compared with June 2010 and +7.8% compared with July 2009)
- The total consideration for sale & purchase agreements in respect of residential units was \$52.2 billion (+58.1 compared with June 2010 and +19.8% compared with July 2009)

Sales of residential units refer to the sale and purchase agreements with payment of stamp duty. These statistics do not include sales of units under the Home Ownership Scheme, the Private Sector Participation Scheme and the Tenants Purchase Scheme except those after payment of premium.

Figures on sale and purchase agreements received for the past 12 months, the year-on-year rate of change and breakdown figures on residential sales are also released.

As deeds may not be lodged with the Land Registry until up to 30 days after the transaction, these statistics generally relate to land transactions in the previous month.

### Land Search

- The number of searches of land registers made by members of the public in July 2010 was 524,383 (+1% compared with June 2010 and +7.1% compared with July 2009)

The statistics cover searches made at the counter, through the self-service terminals and the IRIS Online Services.

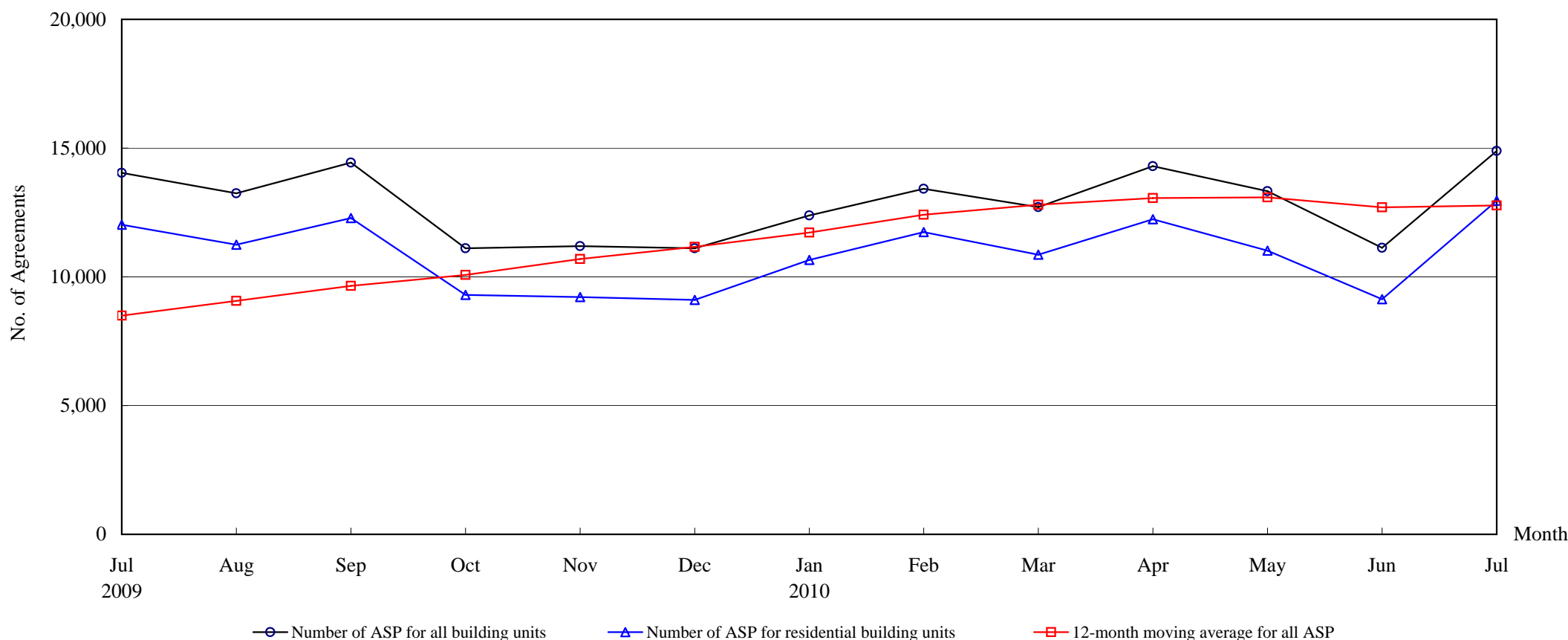

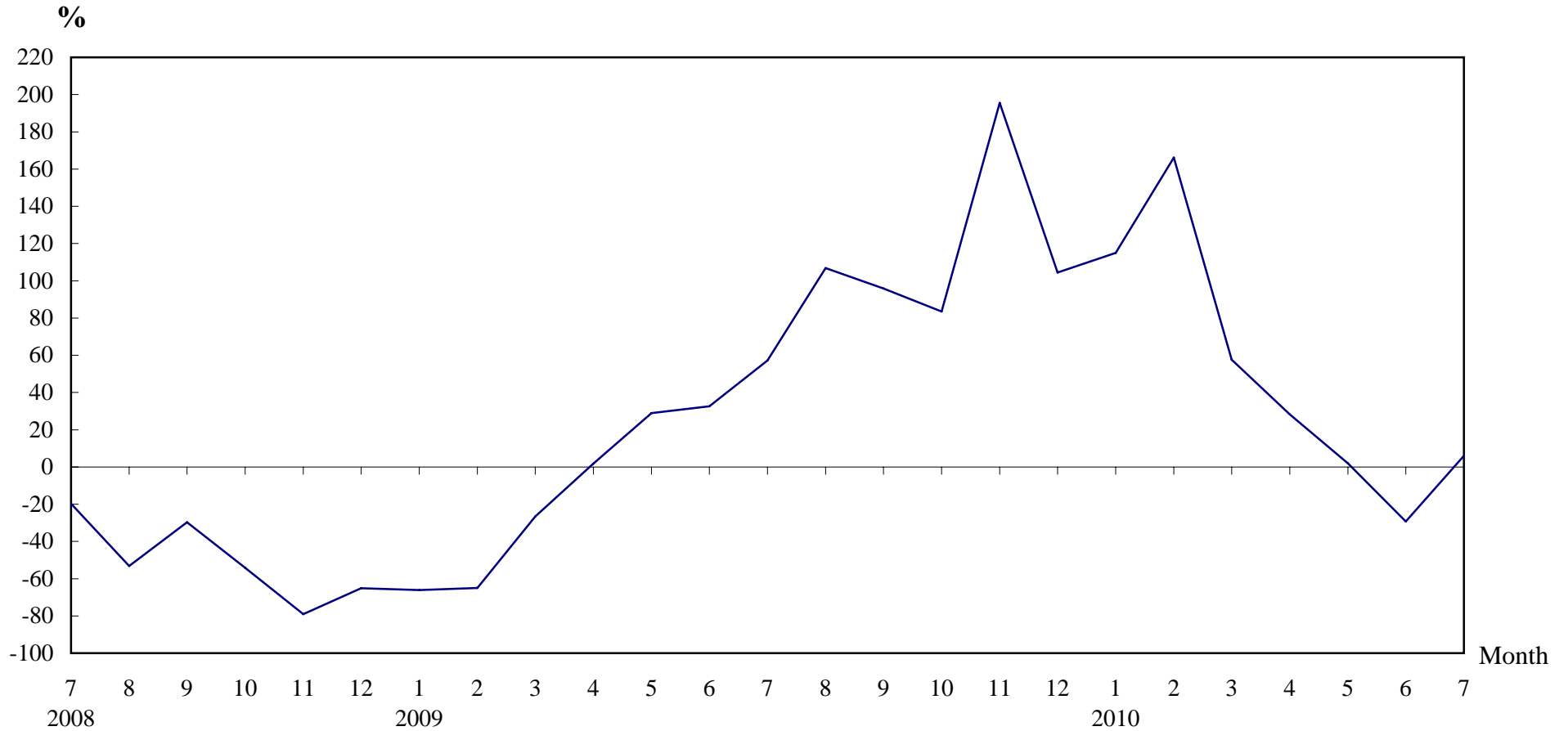
