23. Final review outcome of pilot doctor work reform programmes

At the meeting on 11 May 2009, the Administration was requested to report to the Panel the final review outcome of the pilot doctor work reform programmes after the Steering Committee on Doctor Work Hours submitted its final review report to the Hospital Authority Board in early 2010.

24. Drug Formulary of the Hospital Authority

At the meeting on 12 February 2007, the Administration was requested to report to the Panel when the Hospital Authority Board had come to a view on the mode of supply of self-financed item drugs before implementation. The Administration was also requested to review the assessment criteria for introducing new drugs into the Hospital Authority (HA) Drug Formulary and for assistance under the Samaritan Fund.

When the grant for the Samaritan Fund was discussed at the Panel meeting on 10 November 2008, members raised concern about the assessment criteria and the operation of the Drug Formulary and the Samaritan Fund. Members considered it necessary to advance the discussion on the matter at a forthcoming Panel meeting.

At the meeting on 8 June 2009, the Administration briefed members on the latest developments of the HA Drug Formulary.

When the policy on the use of drugs in public hospitals under HA in immediate life threatening emergency situations was discussed at the Panel's special meeting on 19 June 2009, Hon Andrew CHENG and Hon Albert CHAN proposed to discuss the implementation of the HA Drug Formulary at a future meeting, and deputations should be invited to give views on the subject.

25. Issues arising from the recent medical incidents of HA

Hon Fred LI suggested that issues in connection with the revelation of an incident at the Queen Elizabeth Hospital on 16 August 2009 whereby the identities of two new born babies were exchanged should be discussed by the Panel. These included the handling of medical incidents by HA, the quality of the services provided by HA staff and the protection of patient data privacy.

Dr Hon PAN Pey-chyou proposed to discuss the technical and regulatory issues relating to the series of medical incidents of HA occurred in August 2009, as well as the employment and pay adjustment mechanism for HA doctors and the support provided by HA to its frontline staff in order to prevent recurrence of medical incidents.
