**I Election of Chairman and Deputy Chairman**

Election of Chairman

Mr LEE Cheuk-yan, the incumbent Chairman, called for nominations for the chairmanship of the Panel for the 2009-2010 session. Mr LEE Cheuk-yan was nominated by Dr Margaret NG and the nomination was seconded by Mr CHEUNG Man-kwong and Mr WONG Sing-chi. Mr LEE Cheuk-yan accepted the nomination.

2. As the incumbent Chairman was nominated for the office and the incumbent Deputy Chairman was not available, Dr Margaret NG, the member who had the highest precedence among members of the Panel then present, presided over the election of the Chairman. There being no other nomination, Dr Margaret NG declared Mr LEE Cheuk-yan elected as Chairman of the Panel for the 2009-2010 session. Mr LEE Cheuk-yan then took the chair.

Election of Deputy Chairman

3. The Chairman called for nominations for the deputy chairmanship of the Panel for the 2009-2010 session. Dr PAN Pey-chyou was nominated by Mr CHEUNG Man-kwong and the nomination was seconded by Mr IP Wai-ming. Dr PAN Pey-chyou accepted the nomination.

4. There being no other nomination, the Chairman declared Dr PAN Pey-chyou elected as Deputy Chairman of the Panel for the 2009-2010 session.

**II Schedule of meetings for the 2009-2010 session**

5. Members agreed that, except for the regular meeting in February 2010, which would be rescheduled for 22 February 2010 at 8:30 am, all regular meetings of the Panel in the 2009-2010 legislative session would be held on the third Monday of each month at 10:45 am.
