Employment applications

The Scheme was implemented on 15th July 2003. Between 1st April 2009 to 30th September 2009, **4159** entry applications for employment were received (monthly average: **693**). In the same period, **3367** applications were approved, **299** refused and **425** withdrawn/no further action taken. As at 30th September 2009, **820** applications were under processing.
