Action

**I. Community care services for persons with disabilities**

[LC Paper Nos. CB(2)1618/09-10(01) to (02), CB(2)1648/09-10(01) to (03) and CB(2)1688/09-10(01) to (07)]

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. The Subcommittee received views from 21 deputations on the community care and support services for persons with disabilities ("PWDs"). Major views of the deputations are summarised as follows -

- (a) the Administration should formulate a long-term strategy for provision of community care and support services for PWDs;

Action

- (b) the Administration should extend the pilot scheme on home care service for persons with severe disabilities to cover all districts across the territory and persons with different types of disabilities. Some deputations expressed grave concern about the support services for adult PWDs and urged the Administration to increase the number of places of day activity centres and sheltered workshops to facilitate the adult PWDs' continued living in the community;
- (c) of the 16 District Support Centres for PWDs ("DSCs"), only two had been in operation. The slow progress was largely due to the difficulties in finding suitable premises for setting up the centres and recruiting the relevant professionals, such as clinical physiologists and physiotherapists for service delivery. Some deputations considered that the Administration should reserve sites for setting up of DSCs during the planning and development stage, provide rent allowance or rates concession to facilitate DSCs' operation in commercial buildings, and provide more training courses to increase the supply of professionals in the welfare sector;
- (d) the Administration should review the level of Disability Allowance ("DA"), including the eligibility criteria of Higher DA and the arrangement of deducting the amount of Higher DA if the recipients had been hospitalised for more than 28 days;
- (e) the Administration should review the requirement for PWDs to apply for Comprehensive Social Security Assistance ("CSSA") on a household basis; and
- (f) the Administration should consider introducing the carers allowance, providing counselling service and establishing support centres for family carers of PWDs and enhancing respite service so as to relieve the burden and stress of family carers of PWDs.

3. Members generally shared the issues of concern raised by deputations and expressed concern about the Government's plan and efforts in place to increase the provision of subsidised residential care places and community care and support services for PWDs. Having regard to the slow progress in implementing the 16 DSCs, members considered that the Administration should identify and reserve suitable sites for setting up of welfare facilities and project staffing requirement, in particular professional personnel, prior to the implementation of new service initiatives. Additional provision should be sought from the Lotteries Fund for enhancing the support services for PWDs. To enable PWDs to fully integrate into the community, members also appealed to the Administration to expedite the implementation of Integrated Community Centres for Mental Wellness ("ICCMWs") service mode throughout the territory and extend the pilot scheme on

home care service for persons with severe disabilities to persons with different types of disabilities in all districts across the territory.

4. In the light of the financial burden of non-CSSA PWDs and their family carers, Mr LEUNG Yiu-chung urged the Administration to review the levels of DA and the requirement for PWDs to apply for CSSA on a household basis.

5. The Administration made the following responses -

- (a) it planned to introduce the Residential Care Homes (Persons with Disabilities) Bill into the Legislative Council within the 2009-2010 legislative session to provide for the control of residential care homes for PWDs through a licensing system. In tandem with the legislative proposal, the Administration would seek funding allocation from the Lotteries Fund to introduce the Pilot Bought Place Scheme for private RCHDs in 2010-2011 to encourage the private RCHD operators to enhance their service quality, prior to the implementation of the statutory licensing system;
- (b) it would endeavour to secure premises for setting up of 16 DSCs expeditiously to provide PWDs and their family members/carers with one-stop community support services which aimed at enhancing the domestic and community living skills of PWDs, and thereby facilitating their integration into the community. DSCs also provided training and support services to the family members/carers of PWDs so as to strengthen their caring capacity and to relieve their stress. Two DSCs had been in operation on premises secured since May 2010, five centres were under renovation, sites for three centres had been earmarked in the public housing estate development projects and the remaining six were under planning;
- (c) in light of the successful experience of the pilot operation of ICCMW in Tin Shui Wai, the Social Welfare Department ("SWD") had secured additional annual provision of about \$70 million to expand the integrated service mode across the territory within 2010-2011;
- (d) an interim review and a final review would be conducted to consider whether the pilot scheme on home based services for severe disabilities should be extended to other districts and other service targets in the light of its operational experience;
- (e) a total of some 16 400 places were provided for day training and vocational rehabilitation services. There would be an additional 290 places of day training and 420 places of vocational rehabilitation services in the coming two years;

Action

- (f) DA was non-means-tested, which aimed to meet the specific needs of PWDs and not their basic needs. If PWDs faced financial hardship, they could apply for CSSA. As to non-CSSA disabled persons with financial difficulties, they could apply to the Hospital Authority ("HA") for medical fee waiver, and funding schemes such as the Yan Chai Tetraplegic Fund;
- (g) under the Enhancing Employment of People with Disabilities through Small Enterprise Project, seed money was provided to non-governmental organisations to set up small social enterprise projects with a view to creating job opportunities for and enhancing the employment of PWDs. As at end of May 2010, some \$36 million had been granted and about 500 jobs had been created for PWDs; and
- (h) to alleviate the shortage of nurses in the welfare sector, SWD, in collaboration with HA, had been funding and launching the Enrolled Nurse (General) / Enrolled Nurse (Psychiatric) Training Programme for the Welfare Sector (the Training Programme) since 2006. The trainees of the Training Programmes were required to work in the welfare sector for not less than two years after graduation. A total of six batches of the Training Programmes had been organized.

**II. Any other business**

Discussion items of the next meetings

6. The Chairman said that the Subcommittee would discuss the community care and support services for the elderly at the next meeting in June 2010. Owing to time constraints, the Subcommittee might consider discussing the following issues raised at the meeting at the meeting scheduled for 13 July 2010 –

- (a) support services for family carers of PWDs;
- (b) identification of suitable premises for setting up of welfare facilities for PWDs;
- (c) support services for low-income families, such as fees and charges for community care and support services for PWDs;
- (d) progress of the implementation of ICCMWs and the pilot scheme on home care service for persons with severe disabilities; and
- (e) review of the level of DA and the requirement of PWDs to apply for CSSA on a household basis.
