## FACT SHEET

### Land supply, subsidized housing schemes and housing loan schemes

1.1 The purpose of this fact sheet is to provide the Panel on Housing with a list of papers relating to land supply, subsidized housing schemes and housing loan schemes submitted to the Legislative Council and its committees in the past five years. The details are listed in **Tables 1 to 7**:

- (a) Land supply (see **Table 1**);
- (b) Home Ownership Scheme (HOS), Private Sector Participation Scheme (PSPS) and HOS Secondary Market – HOS was launched in 1978, but it was terminated in 2003; since 2007, the remaining surplus flats have been put up for sale. PSPS was introduced in 1979, while the revitalization of the HOS secondary market is currently under consultation and study (see **Table 2**);
- (c) Home Purchase Loan Scheme – The Scheme was introduced in 1988 and replaced by the Housing Assistance Loan Scheme in 2002 (see **Table 3**);
- (d) Sandwich Class Housing Scheme (SCHS) – SCHS was introduced in 1993. Construction of SCHS flats was suspended in 1998. Unsold flats were put up for sale in 2008 and 2010 respectively (see **Table 4**);
- (e) Home Starter Loan Scheme – The Scheme was introduced in 1998 and replaced by the Housing Assistance Loan Scheme in 2002 (see **Table 5**);
- (f) Tenant Purchase Scheme – The Scheme was introduced in 1998 and terminated in 2005 (see **Table 6**); and
- (g) Housing Assistance Loan Scheme – The Scheme was introduced in 2002 to replace the Home Purchase Loan Scheme and Home Starter Loan Scheme. However, it was terminated in 2004 (see **Table 7**).
