

Reduce & recycle

- 在2015年將回收率進一步提高至55% Raise reduction target to 55% by 2015
- 加強回收硬件設置
 Step up provision of recycling facilities
 - 透過法例和資助形式爲新建及現有物業加裝回收設施 through legislation & subsidies for new and existing buildings respectively
 - 推廣於屋邨和商場就地處理廚餘
 through provision of on-site food waste treatment facilities at housing and commercial property
- 推動地區回收運動
 Launch community-based campaigns
 - 於18區建立回收網絡,推廣以物易物及廚餘回收 build recycling network at 18 districts to promote collection of reusable/recyclable materials & food waste
 - 透過前線政府部門的網絡推動減廢 leverage on network of frontline Government departments to promote waste reduction

• 處理三大類型的廢物

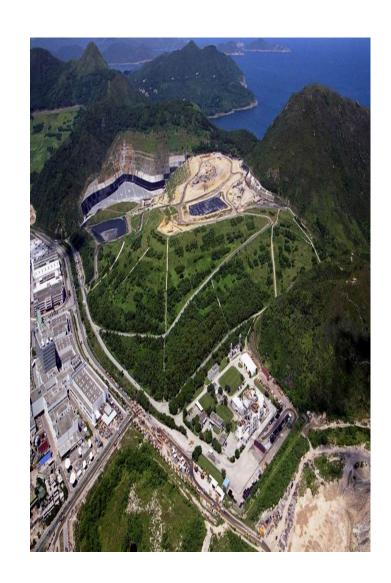
To handle three types of wastes including:

1. 焚化設備規模以外未及處理的都市固 體廢物

Wastes not treated by IWMF due to capacity constraint

2. 不可焚化的廢物,如建築廢料
Wastes that cannot be incinerated, e.g. construction waste

3. 經焚化的垃圾所餘下的灰燼
Ashes remaining from the wastes treated by IWMF



將軍澳堆填區

Tseung Kwan O landfill

- 擴展的需要:在其他設施籌建期間繼續爲香港提供堆填用地 Need for extension: to provide landfill space while other facilities are being planned
- 修訂方案考慮到堆填區接近大量民居的獨特性:
 Revised proposal takes into account its proximity to large-scale residential areas:
 - 不再徵用清水灣郊野公園5公頃的土地 Give up the 5 hectares of Country Park area
 - 縮小堆塡區的擴展範圍至13公頃 Reduce scope of extension to 13 hectares
 - 盡早安排將軍澳堆塡區只接收沒有氣味的廢物(如建築廢物) Allocate wastes without odour (such as construction wastes) to TKO landfill as soon as possible










新界東南堆填區及擴建部分方案的壽命
