(1) Purpose 目的

- Facilitate NGOs to outreach & provide services to target tenants and foster community building at estate level 方便非政府機構接觸目標家庭及為他們提 供服務以促進屋邨層面的社區建設
- Not to replace District Council (DC) funding 不會取代區議會撥款

(2) Background背景

- Introduced in Oct 2009 在2009年10月實施
- Collaborative activities among EMACs & NGOs **邨管諮委會夥非拍政府機構舉辦活動**
- Allotted 30% of EMAC funds for partnering functions 分配30%的邨管諮委會撥款用作舉辦夥拍活動
 - >\$30,000/function for small estates <mark>小型屋</mark>邨每項活動 3萬元
 - >\$50,000/function for large estates 大型屋邨每項活動 5萬元

(3) Functions Held 舉辦活動

- Some 510 partnering functions held from October 2009 to March 2011 由2009年10月至2011年3月舉辦約510項夥拍
- Category of partnering functions 夥拍活動種類
- as satisfactory & above 98%活動的平均評級為「滿意」或以上

• 98% of activities being assessed

(4) Funding Allotment & Expenditure 撥款分配與開支

- 310 functions held < \$30,000 310 項活動的開支<3萬元
- 200 functions held > \$30,000 200 項活動開支>3萬元
- Only 20 functions held by large estates fully utilised the maximum ceiling of funding of \$50,000 僅20項由大型星邨舉辦的夥拍活動悉數使用最高撥 款額5萬元
- Funding ceiling well meets the resource requirement 撥款上限能符合各項服務或活動對資源的需求



(5) Control & Monitoring 控制與監管

- Adopt a prudent approach in vetting project proposals and budgets submitted by NGOs 採取極審慎的態度來審核非政府機構所提交 的計劃建議書和財政預算
- Make reference to DC funding arrangements
 参照區議會採用的撥款安排

- EMAC Chairman submits an assessment report on each completed activity 邨管諮委會主席須在每項活動完結後提交評核 報告
- HD Headquarters randomly checks the NGOs' proposals and final reports
 房署總部抽樣查核非政府機構提交的夥拍活動建議書和總結報告
