### **Declaration of interest requirements by Members of Parliament in the United Kingdom in relation to the Category of “Clients”**

#### **Purpose**

This paper sets out for members’ information details on what interests are required to be registered by Members of the United Kingdom (“UK”) House of Commons under the Category of “Clients”.

#### **Background**

2. At the meeting of the Committee on Members’ Interests on 7 January 2011, members noted the research report on requirements and related arrangements for the registration and disclosure of Members’ interests (RP02/10-11). Members requested the Secretariat to provide further information on whether Members in UK are required to register the names of the clients to whom they provided legal services or business services as well as the amount of payment they received, regardless of whether these services arose out of or related in any manner to their being Members.

#### **Declaration requirements**

##### Directorship and remunerated employment, office, profession, etc

3. In the House of Commons, Members are required to declare:
- (a) *Directorship (Category 1)* i.e. remunerated directorships in public and private companies including directorship which

are individually unremunerated, but where the remuneration is paid through another company in the same group (remuneration received in respect of work done in a Member's parliamentary capacity should be indicated in bands of up to £5,000; £5,001 to £10,000; and thereafter in bands of £5,000).<sup>1</sup>

- (b) *Remunerated employment, office, profession, etc (Category 2)* i.e. employment, office, trade, profession or vocation (apart from membership of the House or ministerial office) which is remunerated or in which the Member has any financial interest (remuneration received in respect of work done in a Member's parliamentary capacity should be indicated in bands of up to £5,000; £5,001 to £10,000; and thereafter in bands of £5,000; membership of Lloyd's should also be registered under this Category and the categories of insurance business the Member is underwriting should be disclosed).<sup>2</sup>

## Clients

### *Registration requirements*

4. In respect of any paid employment a Member has registered in the two categories referred to paragraph 3(a) and (b) above, any provision to clients of services by a Member should be registered under the Category of "Clients" (Category 3). All clients to which personal services are provided should be listed together with the nature of the client's business in each case. Where a Member receives remuneration from a company or partnership engaged in consultancy business which itself has clients, the Member should list any of those clients to whom personal services and advice are provided, either directly or indirectly.

### *Guidelines*

5. According to the Guide to the Rules relating to the conduct of Members, Members are advised that:

- (a) If a Member is employed as a parliamentary adviser by a firm which is itself a consultancy, he or she should register under this category any clients of that firm to which he or she has personally provided services. In addition the Member should register any clients of the consultancy which he or she knows have benefited from such advice. Where a company is named as a client, the nature of the company's business should be indicated. The consultancy itself should be registered under Category 2.
  
- (b) Members must register under this category the precise amount of each individual payment made, the nature of the work carried on in return for that payment, the number of hours worked during the period to which that payment relates and (except where disclosure of the information would be contrary to any legal or established professional duty of privacy or confidentiality) the name and address of the person, organisation or company making that payment.
