Bills

First Reading

Stamp Duty (Amendment) (No. 2) Bill 2010

The Bill was read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure.

Second Reading

Stamp Duty (Amendment) (No. 2) Bill 2010

The Secretary for Transport and Housing moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Road Traffic (Amendment) Bill 2010

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 12 May 2010 resumed.

Hon Miriam LAU, Chairman of the Bills Committee on Road Traffic (Amendment) Bill 2010, addressed the Council on the Committee's Report. After the address, she spoke on the Bill in her personal capacity as a Member.

Hon WONG Sing-chi spoke on the Bill.

While Hon WONG Sing-chi was speaking, the President left the chair at 1:50 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Five Members spoke on the Bill.

Hon Paul CHAN declared that he had been a member of the Transport Advisory Committee. Hon Paul CHAN further declared that he had a driving licence and was a driver, and would drink in his daily life. He then spoke on the Bill.

Two other Members and Hon LEE Cheuk-yan spoke on the Bill.

At 3:29 pm, while Hon LEE Cheuk-yan was speaking, the President resumed the chair.

Two more Members spoke on the Bill.

The Secretary for Transport and Housing replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into Committee and considered the Road Traffic (Amendment) Bill 2010.

Question that clauses 1, 2, 3, 5, 13, 15, 16, 17 and 19 to 23 stand part of the Bill proposed, put and agreed to.

Question that clauses 4 and 18 stand part of the Bill proposed.

The Secretary for Transport and Housing moved amendments to clauses 4 and 18 and spoke on the amendments.

Question on the amendments put and agreed to.

Question that clauses 4 and 18 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 6 stand part of the Bill proposed.

The Chairman stated that Hon Andrew CHENG had given notice to move amendments to clause 6 to add subclauses (1A), (2A) and (3A) and to amend subclauses (2), (3) and (4). Besides, the Secretary for Transport and Housing had also given notice to move an amendment to subclause (5) of clause 6. The Chairman further stated that irrespective of whether Hon Andrew CHENG's amendments were passed, the Secretary for Transport and Housing might move his amendment to the clause, and if the Secretary for Transport and Housing's amendments to clauses 6, 7 and 8 were negatived, he might not move the amendments to clause 14 nor might he move the addition of new clause 21A to the Bill, as those amendments were inconsistent with the decision taken by the committee. The Chairman ordered that clause 6 and the amendments thereto be debated together in a joint debate.

Hon Andrew CHENG moved amendments to clause 6 and spoke on the amendments.

The Secretary for Transport and Housing spoke on the amendments.

Seven Members spoke on the amendments.

The Secretary for Transport and Housing spoke again.

Hon Andrew CHENG spoke again.

Question on the amendments moved by Hon Andrew CHENG put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, seven were in favour of the amendments, 12 against them and six abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, 16 were in favour of the amendments, six against them and four abstained (voting record in **Appendix 1**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the other provisions of the Road Traffic (Amendment) Bill 2010 or amendments thereto, the Committee do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

The Secretary for Transport and Housing moved the amendments to clause 6.

Question on the amendments put and agreed to.

Question that clause 6 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 7 stand part of the Bill proposed.

The Chairman stated that Hon Andrew CHENG had given notice to move amendments to clause 7 to amend clauses 36A(3)(a) and (b), 36A(4)(a) and (b) as well as 36A(5)(a) and (b) as proposed in the Bill. Besides, the Secretary for Transport and Housing had also given notice to move an amendment to clause 7 to amend clause 36A(7) as proposed in the Bill. The Chairman further stated that irrespective of whether Hon Andrew CHENG's amendments were passed, the Secretary for Transport and Housing might move his amendment to the clause. The Chairman ordered that clause 7 and the amendments thereto be debated together in a joint debate.

Hon Andrew CHENG moved amendments to clause 7 and spoke on the amendments.

The Secretary for Transport and Housing spoke on the amendments.

Four Members spoke on the amendments.

The Secretary for Transport and Housing spoke again.

Hon Andrew CHENG spoke again.

Another Member spoke on the amendments.

The Chairman said that although Members were allowed to speak more than once during the committee stage, it would not be a good reason for a Member to repeat the points already covered in his earlier speech just because certain Members were not in the Chamber when he made the speech. The Chairman also reminded Members that they should speak to the Chairman, and should not use inappropriate words in their speeches.

Two more Members spoke on the amendments.

Hon Andrew CHENG spoke for the third time.

Question on the amendments moved by Hon Andrew CHENG put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 22 were present, four were in favour of the amendments, 14 against them and four abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, 11 were in favour of the amendments, seven against them and four abstained (voting record in **Appendix 2**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

The Secretary for Transport and Housing moved the amendments to clause 7.

Question on the amendments put and agreed to.

Question that clause 7 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 8 stand part of the Bill proposed.

The Chairman stated that Hon Andrew CHENG had given notice to move amendments to clause 8 to add subclauses (1A), (2A) and (3A) and to amend subclauses (2), (3) and (4). Besides, the Secretary for Transport and Housing had also given notice to move an amendment to subclause (5) of clause 8. The Chairman further stated that irrespective of whether Hon Andrew CHENG's amendments were passed, the Secretary for Transport and Housing might move his amendment to the clause. The Chairman ordered that clause 8 and the amendments thereto be debated together in a joint debate.

Hon Andrew CHENG moved amendments to clause 8 and spoke on the amendments.

While Hon Andrew CHENG was speaking, the Chairman left the chair at 6:41 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

The Secretary for Transport and Housing spoke on the amendments.

Two Members spoke on the amendments.

The Secretary for Transport and Housing spoke again.

Hon Andrew CHENG spoke again.

Question on the amendments moved by Hon Andrew CHENG put.

Hon Andrew CHENG claimed a division. The Chairman's Deputy then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

At 6:52 pm, while the division bell was ringing, the Chairman resumed the chair.

The Chairman announced that among the Members returned by functional constituencies, 20 were present, five were in favour of the amendments, 12 against them and three abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 14 were in favour of the amendments, seven against them and four abstained (voting record in **Appendix 3**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negated.

The Secretary for Transport and Housing moved the amendment to clause 8.

Question on the amendment moved by the Secretary for Transport and Housing put.

Hon IP Wai-ming claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that there were 45 Members present, 42 were in favour of the amendment and two abstained (voting record in **Appendix 4**). Since the question was agreed by a majority of the Members present, he declared that the amendment was passed.

Question that clause 8 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 9 stand part of the Bill proposed.

The Chairman stated that the Secretary for Transport and Housing had given notice to move an amendment to clause 9 to add subclause (1A). Besides, Hon Andrew CHENG had also given notice to move amendments to subclauses (2) to (7) of clause 9. The Chairman further stated that irrespective of whether the Secretary for Transport and Housing's amendment was passed, Hon Andrew CHENG might move his amendments to the clause. The Chairman ordered that clause 9 and the amendments thereto be debated together in a joint debate.

The Secretary for Transport and Housing moved the amendment to clause 9 and spoke on the amendment.

Hon Andrew CHENG spoke on the amendments.

The Secretary for Transport and Housing spoke again.

Question on the amendment moved by the Secretary for Transport and Housing put.

Hon IP Wai-ming claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that there were 44 Members present, 41 were in favour of the amendment and two abstained (voting record in **Appendix 5**). Since the question was agreed by a majority of the Members present, he declared that the amendment was passed.

Hon Andrew CHENG moved the amendments to clause 9.

Question on the amendments moved by Hon Andrew CHENG put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 21 were present, four were in favour of the amendments, 13 against them and four abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 15 were in favour of the amendments, seven against them and three abstained (voting record in **Appendix 6**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 9 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 10 stand part of the Bill proposed.

The Chairman stated that Hon Andrew CHENG had given notice to move amendments to clause 10(5) to amend clause 39A(2A)(a)(i) to (iii) and (b)(i) to (iii) as proposed in the Bill. He ordered that clause 10 and the amendments thereto be debated together in a joint debate.

Hon Andrew CHENG moved the amendments to clause 10 and spoke on the amendments.

Two Members spoke on the amendments.

The Secretary for Transport and Housing spoke on the amendments.

Hon Andrew CHENG spoke again.

Question on the amendments moved by Hon Andrew CHENG put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 17 were present, 14 were against the amendments and three abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, three were in favour of the amendments, 18 against them and three abstained (voting record in **Appendix 7**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 10 stand part of the bill put and agreed to.

Question that clauses 11 and 12 stand part of the bill proposed.

The Chairman stated that Hon Andrew CHENG had given notice to move amendments to subclauses (2) to (7) of clause 11 as well as subclauses (2) to (7) of clause 12.

Hon Andrew CHENG moved the amendments to clauses 11 and 12 and spoke on the amendments.

The Chairman ordered that clauses 11 and 12 and the amendments thereto be debated together in a joint debate. The Chairman said that the committee would put to vote Hon Andrew CHENG's amendments to clause 11 first. Irrespective of whether such amendments were passed, Hon Andrew CHENG might move his amendments to clause 12.

A Member spoke on the amendments.

The Secretary for Transport and Housing spoke on the amendments.

Question on the amendments to clause 11 moved by Hon Andrew CHENG put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 15 were present, three were in favour of the amendments, eight against them and four abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the amendments, seven against them and three abstained (voting record in **Appendix 8**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 11 stand part of the Bill put and agreed to.

Question on the amendments to clause 12 moved by Hon Andrew CHENG put and negatived.

Question that clause 12 stand part of the Bill put and agreed to.

Question that clause 14 stand part of the Bill proposed.

The Secretary for Transport and Housing moved amendments to clause 14 and spoke on the amendments.

Question on the amendments put.

Hon IP Wai-ming claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that there were 40 Members present and 39 were in favour of the amendments (voting record in **Appendix 9**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that clause 14 as amended stand part of the Bill proposed, put and agreed to.

New clause 21A read the first time.

The Secretary for Transport and Housing moved the Second Reading of new clause 21A and spoke on the new clause.

Question on the Second Reading of new clause 21A proposed and put.

Hon IP Wai-ming claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that there were 34 Members present and 33 were in favour of the motion (voting record in **Appendix 10**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

New clause 21A read the second time.

The Secretary for Transport and Housing moved the addition of new clause 21A to the Bill.

Question on the addition proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Transport and Housing reported that

the Road Traffic (Amendment) Bill 2010

had passed through the committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed and put.

Hon IP Wai-ming claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that there were 31 Members present, 26 were in favour of the motion and four abstained (voting record in **Appendix 11**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the third time and passed.

Motions

Proposed resolution under the Air Pollution Control Ordinance

The Secretary for the Environment moved the following motion and spoke on the motion:

Resolved that the Second Technical Memorandum for Allocation of Emission Allowances in Respect of Specified Licences, published in the Gazette as Special Supplement No. 5 to Gazette No. 41/2010 and laid on the table of the Legislative Council on 20 October 2010, be amended –

- (a) in the Chinese text of section 2.1, by adding “分” after “獲”; and
- (b) in section 2.5, by substituting “three” by “two”.

Question on the motion proposed.

Hon Audrey EU spoke on the motion as the Chairman of the Subcommittee on Second Technical Memorandum for Allocation of Emission Allowances in Respect of Specified Licences, and then in her personal capacity as a Member.

Two Members spoke on the motion.

The Secretary for the Environment replied.

Question on the motion put and agreed to.

Members' Motions

Proposed resolution under the Interpretation and General Clauses Ordinance

Hon TAM Yiu-chung moved the following motion and spoke on the motion:

Resolved that in relation to the —

- (a) Minimum Wage Ordinance (Amendment of Schedule 3) Notice 2010, published in the Gazette as Legal Notice No. 145 of 2010;
- (b) Minimum Wage Ordinance (Commencement) Notice 2010, published in the Gazette as Legal Notice No. 146 of 2010;
- (c) Minimum Wage Ordinance (Commencement) (No. 2) Notice 2010, published in the Gazette as Legal Notice No. 147 of 2010; and
- (d) Employment Ordinance (Amendment of Ninth Schedule) Notice 2010, published in the Gazette as Legal Notice No. 148 of 2010,

and laid on the table of the Legislative Council on 17 November 2010, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the meeting of 5 January 2011.

Question on the motion proposed, put and agreed to.

Air pollution and public health

Hon KAM Nai-wai moved the following motion and spoke on the motion:

That, as the problem of air pollution in Hong Kong has continued to be serious, posing threats to public health, yet the Government has not updated Hong Kong's Air Quality Objectives ('AQOs'), and at present, many highly polluting franchised buses and lorries still run on the roads, continuing to emit exhaust gas, this Council expresses its disappointment in this regard; according to the statistics of the Hedley Environmental Index, in the first 10 months of this year, air pollution caused as many as 635 premature deaths and more than 4 million attendances of medical consultation in Hong Kong; given that air pollution has incurred huge monetary losses and social costs, this Council urges the Government to implement the following proposals, so as to expeditiously improve air quality for the protection of public health:

- (a) to immediately update AQOs by adopting the most stringent standards of the World Health Organization's air quality guidelines as Hong Kong's AQOs, and undertake to review AQOs regularly in the future;
- (b) by way of financial subsidy or franchise extension, to push ahead the early phasing out and replacement of franchised buses with high emissions, so as to improve roadside air quality, and immediately install emission reduction devices on all buses that have not been phased out or replaced;
- (c) to enhance the scheme for the replacement of Euro II diesel commercial vehicles mentioned in the Budget of this year, including placing Pre-Euro and Euro-I vehicles under the scheme and allowing those vehicle owners who only write off their vehicles to receive subsidies under the scheme;
- (d) to increase the number, usage and types of electric vehicles; improve and strengthen support facilities to tie in with the introduction of electric vehicles by, for example, actively discussing with various developers the provision of recharging facilities for electric vehicles in the car parks of their properties; and expeditiously study amending the legislation to expedite and streamline the procedure for electric vehicle drivers to apply for the permit to drive on expressways, so as to assist in popularizing electric vehicles;
- (e) to urge bus companies to expand and increase the provision of interchange concessions and services which appeal to passengers, and to expedite the reorganization and improve the arrangement of bus routes, with a view to avoiding the overlapping of bus routes, relieving traffic congestion and reducing air pollution;

- (f) to expeditiously implement the proposal of designating ‘low emission zones’, so as to restrict the entry of vehicles with high emissions into designated areas;
- (g) in respect of the situation where the Air Pollution Index reaches the ‘extremely severe’ level, to formulate specific guidelines, including implementation of measures to suspend schools and arrange for workers who need to work outdoors for long hours to suspend work, etc., so as to protect the health of school children and the socially disadvantaged, such as people with chronic illness, the elderly and workers working outdoors, in situations where the pollution is serious;
- (h) when formulating measures to improve air pollution, to adopt the latest objectives and benchmarks of the World Health Organization, and evaluate the effectiveness of each measure in improving public health, and set improving public health as the primary policy objective in addressing the problem of air pollution; and
- (i) to recognize that air pollution is a public health issue, and require accountable officials from the Food and Health Bureau to participate in the formulation of policies on improving air quality.

Question on Hon KAM Nai-wai’s motion proposed.

The President stated that four Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the four amendments would be debated together in a joint debate.

Hon CHAN Hak-kan, Hon IP Wai-ming, Hon Ronny TONG and Dr Hon Joseph LEE, who intended to move amendments, spoke on the motion and the amendments.

The Secretary for the Environment spoke on the motion and the amendments.

Five Members spoke on the motion and the amendments.

The President suspended the meeting at 10:10 pm.

* * * * *

The Council resumed at 2:30 pm on 9 December 2010.

Six Members spoke on the motion and the amendments.

Hon KAM Nai-wai spoke on the amendments.

The Secretary for the Environment spoke again.

Hon CHAN Hak-kan moved the following amendment to Hon KAM Nai-wai's motion:

To delete "as" after "That," and substitute with "given that"; to delete "by" after "update AQOs" and substitute with "and formulate a timetable and relevant measures for eventually"; to delete "as Hong Kong's AQOs" after "air quality guidelines"; to add "and the effectiveness of the relevant measures" after "review AQOs regularly"; to add "(f) to encourage, through policy initiatives, the various bus companies to deploy wholly electric buses in new development areas and busy districts, so as to further improve roadside air quality in such areas;" after "reducing air pollution;"; to delete the original "(f)" and substitute with "(g)"; to delete the original "(g)" and substitute with "(h)"; to add "(i) to actively promote the energy conservation policy, and further increase the ratio of natural gas and renewable energy in the fuel mix for power generation in Hong Kong, so as to reduce emission by power generation;" after "pollution is serious;"; to delete the original "(h)" and substitute with "(j)"; to delete "and" after "addressing the problem of air pollution;"; to delete the original "(i)" and substitute with "(k)"; and to add "; and (l) to actively follow up the work of collaborating with Guangdong Province on improving regional air quality after 2010, so as to ensure continuous improvement of regional air quality" immediately before the full stop.

Question on Hon CHAN Hak-kan's amendment to Hon KAM Nai-wai's motion proposed, put and agreed to.

The President stated that as Hon CHAN Hak-kan's amendment had been passed, Dr Hon Joseph LEE had therefore withdrawn his amendment.

As Hon CHAN Hak-kan's amendment had been passed, the President granted leave for Hon IP Wai-ming to revise the terms of his amendment.

Hon IP Wai-ming moved the following further amendment to Hon KAM Nai-wai's motion as amended by Hon CHAN Hak-kan:

To add “; (m) to assist the industries in resolving the technical problems that occur after the implementation of the scheme for the replacement of Euro II diesel commercial vehicles, with a view to ensuring that the repair, design and parts availability, etc., of the new vehicles after replacement can tie in with the operation of the industries; (n) to study and consult the public and the transport sector on a specific proposal of designating ‘low emission zones’; (o) to require power companies in Hong Kong to fully adopt low-emission power generation technologies and clean fuel for power generation on the premise of not increasing electricity tariffs and affecting public health, with a view to alleviating the air pollution caused by power generation emission in Hong Kong; and (p) to classify the related diseases contracted by employees who have to work outdoors under severe air pollution conditions as occupational diseases” immediately before the full stop.

Question on Hon IP Wai-ming’s amendment to Hon KAM Nai-wai’s motion as amended by Hon CHAN Hak-kan proposed, put and agreed to.

As Hon CHAN Hak-kan’s and Hon IP Wai-ming’s amendments had been passed, the President granted leave for Hon Ronny TONG to revise the terms of his amendment.

Hon Ronny TONG moved the following further amendment to Hon KAM Nai-wai’s motion as amended by Hon CHAN Hak-kan and Hon IP Wai-ming:

To add “; (q) to curb the number of vehicle growth through policy formulation, green transport planning, financial measures and building a better green transport system in urban areas; and (r) to provide financial incentives to induce minibus operators to expedite the introduction of new minibuses with lower levels of emission to replace old minibuses” immediately before the full stop.

Question on Hon Ronny TONG’s amendment to Hon KAM Nai-wai’s motion as amended by Hon CHAN Hak-kan and Hon IP Wai-ming proposed, put and agreed to.

Hon KAM Nai-wai replied.

Question on Hon KAM Nai-wai’s motion as amended by Hon CHAN Hak-kan, Hon IP Wai-ming and Hon Ronny TONG put and agreed to.

Reviewing the policy on nature conservation

Hon Audrey EU moved the following motion and spoke on the motion:

That this Council urges the Government to expeditiously review the existing policy on nature conservation and formulate appropriate measures, including: setting up a community-led and government-supported nature conservation fund; putting in place a compensation mechanism for cases in which the land lots have been frozen for development due to nature conservation and have established development rights according to law; immediately implementing planning control on ‘enclaves’ adjacent to country parks; requiring developers, upon the expiry of the planning permission and building plan approval, to apply afresh for development permission according to the existing conservation requirements in respect of projects yet to be commenced; plugging the loophole that developers can undertake large-scale developments by acquiring small house concessionary rights; and increasing the penalties for property owners and liable persons who carry out unlawful development and cause land damage in contravention of the law, so as to properly conserve land lots with high ecological value and picturesque sceneries.

While Hon Audrey EU was speaking, the President left the chair at 4:02 pm temporarily and the President’s Deputy, Hon Miriam LAU, took the chair.

Question on Hon Audrey EU’s motion proposed.

The President’s Deputy stated that Hon KAM Nai-wai and Hon CHEUNG Hok-ming would move amendments to the motion. Also, Hon LEE Wing-tat would move an amendment to Hon CHEUNG Hok-ming’s amendment. In accordance with the Rules of Procedure, the motion and the amendments would be debated together in a joint debate.

Hon KAM Nai-wai, who would move an amendment, spoke on the motion and the amendments.

Hon CHEUNG Hok-ming, who would move an amendment, declared that he owned land and small houses in the New Territories. He then spoke on the motion and the amendments.

At 4:18 pm, while Hon CHEUNG Hok-ming was speaking, the President resumed the chair.

Hon LEE Wing-tat, who would move an amendment, spoke on the motion and the amendments.

The Secretary for the Environment spoke on the motion and the amendments.

Three Members spoke on the motion and the amendments.

Hon LAU Wong-fat declared that he was a rural landowner as well as a real estate developer. He then spoke on the motion and the amendments.

Five other Members spoke on the motion and the amendments.

Hon Audrey EU spoke on the amendments.

The Secretary for the Environment spoke again.

Hon KAM Nai-wai moved the following amendment to Hon Audrey EU's motion:

To add "many land lots with high ecological value have been damaged in recent years," after "That"; to add "conducting comprehensive studies and consultation on" after "nature conservation fund;"; and to add ", so as to enable the public to put forward their views on the substantial social resources incurred by such a compensation mechanism" after "according to law".

Question on Hon KAM Nai-wai's amendment to Hon Audrey EU's motion proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, eight were in favour of the amendment; six against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 17 were present, 10 were in favour of the amendment; four against it and two abstained (voting record in **Appendix 12**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on “Reviewing the policy on nature conservation” or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon CHEUNG Hok-ming moved the following amendment to Hon Audrey EU’s motion:

To add “, given the recent occurrence of a number of cases of tampering with land lots of conservation value, and at the same time conflicts between private land owners’ development rights and the needs of conservation have not been properly tackled,” after “That”; to delete “setting up a community-led and government-supported” after “appropriate measures, including:” and substitute with “(a) to establish policy objectives and strategies for nature conservation, and adopt a scientific and widely recognized mechanism for identifying projects that are in genuine need of conservation; (b) to set up a”; to delete “; putting” after “nature conservation fund” and substitute with “jointly managed by the Government and the community, with a start-up capital injection of \$1 billion from the Government, followed by annual injections each amounting to 1% of the government land auction proceeds, and coupled with proactive efforts to seek community capital injections; (c) to put”; to add “well-devised” after “in place a”; to delete “land lots have been frozen for development” after “cases in which the” and substitute with “uses of the private land lots have been restricted or their development rights frozen”; to delete “and have established development rights according to law; immediately implementing” after “due to nature conservation” and substitute with “; (d) after consulting the various stakeholders in society, to progressively implement”; to delete “ ‘enclaves’ adjacent to country parks; requiring” after “planning control on” and substitute with “land lots of high conservation value adjacent to country parks but yet have no planning restrictions; (e) in case of development projects for land lots within the scope of nature conservation, to require”; to delete “plugging the loophole that developers can undertake large-scale developments by acquiring small house concessionary rights; and increasing the penalties for” after “to be commenced;” and substitute with “and (f) to make clear the respective responsibilities of”; and to delete “so as to properly conserve land lots with high ecological value and picturesque sceneries” immediately before the full stop and substitute with “and at the same time properly conserve land lots of high conservation value through enhanced monitoring and heavier penalties”.

Question on Hon CHEUNG Hok-ming's amendment to Hon Audrey EU's motion proposed.

Hon LEE Wing-tat moved the following amendment to Hon CHEUNG Hok-ming's amendment:

To delete "annual injections each amounting to 1% of the government land auction proceeds" after "followed by" and substitute with "capital injections from a surcharge to be levied upon the payment of regrant premium for changing the use of agricultural lands"; and to add "formulated through thorough studies and public consultation" after "compensation mechanism".

Question on Hon LEE Wing-tat's amendment to Hon CHEUNG Hok-ming's amendment proposed and put.

Hon Audrey EU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 18 were present, 10 were in favour of the amendment; one against it and seven abstained; while among the Members returned by geographical constituencies through direct elections, 17 were present, seven were in favour of the amendment; six against it and three abstained (voting record in **Appendix 13**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question on Hon CHEUNG Hok-ming's amendment to Hon Audrey EU's motion put.

Hon Audrey EU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 18 were present, 15 were in favour of the amendment and three against it; while among the Members returned by geographical constituencies through direct elections, 17 were present, six were in favour of the amendment and 10 against it (voting record in **Appendix 14**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Audrey EU replied.

Question on Hon Audrey EU's motion put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 18 were present, nine were in favour of the motion; five against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 17 were present, 10 were in favour of the motion; four against it and two abstained (voting record in **Appendix 15**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Next meeting
