First Reading

Lifts and Escalators Bill

The Bill was read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure.

Second Reading

Lifts and Escalators Bill

The Secretary for Development moved the Second Reading and spoke on the Bill.

While the Secretary for Development was speaking, the President left the chair at 1:15 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Motions

Proposed resolution under the Mutual Legal Assistance in Criminal Matters Ordinance

The Secretary for Security moved the following motion and spoke on the motion:

Resolved that the Mutual Legal Assistance in Criminal Matters (India) Order, made by the Chief Executive in Council on 15 February 2011, be approved.

Question on the motion proposed.

Dr Hon Margaret NG spoke on the motion as the Chairman of the Subcommittee on Mutual Legal Assistance in Criminal Matters (India) Order.

The Secretary for Security replied.

Question on the motion put and agreed to.

Members' Motions

Proposed resolution under the Disability Discrimination Ordinance

Hon Cyd HO moved the following motion and spoke on the motion:

Resolved that in relation to the Revised Code of Practice on Employment under the Disability Discrimination Ordinance, published in the Gazette as Government Notice No. 2159 on 8 April 2011 and laid on the table of the Legislative Council on 13 April 2011, the period for amending the Revised Code of Practice referred to in section 65(5) of the Disability Discrimination Ordinance (Cap. 487) be extended under section 65(7) of that Ordinance to the meeting of 1 June 2011.

Question on the motion proposed, put and agreed to.

Proposed resolution under Article 75 of the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China

The President's Deputy stated that Hon TAM Yiu-chung would move two motions to amend the Rules of Procedure. The first motion sought to amend Rule 44 and Rule 45(2) of the Rules of Procedure, and the second motion sought to amend Rule 45(1) of the Rules of Procedure.

The President's Deputy further stated that there would be a joint debate on the two motions. Hon TAM Yiu-chung would first speak on the two motions and then move his first motion. After the debate, the first motion would be put to vote. Whether the first motion was passed or not would not affect Hon TAM Yiu-chung's moving of his second motion.

Hon TAM Yiu-chung spoke on the two motions and then moved his first motion as follows:

Resolved that the Rules of Procedure of the Legislative Council of the Hong Kong Special Administrative Region be amended as set out in the Schedule.

Schedule

**Amendments to Rules of Procedure of the Legislative Council
of the Hong Kong Special Administrative Region**

1. Rule 44 amended (Decision of Chair Final)

Rule 44 —

“standing or select”.

2. Rule 45 amended (Order in Council and Committee)

(a) **Repeal**

“standing or select”;

(b) English text —

Repeal

“clerks of any committees”

Substitute

“clerk of any committee”.

A Member and Hon Albert HO spoke on the two motions.

At 2:01 pm, while Hon Albert HO was speaking, the President resumed the chair.

Eleven other Members spoke on the two motions.

Hon TAM Yiu-chung replied.

Hon Albert CHAN sought elucidation of a point raised by Hon TAM Yiu-chung in his speech.

The President reminded Hon Albert CHAN that as Hon TAM Yiu-chung had given a reply, the debate on the two motions had already ended.

Question on Hon TAM Yiu-chung's first motion put.

Hon Albert CHAN claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

While the division bell was ringing, Hon WONG Yuk-man stood up and spoke aloud. The President ordered him to sit down. Hon WONG Yuk-man continued to speak aloud and then walked out of the meeting.

Hon Albert CHAN stood up and spoke aloud. The President ordered him to sit down. Ignoring the President's order, Hon Albert CHAN continued to stand up and spoke aloud. The President then ordered Hon Albert CHAN to withdraw from the Council immediately. Hon Albert CHAN then left the Chamber.

The President announced that among the Members returned by functional constituencies, 24 were present, 23 were in favour of the motion and one against it; while among the Members returned by geographical constituencies through direct elections, 26 were present, 21 were in favour of the motion, three against it and one abstained (voting record in **Appendix I**). Since the question was agreed by a majority of each of the two groups of Members present, he declared that the motion was passed.

Hon TAM Yiu-chung then moved his second motion as follows:

Resolved that the Rules of Procedure of the Legislative Council of the Hong Kong Special Administrative Region be amended as set out in the Schedule.

Question on Hon TAM Yiu-chung’s second motion put.

Hon LEUNG Kwok-hung claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 24 were present, 19 were in favour of the motion and five against it; while among the Members returned by geographical constituencies through direct elections, 26 were present, 11 were in favour of the motion and 14 against it (voting record in **Appendix II**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negated.

Temporarily suspending the implementation of the Minimum Wage Ordinance

Hon Paul TSE moved the following motion and spoke on the motion:

That, as both employees and employers in many industries have complained bitterly about the Minimum Wage Ordinance, the general guidelines promulgated by the Government as well as the specific guidelines formulated for a number of industries which are mostly affected by the Ordinance are not yet able to allay public concern, and Members who supported the passage of the Minimum Wage Bill that day have recently been queried for failing to thoroughly scrutinize the relevant bill and underestimating the negative impact of the legislation, this Council urges the SAR Government to temporarily suspend the implementation of the Ordinance.

Question on Hon Paul TSE's motion proposed.

The President stated that two Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the two amendments would be debated together in a joint debate.

Dr Hon Priscilla LEUNG and Hon Vincent FANG, who intended to move amendments, spoke on the motion and the amendments.

The Secretary for Labour and Welfare spoke on the motion and the amendments.

Two Members spoke on the motion and the amendments.

Hon Andrew LEUNG spoke on the motion and the amendments, and declared that he was the Chairman of the Vocational Training Council.

Ten Members and Hon CHAN Kin-por spoke on the motion and the amendments.

While Hon CHAN Kin-por was speaking, the President left the chair at 6:52 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another Member spoke on the motion and the amendments.

Hon Paul CHAN declared that he was an employer and his company hired cleaning workers, "amahs" and moderately mentally handicapped persons. He then spoke on the motion and the amendments.

Hon Paul TSE spoke on the amendments.

The Secretary for Labour and Welfare spoke again.

Dr Hon Priscilla LEUNG moved the following amendment to Hon Paul TSE's motion:

To delete "as" after "That," and substitute with "although the statutory minimum wage has come into force on 1 May this year, there are still many grey areas in how to correctly compute staff wages, so"; to add "worrying that waves of business closures and layoffs may be triggered, while" after

“Minimum Wage Ordinance,”; to delete “yet” after “Ordinance are not”; to delete “Members who supported the passage of the Minimum Wage Bill that day have recently been queried for failing to thoroughly scrutinize the relevant bill and underestimating the negative impact of the legislation” after “public concern, and” and substitute with “the Government has not provided other assistance measures for implementing the minimum wage; given the possible negative impact arising from the implementation of the Ordinance, such as the closure of some small and medium enterprises and the loss of certain low-skilled and elementary posts”; and to delete “temporarily suspend the implementation of the Ordinance” immediately before the full stop and substitute with “study the provision of funding to set up a ‘relief fund for implementing the minimum wage during its transitional period’, so as to assist small and medium enterprises which are facing difficulties as a result of implementing the minimum wage, thereby reducing elementary workers’ unemployment risks; besides, in response to soaring building management fees caused by the implementation of the minimum wage, which adds to the burden on property owners, the Government may conduct studies on offering support through various social welfare mechanisms to property owners with financial difficulties, particularly the elderly owners of old buildings, so as to minimize the negative impact arising from the implementation of the minimum wage”.

Question on Dr Hon Priscilla LEUNG’s amendment to Hon Paul TSE’s motion proposed and put.

Hon IP Wai-ming claimed a division. The President’s Deputy then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

At 7:30 pm, while the division bell was ringing, the President resumed the chair.

The President announced that among the Members returned by functional constituencies, 23 were present, one was in favour of the amendment, 15 against it and seven abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, one was in favour of the amendment, 16 against it and five abstained (voting record in **Appendix III**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Vincent FANG moved the following amendment to Hon Paul TSE’s motion:

To delete “as” after “That,” and substitute with “after the passage of the Minimum Wage Ordinance by the Legislative Council last year, the preparatory work undertaken by the Government for implementing the legislation was chaotic, and the general guidelines for employers and employees and the reference guidelines for individual industries were only published one after another very shortly before the commencement of the legislation, so”; to delete “, the general guidelines promulgated by the Government as well as the specific guidelines formulated for a number of industries which are mostly affected by the Ordinance are not yet able to allay public concern, and Members who supported the passage of the Minimum Wage Bill that day have recently been queried for failing to thoroughly scrutinize the relevant bill and underestimating the negative impact of the legislation” after “Minimum Wage Ordinance” and substitute with “; in particular, the relevant guidelines are not only unable to allay public concerns about the implementation of the statutory minimum wage, but have also triggered controversies over employee benefits, such as whether employees are entitled to any wages for their meal breaks and rest days, etc., with the result that the negative impact of the legislation may be far more serious than expected; in this connection”; and to delete “to temporarily suspend the implementation of the Ordinance” immediately before the full stop and substitute with “: (a) to vigorously publicize that under the statutory minimum wage, employees’ minimum wage should be \$28 per hour times the number of actual working hours; (b) to step up promoting that there should be no retrogression of employees’ remunerations when compared with their previous remunerations; (c) to encourage the community to respect the rule of law, refrain from making arbitrary moral judgment, and oppose labelling employers who cannot afford extra expenses as ‘unscrupulous employers’; (d) to proactively and thoroughly clarify public skepticism or misunderstanding of the legislation; and (e) to introduce a half-year cushion period for the implementation of the legislation, during which mediation will first be conducted and there will not be immediate prosecution in the event of disputes, so that employers and employees will have sufficient time to adapt to the new legislation, so as to enable all sectors in the society, in the spirit of rationality, pragmatism and partnership, to bring forth a soft landing of the minimum wage to enable all employees in Hong Kong to truly benefit”.

Question on Hon Vincent FANG’s amendment to Hon Paul TSE’s motion proposed and put.

Hon IP Wai-ming claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 23 were present, four were in favour of the amendment, 18 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, 20 were against the amendment and two abstained (voting record in **Appendix IV**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negated.

Question on Hon Paul TSE's motion put.

Hon IP Wai-ming claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

Hon Ronny TONG stated that he had mistakenly voted in favour of the motion; his intent was to vote against it. The President ordered that the voting record be amended accordingly.

The President announced that among the Members returned by functional constituencies, 23 were present, one was in favour of the motion, 21 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present and 22 were against the motion (voting record in **Appendix V**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negated.

Improving ancillary facilities at various crossings for the convenience of residents travelling between Guangdong and Hong Kong

Hon Jeffrey LAM moved the following motion and spoke on the motion:

That, since exchanges between Hong Kong and Mainland have become increasingly frequent, the utilization rates of various land boundary control points are rising year by year, with serious congestion in the flows of people and vehicles occurring frequently during peak periods, this Council urges the Administration to adopt the following improvement measures:

- (a) to conduct studies on the acutely uneven utilization rates of boundary control points in Hong Kong at present, put in place different incentive measures to divert cross-boundary travellers and balance the utilization rates of various crossings, and enhance the arrangements for crowd diversion on weekends and during public holidays, so as to shorten the clearance time for residents travelling between Guangdong and Hong Kong;

- (b) to expeditiously discuss with the Mainland Government improvement to the ancillary facilities near various boundary control points, so as to enhance the linkage between the boundary control points and the facilities such as roads and railway lines, etc., and make it more convenient for residents in both places to travel to and from boundary control points; and
- (c) to expedite the studies on the clearance arrangements at the new boundary control points under planning or construction and on the surrounding ancillary facilities, and having regard to demand, launch extension or improvement works, so as to ensure that the new boundary control points can achieve better diversion effect and alleviate congestion at other crossings.

Question on Hon Jeffrey LAM's motion proposed.

The Secretary for Security spoke on the motion.

Four Members spoke on the motion.

The Secretary for Security spoke again.

Hon Jeffrey LAM replied.

Question on Hon Jeffrey LAM's motion put and agreed to.

Next meeting

The President declared that the next meeting of the Council would be held on 18 May 2011 at 11:00 am.

The Council was adjourned at 8:35 pm.


