Bills

Legislation Publication Bill

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 20 October 2010 resumed.

Dr Hon Margaret NG, Chairman of the Bills Committee on Legislation Publication Bill, addressed the Council on the Committee's Report. After the address, she spoke on the Bill in her personal capacity as a Member.

A Member spoke on the Bill.

The Secretary for Justice replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into committee and considered the Legislation Publication Bill.

Question that clauses 3, 13, 15, 16, 18, 22 to 27 and 29 to 35 stand part of the Bill proposed, put and agreed to.

Question that clauses 1, 2, 4 to 12, 14, 17, 19, 20 and 21, the heading of Part 6 and clause 28 stand part of the Bill proposed.

The Secretary for Justice moved amendments to clauses 1, 2, 4, 10, 11, 12, 14, 17, 19, 20 and 21, the heading of Part 6 and clause 28, as well as the deletion of clauses 5 to 9. He then spoke on the amendments.

Question on the amendments put and agreed to.

The Deputy Chairman stated that as the amendment to delete clauses 5 to 9 had been passed, clauses 5 to 9 were therefore deleted from the Bill.

Question that clauses 1, 2, 4, 10, 11, 12, 14, 17, 19, 20 and 21, the heading of Part 6 and clause 28 as amended stand part of the Bill proposed, put and agreed to.

New clause 4A, the new heading before new clause 10A, and new clauses 10A, 10B, 10C, 10D and 20A read the first time.

The Secretary for Justice moved the Second Reading of new clause 4A, the new heading before new clause 10A, and new clauses 10A, 10B, 10C, 10D and 20A. He then spoke on the new clauses and the new heading.

Question on the Second Reading of new clause 4A, the new heading before new clause 10A, and new clauses 10A, 10B, 10C, 10D and 20A proposed, put and agreed to.

New clause 4A, the new heading before new clause 10A, and new clauses 10A, 10B, 10C, 10D and 20A read the second time.

The Secretary for Justice moved the addition of new clause 4A, the new heading before new clause 10A, and new clauses 10A, 10B, 10C, 10D and 20A to the Bill.

Question on the addition proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Justice reported that

the Legislation Publication Bill

had passed through committee stage with amendments. He moved that the Bill be read the third time and do pass.

A Member spoke on the motion.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Stamp Duty (Amendment) (No. 2) Bill 2010

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 8 December 2010 resumed.

Hon James TO, Chairman of the Bills Committee on Stamp Duty (Amendment) (No. 2) Bill 2010, addressed the Council on the Committee's Report. After the address, he spoke on the Bill in his personal capacity as a Member.

A Member and Hon Abraham SHEK spoke on the Bill.

At 3:59 pm, while Hon Abraham SHEK was speaking, the President resumed the chair.

Nine more Members spoke on the Bill.

The Secretary for Transport and Housing replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into committee and considered the Stamp Duty (Amendment) (No. 2) Bill 2010.

Question that clauses 2, 3, 6, 11, 13 and 15 to 18 stand part of the Bill proposed.

Two Members spoke on the clauses.

Hon James TO spoke for the second time.

The Secretary for Transport and Housing spoke on the clauses.

Question that clauses 2, 3, 6, 11, 13 and 15 to 18 stand part of the Bill put and agreed to.

Question that clauses 1, 4, 5, 7, 9, 12 and 14 stand part of the Bill proposed.

The Secretary for Transport and Housing moved amendments to clauses 1, 5, 7, 9, 12 and 14, and the deletion of clause 4. He then spoke on the amendments.

A Member spoke on the amendments.

Question on the amendments put and agreed to.

The Chairman stated that as the amendment to delete clause 4 had been passed, clause 4 was therefore deleted from the Bill.

Question that clauses 1, 5, 7, 9, 12 and 14 as amended stand part of the Bill proposed, put and agreed to.

Question that clauses 8 and 10 stand part of the Bill proposed.

The Chairman stated that the Secretary for Transport and Housing had given notice to move amendments to clauses 8 and 10. The Secretary's amendments to clause 8 sought to amend the heading of the proposed section 29CA in the Bill and subsections (2) to (9) of that section, as well as to add subsections (3A), (4A), (6A) and (6B). The Secretary's amendments to clause 10 sought to amend the heading of the proposed section 29DA in the Bill and subsections (1) to (12) and (14) of that section, and to add subsections (3A), (7A), (9A), (9B) and (13A). Besides, Hon Abraham SHEK had also given notice to move amendments to clauses 8 and 10. Hon Abraham SHEK's amendments to clause 8 sought to amend subsection (2) of the proposed section 29CA in the Bill and to add subsection (11) to that section. His amendments to clause 10 sought to amend section (2) of the proposed 29DA in the Bill, and to add subsection (13B) to that section. Irrespective of whether the Secretary's amendments were passed or not, Hon Abraham SHEK might move his amendments. The Chairman then ordered a joint debate on the original provisions and the amendments.

The Secretary for Transport and Housing moved amendments to clauses 8 and 10, and spoke on the amendments.

Hon Abraham SHEK and four other Members spoke on the amendments.

Hon James TO, Hon Abraham SHEK and Hon LEUNG Kwok-hung spoke for the second time.

Hon Abraham SHEK spoke for the third time.

The Secretary for Transport and Housing spoke again.

Question on the amendments put and agreed to.

Hon Abraham SHEK moved a further amendment to clause 8 to amend subsection (2) of the proposed section 29CA in the Bill, and a further amendment to clause 10 to amend subsection (2) of the proposed section 29DA in the Bill.

Question on the amendments put.

Hon Abraham SHEK claimed a division. The Chairman then ordered the committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, two were in favour of the amendments and 21 against them; while among the Members returned by geographical constituencies through direct elections, 23 were present and 22 were against the amendments (voting record in **Appendix I**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Hon Abraham SHEK then moved an amendment to clause 8 to add subsection (11) to the proposed section 29CA in the Bill, and an amendment to clause 10 to add subsection (13B) to the proposed section 29DA in the Bill.

Question on the amendments put.

Hon Abraham SHEK claimed a division. The Chairman then ordered the committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, six were in favour of the amendments and 17 against them; while among the Members returned by geographical constituencies through direct elections, 23 were present and 22 were against the amendments (voting record in **Appendix II**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clauses 8 and 10 as amended stand part of the Bill proposed, put and agreed to.

New clauses 6A and 11A read the first time.

The Secretary for Transport and Housing moved the Second Reading of new clauses 6A and 11A, and spoke on the new clauses.

Question on the Second Reading of new clauses 6A and 11A proposed, put and agreed to.

New clauses 6A and 11A read the second time.

The Secretary for Transport and Housing moved the addition of new clauses 6A and 11A to the Bill.

Question on the addition proposed, put and agreed to.

New clause 13A read the first time.

Hon Abraham SHEK moved the Second Reading of new clause 13A and spoke on the new clause.

Three Members spoke on the new clause.

The Secretary for Transport and Housing spoke on the new clause.

Hon Abraham SHEK spoke again.

Question on the Second Reading of new clause 13A proposed and put.

Hon Abraham SHEK claimed a division. The Chairman then ordered the committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 21 were present, six were in favour of the motion and 15 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, seven were in favour of the motion and 15 against it (voting record in **Appendix III**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Question that the long title stand part of the Bill proposed.

The Secretary for Transport and Housing moved an amendment to the long title and spoke on the amendment.

Question on the amendment put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Transport and Housing reported that

the Stamp Duty (Amendment) (No. 2) Bill 2010

had passed through committee stage with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Members' Motions

Expediently implementing the formulation of standard working hours

Hon IP Wai-ming moved the following motion and spoke on the motion:

That after many years of striving by the labour sector, the Minimum Wage Ordinance formally came into force this year, marking a great step forward for labour rights and interests; yet, minimum wage and standard working hours must complement each other in order to be able to maximize the effect of protecting grassroots workers and facilitating Hong Kong's economic development; in this connection, this Council urges the SAR Government to, having regard to the well-being of employees at large, spare no efforts in making preparations for enacting legislation on standard working hours and expediently implement the relevant tasks, including:

- (a) to set a deadline and timetable for conducting studies on regulating working hours;
- (b) to establish a 'study group on legislating for standard working hours' comprising representatives of the Government, employees and employers;
- (c) to regularly hold discussions in the Panel on Manpower of the Legislative Council, and report to the Labour Advisory Board on the progress, so as to strengthen the Legislative Council's function of monitoring the Government on the one hand, and increase the transparency of the relevant work on the other, with a view to enabling the public and the labour sector to know the progress of the studies;
- (d) to proactively ascertain the views of the trade unions of various industries and the relevant stakeholders on standard working hours; and

- (e) through various forms of publicity and education, to increase the public's knowledge and understanding of standard working hours.

While Hon IP Wai-ming was speaking, the President left the chair at 8:47 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Hon IP Wai-ming Hon WONG Yuk-mas motion proposed.

The President's Deputy stated that Hon WONG Sing-chi would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon WONG Sing-chi moved the following amendment to Hon IP Wai-ming's motion and spoke on the motion and the amendment:

To delete "after many years of striving by the labour sector" after "That" and substitute with "minimum wage and standard working hours are the legitimate rights and interests that the Hong Kong labour sector has been requesting to implement for many years; while after many years of striving by the various social sectors"; to delete "formally came" after "Minimum Wage Ordinance" and substitute with "has formally come"; to delete ";" after "labour rights and interests" and substitute with ","; to add "and giving due compensation for overtime work" after "regulating working hours"; to delete "and" after "on standard working hours,"; and to add "and (f) to formulate and implement family-friendly policies, which are closely related to the objectives of standard working hours, so as to promote work-life balance" immediately before the full stop.

Question on Hon WONG Sing-chi's amendment to Hon IP Wai-ming's motion proposed.

The Secretary for Labour and Welfare spoke on the motion and the amendment.

Four Members and Hon Paul CHAN spoke on the motion and the amendment.

At 9:40 pm, while Hon Paul CHAN was speaking, the President resumed the chair.

Four more Members spoke on the motion and the amendment.

The President suspended the meeting at 10:13 pm.

* * * * *

The Council resumed at 2:30 pm on 23 June 2011.

Nine other Members and Hon LEUNG Kwok-hung spoke on the motion and the amendment.

While Hon LEUNG Kwok-hung was speaking, Hon WONG Kwok-hing sought elucidation of a point raised by Hon LEUNG Kwok-hung in his speech. Hon LEUNG Kwok-hung elucidated and continued to speak.

Another Member and Hon WONG Yuk-man spoke on the motion and the amendment.

While Hon WONG Yuk-man was speaking, Hon Paul TSE raised a point of order that the expression used by Hon WONG Yuk-man in his speech was one which had previously been ruled to be offensive by the President. He asked whether such ruling was still valid.

The President stated that according to the Rules of Procedure, public officers and Members attending a Council meeting enjoyed the same status. Members should not use offensive language about public officers attending a Council meeting. The President further stated that unless a Member considered that the expression used by Hon WONG Yuk-man was offensive, he would not stop Mr WONG from speaking.

Hon Paul TSE said that although the public officer mentioned in Hon WONG Yuk-man's speech was not present at the meeting, he considered the expression used by Mr WONG was offensive.

Hon Albert CHAN said that he recalled that according to the Rules of Procedure, the rule about the use of offensive language only applied to public officers and Members while they were attending Council meetings. He asked the President to give an interpretation on this rule and make a ruling on the issue raised by Hon Paul TSE.

The President stated that there were two restrictions on the use of language in a parliamentary context. First, Members should not use inappropriate language against any person under all circumstances. Second, according to the Rules of Procedure, Members should not use offensive language about other Members.

As public officers attending Council meetings enjoyed the same rights as Members, the second restriction was also applicable to public officers attending Council meetings.

The President further stated that as Hon Paul TSE had requested him to make a ruling on whether the expression used by Hon WONG Yuk-man had contravened the Rules of Procedure, he would suspend the meeting to consider the issue. The President then suspended the meeting at 3:50 pm.

The Council resumed at 3:54 pm.

The President stated that Rule 41(4) of the Rules of Procedure provided that “it shall be out of order to use offensive and insulting language about Members of the Council”. This provision applied to all Members of the Council but it did not specify whether or not Members should be present at a meeting. Hence, it should be out of order to use offensive and insulting language about Members of the Council at any time during Council meetings. Rule 10(2) of the Rules of Procedure provided that “These Rules of Procedure.....shall apply, in relation to the item of business in respect of which a public officer attends a meeting, to that public officer as they apply to a Member”. This rule, however, stipulated that certain rules in the Rules of Procedure which were applicable to Members, such as Rule 41(4), should also apply to public officers when they were attending meetings of this Council.

The President ruled that as far as the present case was concerned, Rule 41(4) did not apply as the public officer mentioned in Hon WONG Yuk-man’s speech was not present at the meeting. Nevertheless, the President suggested that Members should use their language skills and avoid making derogatory remarks against public officers. The President then asked Hon WONG Yuk-man to continue with his speech.

Hon Paul TSE raised another point of order. He considered that the mention of the public officer’s name in Hon WONG Yuk-man’s speech was irrelevant to the subject under debate, as evidenced by the fact that the public officer concerned was not even a designated representative of the Administration to attend this item of business.

The President stated that it was common for Members, when delivering speeches at Council meetings, to refer to persons who were not present at the meetings. The President considered that it was not practical to set precise and specific standards to deal with matters in connection with relevance of Members’ speeches. Moreover, to protect Members’ freedom of speech, it was undesirable to impose a stringent requirement on Members by disallowing them

to mention, during Council meetings, public officers who were not present at such meetings. The President then asked Hon WONG Yuk-man to continue with his speech.

Hon WONG Yuk-man continued to speak.

Two more Members spoke on the motion and the amendment.

Hon IP Wai-ming spoke on the amendment.

The Secretary for Labour and Welfare spoke again.

Question on Hon WONG Sing-chi's amendment to Hon IP Wai-ming's motion put.

Hon TAM Yiu-chung claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, six were in favour of the amendment, nine against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 18 were present, 13 were in favour of the amendment and four abstained (voting record in **Appendix IV**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negated.

Hon IP Wai-ming replied.

Question on Hon IP Wai-ming's motion put.

Dr Hon Philip WONG claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, six were in favour of the motion, nine against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 18 were present, 16 were in favour of the motion and one abstained (voting record in **Appendix V**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negated.

Safeguarding the room for business and development of small and medium enterprises

Dr Hon LAM Tai-fai moved the following motion and spoke on the motion:

That after the financial tsunami, European and American economies have not yet fully recovered, and market purchasing power has yet to revive, in addition, the US dollar has remained weak, the exchange rates of Renminbi, etc., have kept rising, rents and raw materials prices have continued to soar, causing operating costs to increase substantially and making the business environment of small and medium enterprises ('SMEs') very difficult; what SMEs worry more is that if regulatory legislation is enacted in the future, they may easily contravene the law inadvertently, be oppressed by large enterprises bringing private litigations against them, and they need to bear heavy compliance costs and litigation fees, thus dealing a severe blow to their business and development, and producing inestimable negative impact on the overall economic development and employment in society; in this connection, this Council urges that when enacting cross-sector regulatory legislation, the Government should completely exempt SMEs from the scope of regulation, so as to effectively safeguard consumer interests as well as SMEs' room for development and sustainable competitiveness.

While Dr Hon LAM Tai-fai was speaking, the President left the chair at 4:40 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Dr Hon LAM Tai-fai's motion proposed.

The President's Deputy stated that five Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the amendments would be debated together in a joint debate.

Hon WONG Ting-kwong, who would move an amendment, spoke on the motion and the amendments.

At 4:54 pm, while Hon WONG Ting-kwong was speaking, the President resumed the chair.

Hon Albert CHAN, Hon Ronny TONG, Hon WONG Yuk-man and Hon Fred LI, who intended to move amendments, spoke on the motion and the amendments.

The Secretary for Commerce and Economic Development spoke on the motion and the amendments.

Seven Members spoke on the motion and the amendments.

Dr Hon LAM Tai-fai spoke on the amendments.

The Secretary for Commerce and Economic Development spoke again.

While the Secretary for Commerce and Economic Development was speaking, Hon Albert CHAN raised a point of order stating that while the President did not permit Dr Hon LAM Tai-fai to propose a motion focusing on the Competition Bill, the response to Dr LAM's motion given by the Secretary was however mostly related to the Competition Bill.

The President stated that Members should not propose a motion on matters which were being scrutinized by a Bills Committee. If such matters were allowed to be debated in Council before the Bills Committee concluded its work, it would amount to depriving the Bills Committee of its proper functions. Hence, if Members wished to express views on the Competition Bill, they might do so at meetings of the Bills Committee. Members would have an opportunity to debate the Bill in Council when the Second Reading debate on the Bill was resumed. The President added that he, however, would not apply the same standards explained above on speeches of Members made in a debate. The Secretary for Commerce and Economic Development then continued to speak.

Hon WONG Ting-kwong moved the following amendment to Dr Hon LAM Tai-fai's motion:

To add "at present small and medium enterprises ('SMEs') in Hong Kong face many challenges;" after "That"; to delete "small and medium enterprises ('SMEs')" after "business environment of" and substitute with "SMEs"; and to delete "completely exempt SMEs from the scope of regulation" after "the Government should" and substitute with "provide SMEs with appropriate exemptions; at the same time, the Government should also formulate strategies and measures to comprehensively improve the business environment, and through various aspects such as taxation, financing, upgrading and transformation, manpower training, product exploration, research and development, brand development, and continuously developing the local, export and China's domestic sales markets, etc., as well as by capitalizing on the Mainland and Hong Kong Closer Economic Partnership Arrangement and the Framework Agreement on Hong Kong/Guangdong Co-operation, assist SMEs in reducing expenses on operating costs, developing markets and strengthening co-operation between enterprises in the two places".

Question on Hon WONG Ting-kwong's amendment to Dr Hon LAM Tai-fai's motion proposed and put.

Dr Hon LAM Tai-fai claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

Hon Tanya CHAN stated that she had voted against the motion but the voting result indicated that she had abstained from voting. The President ordered that the voting record be amended accordingly.

The President announced that among the Members returned by functional constituencies, 10 were present, four were in favour of the amendment, four against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, five were in favour of the amendment, five against it and nine abstained (voting record in **Appendix VI**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negated.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on “Safeguarding the room for business and development of small and medium enterprises” or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Albert CHAN moved the following amendment to Dr Hon LAM Tai-fai’s motion:

To add “, given that” after “That”; to add “(including the rents of public housing shopping arcades under The Link Management Limited)” after “kept rising, rents”; and to add “and strive to improve the business environment of SMEs by, for example, considering buying back The Link Real Estate Investment Trust to lower the rents of public housing shopping arcades to reasonable levels” after “scope of regulation”.

Question on Hon Albert CHAN’s amendment to Dr Hon LAM Tai-fai’s motion proposed and put.

Hon Albert CHAN claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 10 were present, two were in favour of the amendment, six against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, three were in favour of the amendment, 14 against it and three abstained (voting record in **Appendix VII**). Since the question was not agreed by a majority of

each of the two groups of Members present, he declared that the amendment was negatived.

Hon Ronny TONG moved the following amendment to Dr Hon LAM Tai-fai's motion:

To add “, given that” after “That”; and to delete “; what SMEs worry more is that if regulatory legislation is enacted in the future, they may easily contravene the law inadvertently, be oppressed by large enterprises bringing private litigations against them, and they need to bear heavy compliance costs and litigation fees, thus dealing a severe blow to their business and development, and producing inestimable negative impact on the overall economic development and employment in society; in this connection, this Council urges that when enacting cross-sector regulatory legislation, the Government should completely exempt SMEs from the scope of regulation, so as to” after “very difficult” and substitute with “, this Council urges the Government to expeditiously introduce relevant legislation to protect SMEs' competitiveness and safeguard the rights and interests of consumers; regarding SMEs' worries about regulatory legislation, this Council urges the Government to expeditiously promote a competition culture with every effort and explain to SMEs that they should not believe any rumours, so as to allay their concern about regulatory legislation, and”.

Question on Hon Ronny TONG's amendment to Dr Hon LAM Tai-fai's motion proposed and put.

Hon Ronny TONG claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 10 were present, two were in favour of the amendment, five against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, 10 were in favour of the amendment, two against it and eight abstained (voting record in **Appendix VIII**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon WONG Yuk-man moved the following amendment to Dr Hon LAM Tai-fai's motion:

To delete “rents and” after “kept rising,”; to add “and under rampant ‘developer hegemony’, rents have even been increasing endlessly,” after “continued to

soar,”; to delete “completely” after “the Government should” and substitute with “reasonably and appropriately”; and to delete “, so as to effectively safeguard consumer interests as well as SMEs’ room for development and sustainable competitiveness” immediately before the full stop and substitute with “; at the same time, the Government should reform its land policy to prevent people from driving up the rents of offices or shops, so as to give back reasonable room for survival and development to SMEs”.

Question on Hon WONG Yuk-man’s amendment to Dr Hon LAM Tai-fai’s motion proposed and put.

Hon WONG Yuk-man claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 10 were present, three were in favour of the amendment, one against it and six abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, two were in favour of the amendment, four against it and 14 abstained (voting record in **Appendix IX**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Fred LI moved the following amendment to Dr Hon LAM Tai-fai’s motion:

To delete “completely exempt SMEs from the scope of regulation” after “the Government should” and substitute with “comprehensively study and consider SMEs’ difficulties and worries”.

Question on Hon Fred LI’s amendment to Dr Hon LAM Tai-fai’s motion proposed and put.

Hon WONG Yuk-man claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 10 were present, seven were in favour of the amendment, one against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, 16 were in favour of the amendment and four abstained (voting record in

Appendix X). Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

Dr Hon LAM Tai-fai replied.

Question on Dr Hon LAM Tai-fai's motion as amended by Hon Fred LI put and agreed to.

Next meeting

The President declared that the next meeting of the Council would be held on 29 June 2011 at 11:00 am.

The Council was adjourned at 7:21 pm.


