### **The Chief Executive's Question and Answer Session**

The President reminded Members that if any Member interrupted the proceedings of the meeting, he would order the Member concerned to withdraw from the Council immediately, so as to ensure that the meeting would proceed smoothly and to allow more Members to ask questions.

While the Chief Executive was about to address the Council, Hon LEUNG Kwok-hung stood up and spoke aloud. The President ordered him to withdraw from the Council immediately. Ignoring the President's order, Hon LEUNG Kwok-hung moved forward and threw several sheets of paper. With the assistance of security staff, Hon LEUNG Kwok-hung left the Chamber.

The Chief Executive addressed the Council.

While the Chief Executive was addressing the Council, some people in the public gallery yelled. The President asked the Secretariat staff to ensure that the meeting would not be interrupted.

The Chief Executive continued to address the Council.

Hon WONG Yuk-man asked a question and the Chief Executive replied.

While the Chief Executive was replying to Hon WONG Yuk-man's question, Hon Albert CHAN stood up and spoke aloud. Hon Albert CHAN then threw some paper planes. The President ordered Hon Albert CHAN to withdraw from the Council immediately. Ignoring the President's order, Hon Albert CHAN kept speaking aloud. With the assistance of the Clerk and security staff, Hon Albert CHAN left the Chamber.

Eleven Members and Hon CHAN Kam-lam asked questions and the Chief Executive replied.

While Hon CHAN Kam-lam was asking his question, Dr Hon Margaret NG raised a point of order on whether it was appropriate for Hon CHAN Kam-lam to refer to a court case which was pending in court.

The President stated that he would consider whether Hon CHAN Kam-lam's question would prejudice the court case after Mr CHAN had raised his question.

Hon CHAN Kam-lam continued to ask his question and the Chief Executive replied.

Two other Members asked questions and the Chief Executive replied.

The Council was adjourned at 4:33 pm.
