Buildings Energy Efficiency (Fees) Regulation and the Buildings Energy Efficiency (Registered Energy Assessors) Regulation

The Administration's response to Action Items at the Subcommittee meeting on 22 February 2011

(a) Summary highlighting views of the Technical Task Force and relevant minutes

The Administration established a Trade Task Force and a Technical Task Force with representatives from professional bodies, major chambers of commerce, property management companies, real estate developers and retail associations, which served as platforms for discussing the legislative proposal. We have been in close collaboration with the Technical Task Force during the preparation of the Buildings Energy Efficiency (Fees) Regulation and the Buildings Energy Efficiency (Registered Energy Assessors) Regulation ("the REA Regulation").

2. We have been meeting the Technical Task Force since April 2008 and collaborated on the legislative framework. The Technical Task Force, at its latest meeting of 10 November 2010, had also been briefed in detail the latest legislative proposal of the two Regulations. We have received no adverse comments from the Technical Task Force. Summary of the relevant notes of the November meeting is at <u>Annex A</u>. Subsequently, the Technical Task Force has also been kept informed of the progress of the two Regulations, including their publishing in the gazette and tabling in the Legislative Council.

(b) Composition of other disciplinary boards under existing legislation

3. Sections 15 and 16 of the REA Regulation govern the composition of the disciplinary board panel and disciplinary boards, respectively. The composition of disciplinary bodies of some other engineering related legislation is summarized below:

(c) Experience or knowledge required under section 5(2) and examples of similar arrangement under other legislation

4. As explained at the Subcommittee meeting held on 22 February 2011, sections 5(1)(a), 5(1)(b) and 5(2) are designed to cater for different groups of eligible persons applying for registration as Registered Energy Assessors ("REAs"). For section 5(2), we intend to cover an applicant whose competence is comparable to his counterparts seeking registration under section 5(1), by looking at his knowledge, qualification, education,

experience and training, as a whole. Section 5(2) provides reasonable flexibility for the Director of Electrical and Mechanical Services ("the Director") to allow registration from a competent candidate who does not have the prescribed qualification required by section 5(1). For example, an engineer who has a qualification not locally recognised but has expertise and extensive practical experience such as having implemented special building projects of high energy efficiency performance and has ample and well recognized engineering knowledge on energy efficiency of building services installations in buildings.

5. Similar arrangement is adopted could be found in other registration mechanisms for the relevant authorities to determine special cases, for example, section 12(1)(a)(iii) of the Engineers Registration Ordinance (Cap. 409) for registration of a Registered Professional Engineer and section 5(2B) of the Lifts and Escalators (Safety) Ordinance (Cap. 327) for registration of lifts engineers or escalator engineers.

(d) Inclusion of the effective date of registration of REAs in the Register of REAs


6. Members raised at the Subcommittee meeting held on 22 February 2011 that members of the public might have interest to know when the validity period of a registration of REA commences, and asked the Administration to include in the Register of Registered Energy Assessors ("the Register") the effective date of registration of REAs. After serious consideration, the Administration submits that the primary purpose of the Register is to enable a member of the public to ascertain who the REAs are and whether their registrations are still valid for the time being when REAs are required to undertake any work. Hence, the expiry dates of their registrations will be entered into the Register. While we do not envisage that there will be prevalent needs for members of the public, after completion of works (especially many years afterwards), to check or ascertain the eligibility of the REA at the time of the works, if there are special cases where the history of the registration of an REA needs to be traced, any person may direct their queries to the Director.

(e) Samples of specified forms

7. Specified forms should be used when a person applies to be an REA (sections 5 and 8 of the REA Regulation), seeks renewal of his registration (section 6 of the REA Regulation), seeks a duplicate of his certificate of registration (section 10 of the REA Regulation) or notify the Director of change in particulars (section 11 of the REA Regulation). Samples of the draft specified forms are at **Annexes B to D**.
