#### I. Election of Chairman

Dr Margaret NG was elected Chairman of the Subcommittee.

#### II. Meeting with the Administration

2. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

3. <u>The Administration</u> stated that Schedule 3 would be included in future mutual legal assistance in criminal matters orders in line with Section 4(3) of the Mutual Legal Assistance in Criminal Matters Ordinance (Cap. 525) and to facilitate members' understanding on modification in the orders.

4. In light of the Coroner's death inquest into the Manila incident of 23 August 2010 involving a tour group from Hong Kong, <u>the Subcommittee</u> requested the Administration to consider providing a framework for assistance between Hong Kong and overseas jurisdictions in death inquests. The Administration agreed to consider the suggestion and would report the results of its study to the Panel on Security or the relevant Panel for follow-up.

5. <u>The Subcommittee</u> requested the Administration to provide information on relevant precedent court cases involving immovable property that was considered by the court as "instrument of crime" vis-à-vis "location of crime".

6. <u>The Subcommittee</u> requested the Administration to highlight the following in the speech of the Secretary for Security when moving the resolution on Mutual Legal Assistance in Criminal Matters (India) Order ("the Order") at the Council meeting -

- (a) although no provision was made in the Order for refusal of assistance if a request related to an external offence punishable with death, the governments of the Hong Kong Special Administration Region and the Republic of India had agreed that the above request might be refused on the ground of "essential interest" under Article IV(1) of the Order; and
- (b) Article X(4) had to be read in the context of Article X(3) so that any additional questions raised under Article X(4) should be within the original scope of questions specified under Article X(3).

### **III.** Any other business

7. <u>The Chairman</u> said that the Subcommittee had completed scrutiny of the Order. Pending the information to be provided by the Administration, the Subcommittee would submit a report to the House Committee.

8. The being no other business, the meeting ended at 9:40 am.
