1. Community Care Fund ("CCF")	
At the meeting on 12 November 2010, members agreed that a public hearing be conducted to solicit views on CCF before the Administration had finalized the detailed arrangements for it.	January 2011
2. Measures to enhance the support for and prospects of elite athletes	
At the informal meeting on 1 November 2010, the Administration proposed to brief the Panel on measures to enhance the support for elite athletes in February 2011.	January 2011
At the special meeting on 17 December 2010, a motion was passed urging the Government to set up a Sports Fund with a sum equal to the \$6 billion direct cost to be earmarked for staging the 2023 Asian Games, regardless of whether it is successful in submitting the bid or in bidding to host the Games, for the purpose of promoting the policy of sports for all and enhancing the training and retirement arrangements for local elite athletes, and to draw up immediately a ten-year blueprint for sports development.	
3. Implementation of the outstanding leisure and cultural services projects of the former municipal councils	
The Panel received a referral from the meeting between Legislative Council ("LegCo") Members and Sha Tin District Council members on 10 June 2010 regarding the slow progress in the implementation of the outstanding leisure and cultural services projects of the former	February 2011

municipal councils in Sha Tin. With the concurrence of the Chairman, issues relating to the implementation of the outstanding leisure and cultural services projects of the former municipal councils are included on this list for future discussion.

The Administration has agreed to brief the Panel on the subject in February 2011.

4. Territory-wide survey on Intangible Cultural Heritage ("ICH") in Hong Kong

An information paper to brief the Panel on the progress of Phase 1 of the territory-wide survey on ICH will be issued in February 2011.

5. Monitoring of unlicensed hotels and guesthouses

At the meeting on 11 June 2010, members agreed that issues relating to the monitoring of unlicensed hotels and guesthouses should be discussed, as suggested by Hon Paul TSE. At the meeting on 14 October 2010, Hon Paul TSE urged that the issue should be discussed as soon as possible for the early formulation of preventive measures. At the informal meeting on 1 November 2010, the Administration agreed that the subject be discussed in March 2011.

6. Meeting with members of the Arts Development Council ("HKADC")

At the meeting on 14 October 2010, Hon Cyd HO considered that HKADC should review the election procedures for members returned by the arts constituencies, with a view to ensuring their fairness and transparency.

7. Promotion of arts and culture education

At the informal meeting on 1 November 2010, the Administration agreed to brief members on its initiatives to promotion arts and culture education.

8. Advisory Committee on Arts Development ("ACAD")

Hon Tanya CHAN proposed to discuss issues relating to the setting up of ACAD.

9. Monitoring of private recreational leases

At the meeting on 9 July 2010, members agreed that the compliance with the conditions of government leases by private clubs should be discussed, as suggested by Hon Tanya CHAN.

At the meeting on 14 October 2010, Hon Tanya CHAN suggested that the issue should be discussed no later than the end of 2010, as many of the government leases for private clubs would expire in 2011 or 2012.

The Administration advised that it needed more time to complete the review on private recreational leases policy.

10. Matter relating to the Village Representative ("VR") Elections

At the informal meeting on 1 November 2010, the Administration advised that the next VR election would

be held from early to mid January 2011, and upon the conclusion of the elections, it would revert to the Panel with the key features of the arrangements and outcome of the elections.

11. Regulation of internet cafes

At the meeting on 11 June 2010, members passed a motion to urge the Government to study the regulation of internet cafes by way of a licensing regime and draw up a timetable for conducting the study. The Administration agreed to revert to the Panel on the subject after consultation with various stakeholders and the public.

12. Construction of a District Open Space, Sports Centre and Library in Area 74, Tseung Kwan O

The Administration has advised that the Sai Kung DC was consulted on the conceptual design of the project in September 2008. On the completion of the detailed design, the Administration will seek the funding approval of the Finance Committee in mid-2011.

13. Implementation of District Minor Works projects

At the informal meeting on 1 November 2010, the Administration proposed to brief the Panel on issues related to the implementation of District Minor Works projects, such as the manpower requirement and the provision for the maintenance of these projects.

14. Vibrant people, harmonious community activities

At the informal meeting on 1 November 2010, the Administration proposed to brief the Panel on the implementation of the "Vibrant people, harmonious community activities" in the 18 districts.

15. Strengthening the arts and cultural software of Hong Kong

At the meeting on 14 May 2010, members urged the Administration to review the level of subvention for performing arts groups. The Administration advised that a consultancy study had been commissioned to review the funding mechanism for performing arts to ensure the prudent use of public funds in a sustainable manner, to study the feasibility of introducing an "entry and exit" mechanism and providing a progression ladder for the performing arts sector for its flexible development, and to recommend what performing arts forms should fall within the subvention mechanism. The Administration agreed to revert to the Panel when the study was completed in 2011.

16. Effective enforcement of maintenance orders

At the meeting on 11 June 2010, members noted the Administration's plan to consult the legal professional on the proposed legislative amendments to facilitate maintenance payees' collection of maintenance payment in the 4th quarter of 2010. Members agreed that public hearing should be conducted to listen to the views of deputations when the legislative proposals were presented to LegCo.

17. Development of public library services

At the special meeting with the Public Libraries Advisory Committee ("PLAC") on 14 June 2010, members welcomed the suggestion for the Panel and PLAC to meet again in the future to further exchange views on issue relating to the development of library
