LEGISLATIVE COUNCIL PANEL ON HOME AFFAIRS

Nomination of Representatives of Arts Interests for the Hong Kong Arts Development Council

PURPOSE

This paper provides Members with information on the nomination of arts interests representatives for the Hong Kong Arts Development Council (HKADC) (the nomination exercise).

BACKGROUND

- 2. Established in 1995, the HKADC is a statutory body set up to promote the development of arts in Hong Kong. Under section 3 of the HKADC Ordinance (Cap. 472), the HKADC comprises 27 members, of which a Chairman, a Vice-chairman and not more than 22 other members shall be appointed by the Chief Executive. Pursuant to clauses (4) and (5) of section 3 of the Ordinance, of the 22 other members, up to 10 may be nominated by specified arts interests, viz. arts administration, arts criticism, arts education, Chinese opera (xiqu), dance, drama, film arts, literary arts, music and visual arts.
- 3. The arrangements of the nomination exercise have been drawn up having regard to the views of the HKADC and the arts community and past experiences. So far, seven nomination exercises have been conducted. Home Affairs Bureau (HAB) commissioned a consulting firm through open bidding as the nomination agent for each nomination exercise.

THE 2010 HKADC NOMINATION EXERCISE

Four-phase Nomination Exercise

- 4. Following past practice, the 2010 nomination exercise proceeded in four phases as outlined below
 - (a) Phase 1 registration of members of the nominating bodies (detailed eligibility criteria at **Annex A**)
 - Eligible arts organisations¹ or individual arts workers² may register as members of the nominating bodies of the respective arts interests. Registered members of the nominating bodies are published in the gazette³.
 - (b) <u>Phase 2 voter registration</u> (detailed registration guidelines at <u>Annex B</u>)
 - Arts organisations which have been registered as members of the nominating bodies may register their members or their employees who engage in artistic productions or arts administration as voters⁴.
 - Individual arts workers who are registered as members of nominating bodies in Phase 1 will automatically become voters and do not need to undergo voter registration

Eligible arts organisations should be registered bona fide arts organisations with an objective to promote arts development and set up for at least one year in Hong Kong prior to the commencement of the nomination exercise.

Eligible individual arts workers should be current or former members, co-opted members, art advisers, examiners, awardees and grantees of the HKADC, or art advisers and grantees of the Leisure and Cultural Services Department (LCSD) or have collaborated with LCSD in holding art exhibitions / competitions or have participated in these programmes. Full-time or part-time teaching staff of local tertiary institutions, secondary and primary schools teaching arts subjects are also eligible for registration under "arts education".

Membership of the nominating bodies, once gazetted, will continue to be valid in subsequent nomination exercises without the need for re-registration unless the arts organizations / individual arts workers concerned wish to update their particulars or change the arts interests they have registered.

Such voter registrations should be renewed in each nomination exercise as membership and staffing composition of arts organisations may change over time.

(c) Phase 3 – candidate nomination (detailed nomination guidelines at **Annex C**)

• Unless disqualified under section 3(6) of the HKADC Ordinance⁵, registered voters may seek candidature in their own arts interest. A valid candidate nomination should be backed by five proposers or 1% of the number of the registered voters from the same arts interest (whichever is the higher).

(d) Phase 4 – electioneering and polling

- Candidates may publicise their election platforms and are invited to attend a candidate forum organised by the nomination agent.
- Polling was held for three days from 17 to 19 September 2010 (Friday to Sunday) in order to facilitate voters' participation.
- Under a "cross voting system", each voter may cast a maximum of 10 votes, one vote in each contested arts interest, for candidates standing for nomination. Introduced in 1999, the system aims to encourage members of the arts sector to take a broad view of the development of the dynamic sector. The respective number of registered voters for the 10 arts interests and a breakdown of the votes cast in the 2010 nomination exercise are set out at **Annex D**.

Publicity Work

- 5. For the nomination exercise in 2010, publicity was stepped up to promote understanding of the arts community towards the nomination exercise. Two briefing sessions were conducted for the public in March 2010 to introduce the arrangements of the nomination exercise and the work of the HKADC. In addition to press releases, radio broadcast, letter, emails, SMS and phone contacts, HAB adopted the following measures to enhance publicity on the nomination exercise
 - (a) establishing a dedicated website to provide up-to-date information on the nomination exercise;
 - (b) placing advertisements of the nomination exercise on a number of newspapers (including Apple Daily, Headline Daily, Hong Kong Economic Journal, Ming Pao, Sing Tao and South China Morning Post) and arts magazines (including a.m.post, Artmap, finemusic, Muse and Time-out);
 - (c) distributing publicity leaflets and placing posters at numerous venues including the offices of HAB and the HKADC; the Hong Kong Academy for Performing Arts; the Hong Kong Arts Centre; the Jockey Club Creative Arts Centre; the Sunbeam Theatre; the civic centres, museums and major libraries of the LCSD; and the Public Enquiry Services Centres of the 18 District Councils; and
 - (d) hanging giant publicity banners on the exterior wall of the Hong Kong City Hall.
- 6. In response to the recommendations of the Director of Audit and the Public Accounts Committee of the Legislative Council, HAB also implemented the following improvement measures in conducting the 2010 nomination exercise
 - (a) lengthening the period for registration of members of the nominating bodies from 35 days in the 2007 nomination exercise to 42 days in 2010; and

- (b) stepping up voter registration efforts and lengthening the voter registration period from 35 days in the 2007 nomination exercise to 39 days in 2010. The nomination agent also spared no efforts in encouraging the nominating bodies to register their members as voters through various means including website, press releases, letters, e-mails and phone contacts.
- 7. Funding for the publicity of the nomination exercise has increased progressively over the years. The total expenditure for the exercise was about \$1.9 million in 2010, which was more than three folds as compared with \$560,000 in 2001.

Result

8. Members of the arts sector responded positively to the 2010 nomination exercise. A total of 1,909 members participated in the polling and a turnout rate of 27% was achieved, both were record high since the inception of the nomination exercise in 1995.

THE WAY FORWARD

9. The terms of office of the HKADC current members will last until 31 December 2013. The next nomination exercise will be conducted in 2013 to return arts interests representatives to the HKADC for the new term commencing on 1 January 2014. We will work with the HKADC to consider measures that may help the smooth conduct of the 2013 nomination exercise.

2010 Nomination of Representatives of Arts Interests for the Hong Kong Arts Development Council

Eligibility Criteria for Registration as a Member of the Nominating Body of the Respective Arts Interests

An arts organisation or an individual arts worker may apply to be a member of the nominating body of the arts interest(s)^{Note 1} to which it/he/she belongs subject to the criteria set out at (1) or (2) below respectively.

(1) For arts organisations

- (a) The organisation should:
 - (i) be a bona fide arts organisation that aims at promoting the development of the arts; and
 - (ii) be a statutory arts organisation, or have registered under the Societies Ordinance, Companies Ordinance or Trade Unions Ordinance in Hong Kong; and
 - (iii) be formed and operated under a constitution or memorandum and articles of association; and
 - (iv) have been set up for at least <u>one year</u> before the date of commencement of the nomination exercise (i.e. 30 March 2010). In other words, an organisation set up on or after 31 March 2009 is not eligible to apply.
- (b) Multi-disciplinary organisations may apply in more than one arts interest.
- (c) Arts organisations that were specified in the gazette G.N.4115 on 29 June 2007 as members of the nominating bodies of the respective arts interests will continue their membership for the coming term. These organisations do not need to apply again unless they wish to update their particulars or change the arts interests for which they were registered in 2007.

(2) For individual arts workers

- (a) The arts worker should:
 - (i) be a current or former member, co-opted member, arts adviser or examiner of the HKADC, since its establishment on 15 April 1994; or
 - (ii) have been a winner of the arts achievement awards of the HKADC since 15 April 1994; or
 - (iii) have been successful in obtaining grant from the HKADC for arts projects submitted in his/her name since 15 April 1994 (including the participating arts workers listed in the applications for grant); or
 - (iv) have been successful in obtaining grant, financial sponsorship, venue sponsorship or performance fee from the Leisure and Cultural Services Department (LCSD) for arts projects submitted in his/her name since

Note 1 That are, Arts Administration, Arts Criticism, Arts Education, Chinese Opera (Xiqu), Dance, Drama, Film Arts, Literary Arts, Music and Visual Arts

- establishment of LCSD on 1 January 2000 (including the participating arts workers listed in the applications for grant/sponsorship); or
- (v) be or have been in collaboration with LCSD in holding arts exhibitions/competitions; or have participated in these exhibitions/competitions in his/her name since 1 January 2000; or
- (vi) be a current or former arts adviser of LCSD since 1 January 2000; or
- (vii) be a full-time or part-time teaching staff of local tertiary institutions^{Note 2} (including their schools of continuing studies), secondary schools or primary schools in Hong Kong, of subjects relating to arts administration, arts criticism, arts education, Chinese opera (Xiqu), dance, drama, film art, fine art, literary arts, music or visual arts. (Remarks: Applicants qualified under this item should apply to be registered under the arts interest of "Arts Education".)
- (b) Individual arts workers who were specified in the gazette G.N.4115 dated 29 June 2007 as members of the nominating bodies of the respective arts interests will continue their membership for the coming term. These individuals do not need to apply again unless they wish to update their personal particulars or change the arts interests for which they were registered in 2007.

Guidelines for Voter Registration

I. Eligibility to Vote:

- (1) A voter shall be aged 18 years or above; and
- (2) (a) be a member of an arts organisation which has registered as a member of the nominating body (organisational member) of this nomination exercise Note 1, and has joined the organisation for not less than one year Prior to the start date of this nomination exercise, i.e. 30 March 2010; or
 - (b) be an employee of an arts organisation which has registered as a member of the nominating body (organisational member) of this nomination exercise Note 1, and has been directly involved in arts creation, direction or performance in the organisation for not less than one year Note 3 prior to the start date of this nomination exercise, i.e. 30 March 2010; or be a full-time employee of the arts organisation and has been responsible for co-ordination or promotion of arts events or stage management Note 4 in the organisation for not less than one year prior to the start date of this nomination exercise, i.e. 30 March 2010; or
 - (c) be an individual arts worker who has registered as a member of a nominating body of this nomination exercise Note 1.

II. Application Procedure:

(1) For those who are members/employees of arts organisations which have been registered as organisational members of the nominating bodies Note 1, they can apply to be registered as voters through the organisations. For those organisations registered as members of the nominating bodies in 2007 or in the years before, they must submit voter registration forms afresh on behalf of their members this year. The organisations concerned must send the completed registration forms to the Nomination Agent Note 5 by fax, by e-mail, by mail or by

Note 2 If a member joined an arts organisation, which has registered as a member of the nominating body (organisational member) of this nomination exercise, for less than one year but has, prior to joining this organisation, been a member of one or more arts organisation(s) which is(are) also member(s) of the nominating body of the same specified arts interest as this organisation, and his/her membership with all these organisations counted together is not less than one year, then the organisation may produce for consideration by the Nomination Agent documentary proof of his/her membership record with these other arts organisation(s).

Note 3 If an employee joined an arts organisation, which has registered as a member of a nominating body (organisational member) of this nomination exercise, for less than one year, but has, prior to joining this organisation, taken similar positions in other arts organisation(s) which is(are) also member(s) of the nominating body, and his/her service with all these organisations counted together is not less than one year; then the organisation may produce for consideration by the Nomination Agent documentary proof of his/her employment record with these other arts organisation(s).

Note 4 This does not include employees involved in general administration, finance, human resources and other technical support duties in the organisation.

Note 5 That is, PR Concepts Asia Limited.

- hand before the deadline, and ensure the legibility of all the information provided on the form(s). For postal applications, the deadline is determined by the postmark. Late submissions will not be accepted.
- (2) For those individual arts workers who have registered as members of the nominating bodies Note 1, they will automatically become voters and do not need to register.

III. Points to Note:

- (1) Organisational members of the nominating bodies (the organisations concerned) must ascertain that applicants in the voter registration form agree to be registered as voters through them. Each applicant should be registered through only <u>one</u> organisation.
- (2) The applicants should be registered under the same arts interest^{Note 6} of the organisation concerned. In cases of multi-discipline organisations where the organisations concerned have been specified as members of the nominating bodies of more than one arts interest, each of the applicants can be registered under <u>one</u> of the arts interests only.
- (3) If an applicant applies to be registered through more than one arts organisation, the Nomination Agent may contact the organisations concerned to clarify which arts organisation the applicant shall register with. The organisations concerned should inform the Nomination Agent of the applicant's decision within the specified period, or the applicant concerned will not be accepted as a voter.
- (4) Individual arts workers who have registered as individual members of the nominating bodies Note 1 will automatically become voters and do not need to register.
- (5) For organisational/corporate members of the organisations concerned (e.g. affiliated groups), only one representative of each organisational/corporate member is eligible to be registered as voter.
- (6) The organisations concerned should ensure that all information given for the registration is complete and correct, or the applicants may be disqualified for all purposes relating to this nomination exercise.
- (7) Information provided on the registration form (including the name(s), ID card number(s), correspondence address(es) and contact telephone number(s)) must be complete. Failing this, the registration process cannot be completed, and the applicants concerned cannot be registered as voters.

Guidelines for the Nomination of Candidates

I. Eligibility for being a Candidate or a Proposer:

- (1) The candidate shall:
 - (a) be aged 18 years or above; and
 - (b) be a voter of the arts interest for which he/she is standing for candidature; and
 - (c) not be disqualified from being nominated under section 3(6) of the Hong Kong Arts Development Council Ordinance (Cap 472); and
 - (d) be nominated by 5 proposers or 1% of the number of the registered voters from the same arts interest (whichever is the higher). (The actual number of proposers required for the respective arts interests will be announced upon confirmation of the electorate.)
- (2) A proposer shall be a voter of the respective arts interest for which the prospective candidate is seeking candidature. The proposer shall make only one nomination in the nomination exercise. Otherwise, his/her eligibility as a proposer will be invalidated.

II. Procedures of Nominating Candidates:

Nominations should be made during the nomination period on Candidate Application Forms. Proposers cannot revoke their nominations. Applicants seeking candidature should submit completed forms together with the required supporting documents to the Nomination Agent in person or by their authorised persons before the deadline. The applicants should ensure the legibility of all information submitted for the nomination. Late submissions will not be accepted.

III. Points to Note:

- (1) An applicant is encouraged to submit his/her application well before the deadline of the nomination period to allow time for rectification of errors, if any, in his/her application form.
- (2) An applicant should ensure that his/her proposers are eligible voters in his/her arts interest and have not nominated other prospective candidates.
- (3) An applicant is advised to obtain nominations from more than the required minimum so as to avoid the risk of having his/her nomination invalidated should any of the proposers be subsequently found to be unqualified as proposers.

- (4) An applicant should ensure that all information given for the nomination is complete and correct. Should there be any false information or information withheld, the nomination concerned will be invalidated.
- (5) An applicant is not allowed to withdraw his/her candidature application or subsequent candidature (if applicable) after the close of the nomination period.
- (6) Voters subscribing to a nomination should sign the relevant Candidate Application Form personally.
- (7) The Nomination Agent is the final authority to determine the eligibility of an applicant and a proposer.
