INTRODUCTION

On 31 March 2011, the Secretary for Security, under section 50(2) and section 49I of the Dangerous Drugs Ordinance (Cap. 134) ("the Ordinance"), made the Dangerous Drugs Ordinance (Amendment of Second Schedule) Order 2011 (**Annex A**) and the Dangerous Drugs Ordinance (Amendment of Fourth Schedule) Order 2011 (**Annex B**) respectively.

JUSTIFICATIONS

Second Schedule

- 2. Under section 22(1)(f) of the Ordinance, a sister in charge of a ward, theatre or other department in a prescribed hospital may possess and supply dangerous drugs so far as it is necessary for the practice or exercise of their profession, function or employment. A prescribed hospital is defined in section 2 to mean, inter alia, a hospital or institution specified in the Second Schedule.
- 3. A new nursing home as listed in **Annex C** has come into operation. In the course of treatment of elderly patients by the institution, the use of narcotics and benzodiazepines which are subject to the control of the Ordinance may be involved. It is essential to include this institution in the Second Schedule to meet its operation needs in accordance with section 22 of the Ordinance.

Fourth Schedule

- 4. Under section 49B of the Ordinance, the Central Registry of Drug Abuse (CRDA) collects, collates and analyses confidential information supplied by reporting agencies and publishes statistical information on drug abuse on an aggregate basis. It has proved to be a valuable tool to monitor changes in trends or characteristics of the local drug abuse situation. Confidentiality of records kept by reporting agencies and the CRDA is protected under Part VIIA of the Ordinance.
- 5. At present, there are 67 reporting agencies listed in the Fourth Schedule. To broaden the reporting base and ensure confidentiality of records, five additional agencies as listed in **Annex D**, have agreed to be included in the Fourth Schedule. The opportunity is also taken to update the names of two existing reporting agencies in the Fourth Schedule to reflect the changes as shown in **Annex E**.

THE ORDERS

Dangerous Drugs Ordinance (Amendment of the Second Schedule) Order 2011

7. The Order in **Annex A** adds the nursing home listed in **Annex C** to the Second Schedule to the Ordinance.

Dangerous Drugs Ordinance (Amendment of the Fourth Schedule) Order 2011

8. The Order in **Annex B** amends the Fourth Schedule to the Ordinance by adding five new agencies listed in **Annex D** and updating the names of two agencies to reflect the changes shown in **Annex E**.

IMPLICATIONS OF THE PROPOSAL

10. The amendment is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the current binding effect of the Ordinance. It has no economic, productivity, environmental or sustainability implications. The additional workload and financial implications arising are negligible which will be absorbed by relevant bureaux and departments.

PUBLIC CONSULTATION

11. We consulted the institutions concerned and obtained their consent to be included in this legislative amendment exercise.
