Re : Our Views on the "Re-organization of the Government Secretariat"

- 1. Restructuring of Commerce and Economic Development Bureau**
We support the proposal to restructure CEDB into two new bureaux, namely the TCB and CIB. We believe it will better recognize the importance of industrial development and technology in our economic development. With dedicated high level leadership, it will facilitate better and more effective decision making.
We are, in general, support the proposed Organization Structure shown in Appendix E & F.
- 2. Creation of the Culture Bureau**
At present, cultural affairs are scattered among a number of policy bureau. We support the proposal of bringing these all under the unified structure of the new CB. Currently the Create Hong Kong Branch is under CEDB, we believe with the creation of the Culture Bureau, the Create HK Branch is grouped under the new CB, which is most appropriate.
We are, in general, support the proposed Organization Structure shown in Appendix C.
- 3. The Deputy Financial Secretary**
We support the proposal of creating the post of DFS to further promote the economic development of Hong Kong and enhance our competitiveness. And to supervise the CIB and TCB.

As a conclusion, we support the Re-organization of the Government Secretariat proposal and will be happy to see it implemented with effect from July 1, 2012.
