#### 2012年2月24日的內務委員會特別會議

在 2012 年 2 月 24 日召開的內務委員會特別會議上,議員就西九填海區概念規劃比賽 (比賽)評審團成員梁振英先生涉及利益衝突的指稱,向當局索取進一步資料/文件。

#### 其他評審團成員的投票紀錄

因應議員的要求,我們現以不記名方式提供其他九名評審團成員的投票紀錄,讓議員可知悉全部十名評審團成員的投票模式。附件1列出了十位評審團成員在各投票回合(除了第四回合)的投票紀錄。立法會CB(2) 1198/11-12(01)號文件的附件10指出,評審團成員一共進行了七個評審回合,其中有六個回合涉及投票。第四回合為非投票回合,評審團只透過討論提名五個參賽作品以選出亞軍得獎者,而沒有進行投票。

#### 行政會議的會議記錄

我們向行政會議(行會)秘書處查詢後確定並無紀錄顯示在 2001至 2003 年期間提交行會的文件有提及是項比賽;直至 2003年年中,西九龍文娛藝術區發展計劃督導委員會向行會提交工作進度報告,才提及是項比賽,而梁先生亦在席上申報他於是項比賽中的參與。

#### 技術評估委員會的職權範圍

《比賽資料文件》第 9 段訂明「評審團會由一個共有 10 名成員的技術評估委員會協助工作。該委員會主席為規劃署署 長......委員會的主要職責,是就每份參賽作品在技術方面的評價向 評審團提供意見。技術評估委員會主席須出席評審團的會議,闡釋 技術評估委員會的意見,但不得參與決定得獎名單。」有關技術評 估委員會的職權範圍,只有上述的提述,而立法會 CB(2)1198/11-12(01)號文件第 21 至 27 段及附件 9 的《技術評估委員會報告》已 交代技術評估委員會如何進行評估及向評審團提出意見。

#### 有關披露資料的信件

當局曾就公開與梁振英先生涉及利益衝突的指稱有關的資料,致函梁先生、T. R. Hamzah & Yeang 和梁黃顧建築師(香港)事務所有限公司。現附上有關信件(附件2至9°)。我們已就公開他們給當局的回信,徵求他們的同意,並正等待他們的回覆。我們在處理公開這些信件的事宜時,會考慮保密和公眾利益的因素。

我們重申當局並不認為有需要就此事引用《立法會(權力及特權)條例》(第 382 章)。在議員研究梁先生以比賽評審團成員身份在是項比賽中的參與的事宜上,我們樂意與議員通力合作。

#### West Kowloon Reclamation Concept Plan Competition

I am writing to seek your kind assistance with respect to the captioned Competition held in Hong Kong in 2001/02, of which you were one of the jurors.

Recently, there have been media enquiries about your conflict of interest declaration and requests for disclosure of relevant information. We also note from media reports that you have suggested that additional information pertaining to the Competition be disclosed.

Taking into account our obligation to safeguard the confidentiality requirement and public interest consideration, we intend to disclose to the public further information. This will include the following documents as attached—

i) Letter dated 21 February 2002 from Mr Eric Johnson to you (Annex 1);

- ii) Declaration by Members of the Jury made by you on 25 February 2002 (Annex 2);
- iii) Process of selecting winning entries (Annex 3);
- iv) Voting record of Mr C Y Leung (Annex 4);
- v) Letter dated 11 March 2002 from you to Mr Eric Johnson (Annex 5); and
- vi) Letter dated 23 March 2002 from Mr Eric Johnson to you (Annex 6).

We hope to be able to obtain your consent regarding the above proposed disclosure. We will take into account your response in determining the way forward on the matter.

You may wish to note that we are approaching about the proposed disclosure to the public of pregistration form and updated list of project team members, which were submitted to the Organiser of the Competition in 2001.

#### **Process of Selecting Winning Entries**

1. All entries were shown to the Jury on an anonymous basis and each was represented by a serial number. The Jury agreed upon an elimination process for selecting the first prize winner, the second prize winner and three honourable mentions by casting votes.

#### Selection of first prize winner on 26 February 2002

- 2. The first prize winner was selected in the following manner –
- (a) Each member of the Jury was invited to vote for five entries meriting further consideration as the winning entry, on a non-binding basis and without ranking them (Voting Round 1). 20 entries were selected in this way. After reviewing the votes cast, the Jury decided that the nine entries with the most votes should be discussed further. The entry, which was subsequently found to be associated with Mr C Y Leung (hereafter referred to as "the entry concerned"), was among these nine entries.
- (b) The nine entries with the most votes were each brought in front of the Jury in serial number order. Individual Jury members discussed specific aspects which they felt merited the Jury's consideration.
- (c) Members then each cast one vote on a non-binding basis to select a winner from the nine entries discussed (Voting Round 2). After reviewing the votes cast, the Jury decided to discuss further the three entries receiving the most votes. The entry concerned was among these three entries

(d) After thorough discussion of all the three entries concerned, each Jury member cast a binding vote to select the first prize winner (Voting Round 3). The selected entry was from a team led by Foster and Partners.

## Selection of second prize winner on 26 February 2002

- 3. The second prize winner was selected in the following manner –
- (a) The eight entries remaining from the original group of nine considered for selection as the first prize winner were again displayed in turn. After discussion, five entries (including the entry concerned) were nominated for further consideration.
- (b) Members then each cast a non-binding vote for one entry from the five selected entries (Voting Round 4). After reviewing the votes cast, the Jury decided to discuss the three entries receiving the most votes. The entry concerned was among these three entries.
- (c) Each of these three entries was placed before the Jury in turn for further detailed discussion, after which each member cast a binding vote to select the second prize winner (Voting Round 5). The selected entry was from a team led by Mr Philip Y K Liao.

## Selection of honourable mentions on 27 February 2002

- 4. The three entries awarded honourable mentions (of equal standing) were selected in the following manner –
- (a) The Jury decided to award honourable mention prizes to entries presenting interesting alternative ways of tackling the competition site.
- (b) The seven entries remaining from the group of eight considered for selection as the second prize winner were again displayed in turn. Members were invited to nominate any entry from among these seven, or any other entry, that they felt merited further consideration. After discussion, six entries (including the entry concerned) were nominated.

- (c) Members discussed all of the entries nominated and cast binding votes for the three entries to be awarded honourable mentions (Voting Round 6).
- (d) The entry concerned was one of the three entries with the highest votes to be awarded honourable mentions.

### Disqualification of the entry concerned on 28 February 2002

On 28 February 2002 before the announcement of the competition results, the Competition Team informed Mr Leung of the finding that a project team member of an entrant on the preliminary list of winning entries appeared to be associated with him. Mr Leung reported the matter to the Jury that morning, and the Jury decided to disqualify the entry concerned. Except for the disqualified entry, the three entries with the most votes were selected as the honourable mentions.

#### West Kowloon Reclamation Concept Plan Competition

Thank you for your letter dated 15 February 2012.

As reiterated by the Government on various occasions, we have to take into account considerations of confidentiality as well as public interest when addressing the issue of disclosure of information on the captioned subject. We will consider the requests in your letter dated 15 February 2012 for disclosing additional information and/or documents on the basis of the aforementioned considerations.

In this connection, we would be grateful for your express confirmation that you have no objection to the proposed disclosure of the following documents, irrespective of the requests in your letter dated 15 February 2012 for disclosing additional information and/or documents: -

i) Letter dated 21 February 2002 from Mr Eric Johnson to you (Annex 1);

- ii) Declaration by Members of the Jury made by you on 25 February 2002 (Annex 2);
- iii) Letter dated 11 March 2002 from you to Mr Eric Johnson (Annex 3); and
- iv) Letter dated 23 March 2002 from Mr Eric Johnson to you (Annex 4).

Regarding the document on the process of selecting winning entries (Annex 5), which is based on the Jury Report, and your voting record (Annex 6), we have made refinements to present the voting process in further detail and in a manner which is consistent with considerations of confidentiality (both in respect of the jurors and of other entrants) and public interest. We would also be grateful for your express confirmation that you have no objection to the proposed disclosure of these two annexes, irrespective of the requests in your letter dated 15 February 2012 for disclosing additional information and/or documents.

Your responses to the above will be taken into account by the Government on the subject of disclosure.

On the question of the discovery of the company associated with you being among the project team members of an entrant on the preliminary list of winning entries, as indicated in Mr Eric Johnson's letter dated 21 February 2002, the completed declarations were scheduled to be reviewed by the organizer and Lord Rothschild on 24 February 2002 before the adjudication process started on 25 February 2002. The Competition Team received your declaration as per Annex 2 on 25 February 2002. As mentioned in the press release on the captioned subject on 8 February 2012, the discovery was made by the Competition Team after the voting process had been completed. The Competition Team informed you of the finding in the morning of 28 February 2002. You reported the matter to the Jury, which decided to disqualify the entry concerned.

As stated in the Government's response on 14 February 2012 to enquiries about the issue of press release on 8 February, we will not comment on media reports based on anonymous sources.

#### **Process of Selecting Winning Entries**

1. All entries were shown to the Jury on an anonymous basis and each was represented by a serial number. The Jury agreed upon an elimination process for selecting the first prize winner, the second prize winner and three honourable mentions by casting votes. There were a total of 10 jurors.

#### Selection of first prize winner on 26 February 2002

- 2. The first prize winner was selected in the following manner –
- (a) Each member of the Jury was invited to vote for five entries meriting further consideration as the winning entry, on a non-binding basis and without ranking them (Round 1 Voting). 20 entries were selected in this way. After reviewing the votes cast, the Jury decided that the nine entries with the most votes should be discussed further. The entry, which was subsequently found to be associated with Mr C Y Leung (hereafter referred to as "the Entry Concerned"), was among these nine entries.
- (b) The aforesaid nine entries with the most votes were each brought in front of the Jury in the order of their serial numbers. Individual Jury members discussed specific aspects which they felt merited the Jury's consideration.
- (c) Members then each cast one vote on a non-binding basis to select a winner from the nine entries discussed (Round 2 Voting). After reviewing the votes cast, the Jury decided to discuss further the three entries receiving the most votes. The Entry Concerned was among these three entries.

(d) After thorough discussion of all the three entries concerned, each Jury member cast a binding vote to select the first prize winner (Round 3 - Voting). The selected entry was from a team led by Foster and Partners.

## Selection of second prize winner on 26 February 2002

- 3. The second prize winner was selected in the following manner –
- (a) The eight entries remaining from the original group of nine considered for selection as the first prize winner were again displayed in turn. After discussion, five entries (including the Entry Concerned) were nominated for further consideration (Round 4 This round involved discussion only. No voting took place).
- (b) Members then each cast a non-binding vote for one entry from the five selected entries (Round 5 Voting). After reviewing the votes cast, the Jury decided to discuss the three entries receiving the most votes. The Entry Concerned was among these three entries.
- (c) Each of these three entries was placed before the Jury in turn for further detailed discussion, after which each member cast a binding vote to select the second prize winner (Round 6 Voting). The selected entry was from a team led by Mr Philip Y K Liao.

### Selection of honourable mentions on 27 February 2002

- 4. The three entries awarded honourable mentions (of equal standing) were selected in the following manner –
- (a) The Jury decided to award honourable mention prizes to entries presenting interesting alternative ways of tackling the competition site.
- (b) The seven entries remaining from the group of eight considered for selection as the second prize winner were again displayed in turn. Members of the Jury were invited to nominate any one entry from among these seven, or any other entry (even though not among these seven), that in their view merited further consideration. After discussion (no votes were taken), six entries (including

the Entry Concerned) were nominated.

- (c) Members discussed all of the entries nominated and cast binding votes for the three entries to be awarded honourable mentions (Round 7 Voting).
- (d) The Entry Concerned was one of the three entries with the highest votes to be awarded honourable mentions.

### Disqualification of the Entry Concerned on 28 February 2002

5. On 28 February 2002 before the announcement of the competition results, the Competition Team informed Mr Leung of the finding that a project team member of an entrant on the preliminary list of winning entries, namely the Entry Concerned, appeared to be associated with him. Mr Leung reported the matter to the Jury that morning, and the Jury decided to disqualify the Entry Concerned. Disregarding the disqualified entry, the three entries receiving the most votes in Round 7 were selected as the honourable mentions.

#### Rounds of Voting

#### Mr C Y Leung's vote

26 February 2002

Round 1 - Voting (Selection of 20 entries for further consideration)

Mr Leung was absent from this round of voting. He selected 18 entries during the viewing session on 25 February 2002. At Round 1, 7 of these 18 entries were also voted for by other jurors. Although Mr Leung was absent, it was agreed by other jurors that his selection should be added to the tally of votes (i.e. adding one more vote to the total number of votes received by these 7 entries).

Out of Mr Leung's 18 selected entries, 6 (including the Entry Concerned\*) were among the top 9 entries with the most votes. It was agreed that these 9 entries should be discussed further. The Entry Concerned received a total of 4 votes in this round of voting.

Round 2 - Voting (Non-binding vote to select the first prize winner from the 9 entries with the most votes in Round 1) Mr Leung voted for the Entry Concerned, which received 3 out of 10 votes in this round of voting.

<sup>\*</sup> The entry, which was subsequently found to be associated with Mr C Y Leung, is referred to as "the Entry Concerned".

Round 3 - Voting (Binding vote to select the first prize winner from the 3 entries with the most votes in Round 2) Mr Leung voted for the Entry Concerned, which received 2 out of 10 votes in this round of voting.

#### Round 4

(Discussion to nominate 5 entries from the 8 entries remaining from the original group of 9 considered for selection as the first prize winner. No voting took place)

The Entry Concerned was among the 5 nominated entries.

Round 5 - Voting (Non-binding vote to select the second prize winner from the 5 entries nominated in Round 4) Mr Leung voted for the Entry Concerned, which received 3 out of 10 votes in this round of voting.

Round 6 - Voting (Binding vote to select the second prize winner from the 3 entries with the most votes in Round 5) Mr Leung did not vote for the Entry Concerned, which received 1 out of 10 votes in this round of voting.

#### 27 February 2002

Round 7 - Voting (Binding votes for three entries to select the three honourable mentions) Mr Leung voted for three entries, including the Entry Concerned, which received 9 out of 30 votes in this round of voting. Given that the 30 votes consisted of each of the 10 jurors voting for 3 entries, this meant that 9 out of the 10 jurors cast a vote for the Entry Concerned.

## West Kowloon Reclamation Concept Plan Competition

Thank you for your letter dated 20 February 2012.

The statements made by the Government on 8 February 2012 were in response to enquiries from the media on the captioned matter. As reiterated by the Government on various occasions, including our letter to you dated 16 February 2012, we have to take into account the considerations of confidentiality as well as the public interest when addressing the issue of disclosure of information in relation to the West Kowloon Reclamation Concept Plan Competition. We would like to emphasize that the Government has acted impartially in respect of the matter of disclosure.

Four of the six annexes to our previous letters were relevant primary documents proposed for disclosure to the public. We note that you have expressed concern about the veracity and accuracy of the information contained in our previous letters, in particular Annexes 5 and 6 enclosed therewith for your consideration and giving of consent to disclosure. The said Annexes were prepared based on the contemporaneous records, and the information contained in the Annexes is true and accurate. The matters you identified in paragraphs (a) to (c) of your letter of 20 February 2012 were not differences in substance, but represent different and more refined ways of presenting and explaining what actually happened at the time with considerations of confidentiality and the public interest in mind, so that the readers will be able to view the voting record in context.

Specifically, our responses to paragraphs (a) to (c) are set out below -

- (a) As Round 4 only involved discussion to nominate entries for selection of the second prize winner and no actual voting took place, we did not present this "nomination round" in Annex 4 to our letter dated 14 February 2012. However, as explained in our letter dated 16 February 2012, we have made refinements to present the voting process in further detail, hence the description in Annex 6 to our subsequent letter was amended to include information about the "nomination round", making it 7 rounds of voting and discussions (as opposed to 6 rounds of voting).
- (b) There is no contradiction between the descriptions on the "Binding vote to select the second prize winner" in the annexes to our letters dated 14 and 16 February 2012. Annex 4 to our letter dated 16 February 2012 seeks to highlight the Entry Concerned, which is the subject of public interest.
- (c) As stated in Annex 5 on the "Process of Selecting Winning Entries" to our letter of 16 February 2012, for the selection of the three entries awarded honourable mentions, Members of the Jury were invited to nominate any one entry from among the seven entries remaining from the group of eight considered for selection as the second prize winner, or any other entry (even though not among these seven), that in their view merited further consideration. After discussion, 6 entries (including the Entry Concerned) were nominated. Each member were to vote for three entries among the 6 nominated entries. There was no suggestion that after the second prize winner was selected, there were only four entries left for the selection of three honourable mentions.

As you may be aware, the House Committee of the Legislative Council ("LegCo") has scheduled a meeting on 24 February 2012 to discuss "Issues relating to allegations of conflict of interests in the West Kowloon Reclamation Concept Plan Competition", and has further requested the Government to provide information relevant to the allegations of conflict of interests involving yourself and one of the entrants therein. The Government has fully considered the matter and decided to disclose to the House Committee information relevant to those allegations.

We enclose herewith the LegCo House Committee Paper and its annexes. Some of the annexes are identical to those sent to you in our earlier letters but some have been revised so as to explain the voting process in further detail and in a manner which is consistent with considerations of confidentiality (both in respect of the jurors and of other entrants) and the public interest. In this connection, we have also taken into account your views and suggestions as contained in your said letter as part of the considerations of confidentiality as well as the public interest when addressing the scope of the disclosure to the House Committee.
