Action

**I. Election of Chairman**

Ir Dr Raymond HO, the member who had the highest precedence among those present in the meeting, presided at the election of Chairman of the Bills Committee.

2. Mr IP Kwok-him nominated Ir Dr Raymond HO, and the nomination was seconded by Mr Alan LEONG and Mr WONG Sing-chi. Ir Dr Raymond HO accepted the nomination.

3. There being no other nomination, Ir Dr Raymond HO was elected Chairman of the Bills Committee, and took over the chair of the meeting.

4. The Chairman proposed and members accepted the late application from Ms Cyd HO to become a member of the Bills Committee.

5. The Administration briefed the Bills Committee on the Bill. Members deliberated (Index of proceedings attached at **Appendix**).

Admin 6. The Administration was requested to –

- (a) advise whether consideration could be given to extending the validity period of provisional registration so that those senior workers who did not want to attend trade tests would not be forced out of work when the registration expired;
- (b) set out details of the proposals under which minor works of value below certain amount would be exempted so that workers who

were not registered for the relevant trades would be allowed to undertake those construction works;

- (c) provide details of the design of the all-in-one registration card and relevant logistical arrangements;
- (d) conduct a briefing for staff members of Construction Workers Registration Authority ("CWRA") and listen to their concerns directly; and forthwith report on the outcome of consultation with those staff members; and
- (e) provide copies of the minutes of the relevant meetings of Construction Industry Council and CWRA which showed that CWRA staff would be offered a further employment contract of at least two years upon the expiry of the existing contracts valid on the day of amalgamation.

### **III. Any other business**

7. Members agreed that the Bills Committee should hold a meeting on Saturday, 5 May 2012 to receive deputations' views on the Bill. The Bills Committee noted the Administration's wish that meetings be held more frequently.

Given the strenuous nature of construction works most of which had to be performed outdoor, effort should be given to enhance durability of the card; and  (c) the Administration was required to note that she had received complaints from CWRA staff who had written to CIC management to express their concerns about transitional staff arrangements at the amalgamation of CIC and CWRA, and had received no reply so far. 		<p>The Administration's response that –</p> <ul style="list-style-type: none"> <li>(a) the purpose of bringing in provisional registration was to allow construction workers to continue to work pending completion of prescribed training and assessment/trade tests;</li> <li>(b) the existing legislation did not provide for the extension of the provisional registration. As such, the Administration intended to extend under the Bill the validity period of registration of skilled workers (provisional) and semi-skilled workers (provisional) under special circumstances (such as illnesses and injuries) which were beyond workers' control;</li> <li>(c) the Administration had yet to implement Phase Two Prohibition under the Construction Work Registration Ordinance ("CWRO"), which would prohibit workers from undertaking works for which they were not registered. In consultation with the trade organizations, the Administration was in the course of identifying ways and measures to improve the provisional registration system;</li> <li>(d) in order to reduce the number of cards a worker had to carry to work, the Bill sought to amend CWRO such that in future a construction worker registration card would be able to store and display information of various construction-related cards/certificates issued by other authorities. Meanwhile, the Administration would also think of ways to enhance the durability of the card;</li> <li>(e) provisions would be included in the Bill to ensure the continuance of existing employments following amalgamation until their natural expiry, and there would not be unilateral alteration of the employment contracts by CIC;</li> <li>(f) the Administration had met regularly with CIC and CWRA management on transitional arrangements for staff. CIC and CWRA management had agreed that CWRA staff would be offered a further employment contract of not less than two years upon expiry of existing contract valid on the day of amalgamation.</li> </ul>

		<p>effect, the Construction Industry Legislation (Miscellaneous Amendments) Bill would cease to exist;</p> <p>(b) the Administration had met with relevant labour unions on how to move on to stage 2 legislative amendments which would deal mainly with the implementation of the Phase Two Prohibition under CWRO. The Administration was aware of the needs of senior workers, and was considering the possibility of replacing trade tests with oral assessment;</p> <p>(c) construction contractors were required to provide either static or mobile card-readers at works sites to verify the registration status of construction workers;</p> <p>(d) to allow greater flexibility for carrying out small-scale construction works, the Administration was considering exempting minor works of lesser scale and value from the Phase Two Prohibition forbidding workers from undertaking works which they had not registered for;</p> <p>(e) with the help of the trade unions, the Administration would encourage construction workers through different means to become multi-skilled; and</p> <p>(f) in a way similar to the driving licence, the Administration would explore the possibility of displaying the types of works for which the card-holder was registered on the construction worker registration card issued under CWRO</p>
