

**Administration's Response to
Follow-up items arising from 3rd meeting on 14 May 2012**

I. Transitional arrangements for staff

Members were concerned about the transitional arrangements for staff of the Construction Workers Registration Authority (CWRA) and those contract staff in the Construction Industry Council (CIC) who are providing workers registration services on behalf of CWRA. Members requested the Administration to –

- (1) provide a table showing respective numbers of the affected staff together with relevant information; and
- (2) liaise with the CIC management with a view to issuing a letter assuring those contract staff in existing establishment that the amalgamation of CIC and CWRA would cause no change to their existing terms of employment.

Administration's Response

2. We provide in the table below the type and number of the concerned staff, their terms of employment and the related transitional arrangements for Members' information –

3. We have already liaised with the CIC management to request the latter to meet those contract staff in existing establishment who are providing workers registration services as soon as possible with a view to giving the staff a written assurance on the arrangements upon amalgamation.

II Extension of the validity period of provisional registration

4. Members agreed that workers should produce relevant documents when applying for extension of the validity period of their provisional registrations and they should not be required to pay any charges. Members requested the Administration to liaise with CIC with a view to consulting industry stakeholders in drawing up the

administrative guidelines for these applications.

Administration's Response

5. We have already liaised with CIC to impress on the need to consult the industry stakeholders when formulating the relevant administrative guidelines in future.
