Action

I. Meeting with the Administration

(CMAB C1/30/5/4, LC Paper Nos. CB(2)1250/11-12(02) to (03), CB(2)1388/11-12(01) to (03), CB(3)403/11-12 and LS 28/11-12)

The Bills Committee deliberated (index of proceedings attached at Annex).

Admin

2. The Administration was requested to consider the following views and concerns raised by members -

- (a) in respect of the requirement for candidates to obtain permission for the display or affixing of printed election advertisements ("EAs") in private premises/shops, whether there was room for improvement to facilitate the smooth conduct of electioneering activities of candidates (e.g. simplification of forms or procedures);
- (b) provision of technical support and advice to candidates who encountered problems in uploading the EA particulars/ submissions (e.g. IT support hotline services during elections), and the need for the Registration and Electoral Office ("REO") to provide timely and effective response to candidates;
- (c) in respect of the content layout standard to be drawn up by REO for candidates to follow in designing and setting up their platforms, whether creativity, flexibility and innovation in the design and development of candidates' platforms would be allowed;
- (d) having regard to the various problems relating to the existing arrangements for counting Geographical Constituency ("GC") and Functional Constituency ("FC") ballot papers, in particular, the delay in the compilation of voter turnout statistics due to ballot discrepancies and the consequential delay in the counting of ballot papers as well as the announcement of election results, the measures, if any, to be taken to speed up the counting process without compromising the principle of protecting the secrecy of votes;

Action

- (e) measures to speed up the sorting and separation of ballot papers cast at dedicated polling stations and the delivery of these ballot papers to the relevant counting stations for counting; and
- (f) in anticipation of a large number of GC ballot papers misplacing in FC ballot boxes, or vice versa, due to the large number of ballot papers involved in GCs and District Council (second) FC, whether it was legally in order to proceed with the counting of GC ballot papers at the counting stations when the number of GC ballot papers cast in the GC ballot boxes did not tally with the number of ballot papers issued.

3. The Chairman said that the Bills Committee would commence clause-by-clause examination of the Bill at its next meeting.

II. Any other business

4. The Chairman reminded members that the next meeting of the Bills Committee would be held on Friday, 23 March 2012, at 3:00 pm or immediately after the House Committee meeting, whichever was later.

(Post-meeting note: The meeting was subsequently re-scheduled for 26 March 2012 at 10:45 am. With the concurrence of the Chairman, the re-scheduled meeting was cancelled as the number of members who had indicated their availability for the meeting was less than the required quorum.)

001544 - 002201	Ms Cyd HO Chairman Admin	<p>Ms HO's enquiry about the inclusion of photographs provided by a candidate's supporters out of their own volition in EAs published by the candidate.</p> <p>The Administration responded that the candidate was required to obtain consent of support if the photographs included in an EA had the effect of implying, or causing electors to believe, that the candidate had the support of the persons or organizations in the photographs.</p> <p>Ms HO's concern about the existing rules governing the display of printed EAs, e.g. posters, in shops, and whether the procedural requirements for display of printed EAs could be streamlined.</p> <p>The Administration advised that to avoid any possible dispute in future, candidates who wished to display their printed EAs, including posters, in private premises such as shops must obtain the prior consent or authorization of the shop owners/occupiers.</p> <p>Members' enquiry on whether a sample form was in place for use by candidates to notify the Registration and Electoral Office ("REO") of their obtaining of shop owners' or occupiers' consent for display of election posters.</p>

		<p>The Administration advised that every candidate was required to deposit a copy of each of the completed consent forms with the relevant Returning Officer ("RO") before the display, distribution or otherwise use of any EAs. While REO had provided a standard form of "Consent of Support", there was no prescribed form of permission for display of EAs.</p> <p>Guiding principles for shop owners'/occupiers' consideration of whether individual candidates' requests for display/posting of printed EAs in their premises should be acceded to, which included, among others, fairness and equality for conducting election-related activities.</p>

In this regard, candidates would enjoy a large degree of freedom in using their creativity to develop and design candidates' platforms. The Administration further advised that if a candidate chose to post EAs onto his election website, the candidate was required to provide the website address to the relevant RO who would then publicize such information.</p>

Owing to security reasons, the poll at these DPSs was conducted from 9 am to 4 pm. Three DPSs were also set up at police stations for registered electors who were detained by the Police on the polling day and expressed their wish to vote to do so.
