Special Question and Answer Session

At the House Committee's meeting today, in response to the request of Hon Paul TSE, Members discussed how the Legislative Council could follow up on the wide public concern arising from the suspected acceptance of advantages from Sun Hung Kai Properties Limited by Mr Rafael HUI, former Chief Secretary for Administration. The specific issues raised by Hon Paul TSE are set out in his letter to me dated 2 April 2012, which is attached for your information.

As the information related to questions raised on this subject can only be provided by you, Members consider that it would be necessary to request your attendance at a Special Chief Executive's Question and Answer Session ("Q&A Session") to be held at your earliest convenience. We hope that this Special Q&A Session would last for one and a half hours to allow sufficient time for Members to raise questions on the matter. Should this arrangement be found not feasible, we hope that the next Q&A Session could be held as soon as practicable so that Members could ask questions on this subject in addition to others.

有關特首曾降權先生與前政務司司長許任仁先生涉嫌收受新地利益案件(下稱"許案")

日前廉政公署正式拘捕許索涉索人士,舉世瞩目,更嚴重打擊香港社會監 體廉潔聲譽及形象。

鑑於曾蔭權先生與許任仁先生公私關係密切,兩人當時身任特區政府兩位最高權力官員,涉嫌先後以類似形式收受富商利益,巧合之餘,更令市民懷疑曾特首早前就深圳「曾大屋」公開解釋是否事實之全部。此外,曾先生身為許任仁先生好友及廉政專員項頭上司,理應知道廉署調查許索詳情。市民認為,曾先生有需要交代以下問題,讓立法會有更多依據考慮應否啓動彈劾行政長官機制,並檢討現行高薪養廉政策及加强防止高官收受利益機制。

- 曾特首何時最早知悉廉署調查許任仁先生?廉署查詢許案期間,曾先生有 否一直從廉署或廉政事員了解進度?
- 2. 曾特首邀請許任仁先生在 05 年重返政府出任政務司司長前,曾否進行任何既定審查程序?有否考慮許與新地關係密切,有可能加深「官商勾結」 印象?

- 4. 曾特首曾否就許索調查進度及跟進與許仕仁先生有任何商討?如有, 詳憬 為何?
- 5. 曾特首曾否就案件的檢控與否及檢控時序給予廉署或廉政事員任何意見?
- 6. 曾特首在許案爆發(2012 年 3 月 29 日) 前離港,事先是否知道廉署即將就 許案採取拘捕行動?如知道,為何仍選擇離港?如不知道,事後為何不馬 上回港應付許索可能引發的管治及信心危機?

就上述及相關疑問,希望關下能源時容排委員作討論及擬定最恰當跟進方案。
