**Report No. 21/11-12 of the House Committee on Consideration of
Subsidiary Legislation and Other Instruments**

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire on 6 June 2012.

3. The House Committee formed a subcommittee to study items (2) and (3) at its meeting on 11 May 2012.
