1. Manpower arrangements for the establishment of the Hong Kong Economic, Trade and Cultural Office in Taiwan

The Administration will seek members' views on its manpower plan and staffing proposal for the establishment of the Hong Kong Economic, Trade and Cultural Office in Taiwan.

2. Development of the exhibition industry in Hong Kong

At the Panel meeting on 21 December 2010, the Panel discussed the development of the exhibition industry in Hong Kong, in particular the promotion of the Meetings, Incentive travels, Conventions and Exhibitions (MICE) industry, measures to encourage the utilization of the existing convention and exhibition facilities, as well as the Hong Kong Trade Development Council's assistance for local small and medium enterprises and new exhibitors. Members urged the Administration to provide a more level playing field for AsiaWorld-Expo to compete with the Hong Kong Convention and Exhibition Centre on an equal footing, and help sort out their differences which posed barriers to co-operation. The Administration will update the Panel on the latest development of the exhibition industry in Hong Kong. Stakeholders will be invited to present their views on the issue.

3. Progress report of the Hong Kong Council for Testing and Certification

The Administration will update members on the work progress of the Hong Kong Council for Testing and Certification (HKCTC) in implementing its development plan for the industry and seek members' support to extend a supernumerary Administrative Officer Staff Grade C post created to support the work of HKCTC. The post will lapse on 15 March 2012.

6. Review of the governance of the Hong Kong Export Credit Insurance Corporation

The Public Accounts Committee (PAC) Report No. 56 was tabled in the Council on 6 July 2011. One of the chapters in the Report is on the Hong Kong Export Credit Insurance Corporation (ECIC). As the ECIC was established in 1966, PAC is concerned that the governance structure of ECIC as prescribed by the ECIC Ordinance may not be in line with modern-day practices and requirements. Noting that the Commerce and Economic Development Bureau does not micro-manage the daily operations of the ECIC, PAC considers it all the more important for the Advisory Board to play the role of a governing board to monitor the work and performance of the ECIC as well as to oversee its governance. In this connection, the Secretary for Commerce and Economic Development undertook to conduct a review of the governance of the ECIC and report the outcome to the Panel before the end of 2011.
