# Information provided by the University of Hong Kong on Safeguarding Academic Freedom

### (Translation)

Academic freedom is a core value of The University of Hong Kong (HKU) and is in its lifeline and tradition. All teachers and students of HKU own the right to academic freedom.

As early as in 2003, HKU stipulated a set of clear policies to safeguard academic freedom, provide a clear definition of "academic freedom" and set out specific principles for the protection of academic freedom. These policies ensure that teachers and students enjoy the right to pursue academic truth and engage in rational debates, criticisms and discussions, while understand their corresponding responsibilities. On the other hand, the University also has in place a well-established mechanism to deal with complaints from staff and students, including complaints about interference with academic freedom. Such a mechanism could ensure that all complaints would receive a fair and equitable treatment and investigation. It would also help protect the complainant by ensuring that they would not be subject to retaliation by lodging a complaint.

In addition, the HKU Council endorsed a policy on whistle-blowing last month to further encourage staff, students and other persons to lodge complaints in relation to the University's mishandling of affairs or inappropriate behavior or conduct on the part of its staff.

On the whole, HKU firmly believe that academic freedom is closely related to the protection of the University's freedom. It protects the autonomy of students on their studies, course selection and academic activities. It also protects the freedom of teachers on teaching, research and publications. If there is no academic freedom, universities would



not be able to achieve excellence, let alone making significant accomplishments and contributions. Therefore, HKU would make every effort to uphold academic freedom.

## Information provided by the Hong Kong Baptist University on Safeguarding Academic Freedom

#### (Translation)

The Hong Kong Baptist University (HKBU) is determined to safeguard academic freedom, freedom of speech and institutional autonomy. It also holds dear core values such as the rule of law and personal privacy. HKBU would continue to stand firm behind these core values.

Building on the premise of academic freedom, HKBU advocates the governing of the university by professors. The Senate, as the highest academic decision-making body, comprises academic staff and student representatives. All important academic decisions must be discussed and endorsed by the Senate, which is consistent with practices in renowned universities around the World.

In respect of teaching, academic staff in HKBU is free to decide on their own teaching methods and materials in accordance with broad academic policies endorsed by the Senate. In the course of conducting academic researches, academic staff in HKBU can determine on their own the research topics, research methods, working partners, publication channels and publication time, without being subject to any review or intervention. Staff and students are free to participate in a variety of academic activities.

The assessment of academic staff is based on the criteria of academic, research and service quality. Factors that are not related to academic work will not be considered.

The University also respects the freedom of speech - academic staff and students are free to express their views in within and outside the campus of HKBU. The "Democracy Wall" which allows students and staff to express their views is administered by the Students' Union which is operated independently from the University.
