## Supplementary Information on E-Textbook Market Development Scheme

Purpose and Breakdown of the proposed \$50 million for the E-Textbook Market Development Scheme (EMADS)

E-textbooks could be a desirable alternative to printed textbooks. One of the main aims of the EMADS is to facilitate and encourage the participation of potential and aspiring e-textbook developers to develop a diverse range of e-textbooks according to the requirements of our curricula. The Scheme will be open to all organisations, enterprises, academic institutes or societies as registered under the laws of the Hong Kong Special Administrative Region. To encourage the aspiring developers, especially those of a non-profit making nature who are likely to be less-endowed financially, to join the Scheme and thus expand the source of supply of e-textbooks, we propose to provide a seeding grant to successful non-profit making Applicants under the EMADS.

- 2. According to a consultancy study on Hong Kong's textbook market, a rough estimation of the average development cost of an e-textbook covering one subject set for one Key Stage of learning is around \$8 million. It is thus recommended that the successful non-profit making Applicants be provided with a seeding grant of not more than \$4 million or 50% of the development cost of an e-textbook subject set, whichever is the less. The funding caps could not only ensure a commitment from the Applicant, it could also avoid exposing the Government to a financial risk greater than that borne by the Applicant.
- 3. Based on our assessment of the relevant expertise for e-textbook development available in the non-commercial sector, we expect that about 12 to 14 applications from interested non-profit making organisations will qualify for the seeding grant. It is therefore proposed that a new non-recurrent commitment of \$50 million be created to provide seeding grants under the EMADS.
