## **Explanatory Note**

This Regulation adds 12 substances to Division A of Part I of the Poisons List (*Poisons List*) set out in the Schedule to the Poisons List Regulations (Cap. 138 sub. leg. B) so that, among other applicable requirements, poisons containing those substances can only be sold on registered premises of an authorized seller of poisons by a registered pharmacist or in the pharmacist's presence and under the pharmacist's supervision.

2. This Regulation also repeals a redundant full stop in the English text of the item relating to "Phenois" in Division A of Part II of the Poisons List.
