Background 背景

- Introduced since August 2003 2003年8月起推行
- Extended to cover reckless conducts & breaches of the tenancy agreement

範圍已擴大至涵蓋魯莽行為和違反租約條款

- Cover 28 misdeeds, categorised by severity of impact on environmental hygiene or estate management 涵蓋28種不當行為,按不當行為對環境衛生或屋邨管理所產生不良影響的嚴重程度分類
- Tenancy terminated upon accumulation of 16 points within 2 years

租户在2年內被扣滿16分,會被終止租約



Overall Enforcement Results 整體成效

- Results of 2012 Public Housing Recurrent Survey 2012年公營房屋住戶綜合統計調查結果
 - ➤ awareness of Marking Scheme 知悉扣分制 : 96%
 - ➤ reasonable penalty 罰則合理 : 64%
 - ➤ satisfaction on cleanliness and hygiene conditions 清潔衞生狀況滿意程度 : 73%
- 20 100 point-allotment cases 扣分個案共20 100宗
 - ➤ 10 points or above : 1 170 households
 - 10 分或以上 : 1 170户
 - ➤ 16 points or above : 57 households
 - 16 分或以上 : 57戶
- Most Frequently Committed Misdeeds 最常見不當行為



Throwing Objects from Height 高空擲物 (cont'd 續)

- Proactive measures adopted since 2009 自2009年採取的積極措施
 - ➤ Intensified publicity 加強宣傳



- ▶ Deploy 'Mobile Digital Closed Circuit Television' sets and Special Operation Teams (SOTs) to detect suspected offenders 調配「流動數碼化監察系統」及特別任務隊偵察可疑違例者
- Intensified patrols by estate staff under overall monitoring of a Headquarters (HQ) Task Force

- Points allotted in 2012 在2012年被扣分的住戶
 - ▶ 7 points 200 households (80 households in 2009)

 - ➤ 15 points 10 households (10 households in 2009) 15分 – 10户 (2009年約有10户)





Review Items 檢討項目 (4)

Control of Dog-keeping 管制養狗

● Dog keeping is prohibited except 除以下情況,住戶不可飼養狗隻



- ▶ Dogs permitted under 'Temporary Permission Rule' (TPR) 按「可暫准原則」批准飼養的狗隻
- ➤ Service dogs for visually impaired tenants 視障人士所養的服務犬
- Dogs kept on special grounds for mental support 因租戶極需作精神支援特別批准飼養的狗隻
- 5 points allotted without warning and removal of dogs within
 14 days

會在不給予警告下被扣5分,並須在十四天內送走狗隻。



Review Items 檢討項目 (5)

Control of Dog-keeping 管制養狗 (con'td 續)

- Enhanced Measures 優化管制措施
 - ▶ Stringent control on dog licence renewal under the TPR 嚴厲規管租戶按「可暫准原則」續領狗牌
 - ▶ Intensified patrol and enforcement actions by estate staff at estate level and SOTs at Regional HQ level 在屋邨和區域層面加強屋邨人員和特別任務隊的巡邏及執法行動
 - ➤ Enhanced publicity 加強宣傳
 - ➤ Data matching on dog owners' licence information transferred by Agriculture, Fisheries and Conservation Department

Control of Dog-keeping 管制養狗 (con'td 續)

- Registered dogs dropped from 13 300 to 5 500 已登記的狗隻數字已由13 300下降至5 500
- 2012 tenants allotted points 470 2012年被扣分租户 - 470名
