

**Proposed creation of one supernumerary post in the  
Central Policy Unit (CPU) as Assistant Secretary to the  
Commission on Strategy Development (CSD)  
(EC(2012-13)23 and 23A)**

Our replies to the questions raised by the Establishment Subcommittee (ESC) members on 20 March 2013 are as follows:

- (a): Subjects discussed and concrete results of the work of CSD in the past years.**
- (b): List of papers, reports, researches and analyses released by CSD in the past years, and means through which the public can access these materials.**

Reply to (a) & (b): The CSD was established in 1998. The subjects of discussion of CSD covered a comprehensive range of issues related to the long-term development of Hong Kong, with particular reference to the direction and strategy for Hong Kong's social, economic and political developments. In February 2000, CSD issued a report entitled "Bringing the Vision to Life – Hong Kong's Long-Term Development Needs and Goals" which contained an overview of CSD's thoughts on the issues that would impact on Hong Kong's development over the next 30 years. This report had been uploaded onto CPU's website for reference by the public. To enhance the transparency of CSD's discussion, all documents of CSD meetings since 2005 including the agenda, discussion papers and summaries of views expressed at meetings had been uploaded onto CPU's website for reference by the public. Subjects discussed by CSD since 2005 and the relevant discussion papers (including summaries of views expressed at meetings) are listed at Table (I) of **Annex 1**; and subjects of open research reports of CSD are listed at Table (II) of **Annex 1**. Members of the public can download these documents from CSD's webpage on CPU's website.

As regards the question on concrete results of the work of CSD, we have already explained at the ESC meeting that CSD was an advisory body and not an executive body. CSD provides a platform to gather views on strategic issues related to Hong Kong's long-term development from members who come from various sectors of the community, in order to facilitate policy bureaux in their consideration and formulation of relevant policies. The Chief Executive, the Secretaries, policy bureaux and other public bodies concerned attach great importance to suggestions of CSD. For example, the Chief Executive and the Financial Secretary have consulted CSD when drafting the annual Policy Address and Budget; and the Development Bureau and the Airport Authority have consulted CSD on land supply and airport development issues respectively to listen to ideas from various sectors. Therefore, views of CSD have made an impact on important policies of Hong Kong, enabling them to better meet society's needs.

**(c): Information on the occupation and affiliation with political parties, if applicable, of each non-official member of the current term of CSD.**

Reply to (c): Membership list of the current term of CSD, with the occupation of each member listed, is at **Annex 2**. The Government has invited outstanding talents from various sectors who have a macro perspective and long-term vision, as well as strong commitment, to join CSD. The objective is to gather from various sectors inputs for strategic issues related to Hong Kong's long-term development, so as to establish a foundation for formulation of policies in the future. In inviting members to join CSD, the Government has fully considered their areas of expertise, commitment to society and experience in serving the community in order to appoint the most suitable people. Whether members had affiliation with political parties was not a factor considered when appointing the members. We have not collected information on members' affiliation with political parties, and are therefore unable to provide such information.

**(d): Clarification on the previous remark made by Mr SHIU Sin-por, Head of CPU that CPU was the “government's political tool”.**

Reply to (d): As clarified by Head, CPU at the meeting of Panel on Public Service on 19 November 2012, he said in a television programme earlier that CPU was “government's tool” based on the fact that CPU is a Government body, and its job is to serve the needs of the Government and the community.
