Special meetings on 4 January 2013

**Motion on the notice requirement in respect of amendments to the
Finance Committee Procedure,
Public Works Subcommittee Procedure and
Establishment Subcommittee Procedure**

Further to circulars LC Paper Nos. FC29/12-13 and FC39/12-13 issued on 31 October and 9 November 2012 respectively, the Chairman has directed that two special meetings be held **on Friday, 4 January 2013** to deal with the unfinished business of the meeting on 2 November 2012 in relation to the motion on the notice requirement in respect of amendments to the Finance Committee Procedure, Public Works Subcommittee Procedure and Establishment Subcommittee Procedure. The agenda for the meetings is attached.

2. The two special meetings of the Finance Committee (FC) on 4 January 2013 will each last for two hours with details as follows –

- (a) the first FC meeting will be held immediately after the House Committee meeting scheduled for the same day at 2:30 pm;
and
- (b) the second meeting will start 10 minutes after the first FC meeting.

3. The meetings of the FC will continue with the joint debate on the motion. Each member may only speak once in the debate and the speaking time limit for each member is 15 minutes. I set out below the procedure of the meeting for members' reference –

- (a) the Chairman calls upon the following members who intend to move amendments and who have not yet spoken at the meeting on 2 November 2012 to speak:

 - (x) Dr Hon Fernando CHEUNG Chiu-hung;
 - (xi) Hon Frederick FUNG Kin-kee;
 - (xii) Hon Kenneth LEUNG;
 - (xiii) Hon Charles Peter MOK;
 - (xiv) Hon Gary FAN Kwok-wai;
 - (xv) Hon IP Kin-yuen;
 - (xvi) Dr Hon Joseph LEE Kok-long; and
 - (xvii) Hon LEUNG Yiu-chung;
- (b) the Chairman invites other members who have not yet spoken at the meeting on 2 November 2012 to speak;
- (c) in accordance with Rule 34(5) of the Rules of Procedure, the Chairman has decided that he will call upon members to move their respective amendments in accordance with the order shown in the agenda;
- (d) the Chairman invites Hon Albert CHAN Wai-yip to move his first amendment to the motion, and forthwith proposes and puts to vote the question on Hon Albert CHAN Wai-yip's first amendment;
- (e) after Hon Albert CHAN Wai-yip's first amendment has been voted upon, the Chairman deals with the rest of the amendments proposed by members; and

- (f) after all amendments have been dealt with, the Chairman puts to vote the question on the motion, or the motion as amended, as the case may be.
