Special meeting on 2 November 2012

**Motion on the notice requirement in respect of amendments to the
Finance Committee Procedure,
Public Works Subcommittee Procedure and
Establishment Subcommittee Procedure**

Further to LC Paper Nos. FC11/12-13 and FC22/12-13 issued on 22 and 26 October 2012 respectively, the Chairman has given permission for 24 members to move a total of 1 244 amendments to the motion on the notice requirement in respect of amendments to the Finance Committee Procedure, Public Works Subcommittee Procedure and Establishment Subcommittee Procedure. As directed by the Chairman, the respective amendments will be printed in the terms in which they were handed in on the agenda of the Finance Committee meeting **on 2 November 2012 which will be held immediately after the House Committee scheduled for the same day at 2:30 pm.** The meeting will last for two hours. An updated agenda is attached. In case the motion debate cannot be finished, it will be carried over to the next meeting or, if the Chairman decides, to a special meeting.

2. The Chairman will order a joint debate on the motion and the amendments. Each member may only speak once in the debate and the speaking time limit for each member is 15 minutes. To assist members in debating the motion and amendments, I set out below the procedure to be followed during the debate:

- (a) the Chairman speaks on the motion;
- (b) the Chairman moves and proposes the question on the motion;
- (c) the Chairman calls upon the members who intend to move amendments to speak in the following order, but no amendment is to be moved at this stage:

 - (xvii) Dr Hon Fernando CHEUNG Chiu-hung;
 - (xviii) Hon Frederick FUNG Kin-kee;
 - (xix) Hon Kenneth LEUNG;
 - (xx) Hon Charles Peter MOK;
 - (xxi) Hon Gary FAN Kwok-wai;
 - (xxii) Hon IP Kin-yuen;
 - (xxiii) Dr Hon Joseph LEE Kok-long; and
 - (xxiv) Hon LEUNG Yiu-chung;
- (d) the Chairman invites other members to speak;
- (e) in accordance with Rule 34(5) of the Rules of Procedure, the Chairman has decided that he will call upon members to move their respective amendments in accordance with the order shown in the agenda;
- (f) the Chairman invites Hon Albert CHAN Wai-yip to move his first amendment to the motion, and forthwith proposes and puts to vote the question on Hon Albert CHAN Wai-yip's first amendment;

- (g) after Hon Albert CHAN Wai-yip's first amendment has been voted upon, the Chairman deals with the rest of the amendments proposed by members; and
- (h) after all amendments have been dealt with, the Chairman puts to vote the question on the motion, or the motion as amended, as the case may be.

3. Given the large number of amendments and to economize on the use of paper, the amendments will be issued to members **by e-mail only**. In addition, the amendments and this circular are uploaded onto the Legislative Council website to facilitate members' reference.
