Report No. 11/12-13 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire on 27 February 2013.

Subsidiary legislation considered

2. The House Committee has considered the following items of subsidiary legislation -

3. The House Committee formed a subcommittee to study item (1) in detail at its meeting on 4 January 2013. The Subcommittee reported its deliberations to the House Committee on 8 February 2013 vide LC Paper No. CB(4)363/12-13.

4. In respect of items (2) to (4), the House Committee considered it not necessary to form any subcommittee to study these items of subsidiary legislation.

Note: The House Committee formed four subcommittees to study eight items of subsidiary legislation at its meeting on 8 February 2013. The Council passed on 20 February 2013 four resolutions moved by Hon Andrew LEUNG, Chairman of the House Committee, to extend the scrutiny period of these eight items of subsidiary legislation as follows:

(a) The 1st resolution to extend the scrutiny period of the following item of subsidiary legislation to 20 March 2013:

- Personal Data (Privacy) (Amendment) Ordinance 2012 (Commencement) Notice (L.N. 5/2013);*

(b) The 2nd resolution to extend the scrutiny period of the following five items of subsidiary legislation to 27 March 2013:

- (i) Companies (Words and Expressions in Company Names) Order (L.N. 7/2013);*
- (ii) Companies (Disclosure of Company Name and Liability Status) Regulation (L.N. 8/2013);*
- (iii) Companies (Accounting Standards (Prescribed Body)) Regulation (L.N. 9/2013);*
- (iv) Companies (Directors' Report) Regulation (L.N. 10/2013);*
- (v) Companies (Summary Financial Reports) Regulation (L.N. 11/2013);*

(c) The 3rd resolution to extend the scrutiny period of the following item of subsidiary legislation to 27 March 2013:

- Securities and Futures (Contracts Limits and Reportable Positions) (Amendment) Rules 2013 (L.N. 13/2013); and*

(d) *The 4th resolution to extend the scrutiny period of the following item of subsidiary legislation to 27 March 2013:*

- *Residential Properties (First-hand Sales) Ordinance (Commencement) Notice (L.N. 14/2013).*
