Report No. 19/12-13 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire on 26 June 2013.

Subsidiary legislation considered

3. The House Committee formed a subcommittee to study item (11) at its meeting on 31 May 2013. The Subcommittee made a verbal report to the House Committee on 14 June 2013, and provided a written report vide LC Paper No. CB(2)1405/12-13 issued to Members on 19 June 2013.

4. In respect of items (1) to (10) and (12), the House Committee considered it not necessary to form any subcommittee to study these items of subsidiary legislation.

Note: The House Committee formed two Subcommittees to study the following items of subsidiary legislation at its meeting on 31 May 2013. The Council passed on 19 June 2013 two resolutions moved respectively by the Chairmen of these Subcommittees, to extend the period for amending these items of subsidiary legislation to 17 July 2013. The third batch of six items of subsidiary legislation made under the new Companies Ordinance as listed below are being scrutinized by the Subcommittee formed by the House Committee on 8 February 2013 to study the relevant subsidiary legislation.
