# I. Election of Chairman (and Deputy Chairman)

Election of Chairman

Action

- Mr Frederick FUNG, the incumbent Chairman, called for nominations for the chairmanship of the Subcommittee on Poverty ("the Subcommittee"). 		In response to the major views and concerns of deputations, the Administration gave a succinct brief on its paper and advised that –	
		Employment support

		(a) the effectiveness of the suggestion of providing tax concession to encourage more employers to hire persons with disabilities was in doubt as almost 90% of registered corporations did not need to pay any tax and staff costs were counted as deductible expenses in calculating taxpayer's assessable profits;	
		(b) according to international experience, most of the overseas countries which had introduced an employment quota system considered the system unsuccessful in helping persons with disabilities secure employment and integrate into the community;	
		(c) on the premise that persons with disabilities should be assisted to find appropriate jobs on the basis of their abilities, the Administration would continue to provide more incentives and support to employers and strengthen employment support services to promote the employment of persons with disabilities;	
		(d) the Social Welfare Department ("SWD") would examine its coordination with the Labour Department ("LD") in providing employment support services for persons with disabilities;	
		(e) SWD would examine the feasibility of extending the period of the post-placement service for persons with disabilities, taking into account the financial and manpower implications as well as the efficacy in doing so;	
		(f) since 2001, the "Enhancing Employment of People with Disabilities through Small Enterprise" Project had supported the set up of 91 social enterprises ("SEs"). Among them, 71 were still in business and only some 20 had closed down, largely owing to expiry of leases;	
		(g) SWD had launched the "Financial Support Scheme for Self-help Organizations of Persons with Disabilities/Chronic Illnesses" since 2001 to support Self-help Organizations. These organizations could also make use of the funding support to create employment opportunities for their members;

		(h) the objectives of sheltered workshop service were to provide persons with disabilities who were not able to enter into open employment with appropriate vocational training, and to enhance their working capacity so that they could move on to open employment wherever possible;	
		(i) LD received 9 361 job vacancies for job seekers with disabilities in 2014. About 60% of them were professional, managerial and clerical jobs, which were the preference of most of the registered job seekers with disabilities. LD would continue to strengthen employment support services for persons with disabilities, particularly those with higher educational qualifications;	
		(j) LD had already followed up 殘疾人士及長期病患者就業關注組's concerns in respect of services provided by the Selective Placement Division. LD would continue to provide quality employment services to job seekers with disabilities;	
		Financial assistance	
		(k) the "pilot scheme on living allowance for carers of the elderly persons from low income families" ("the pilot scheme on carer allowance") was launched in June 2014. During the two-year pilot period, the Administration would closely monitor the development of the scheme, evaluate its effectiveness and its long term implications for policies on carers. The evaluation would include whether the corresponding initiatives were applicable to persons with severe disabilities;	
		(1) families constituted the core units of a community, hence members of the same family should render assistance and support to each other. Based on this principle, applicants for the Comprehensive Social Security Assistance ("CSSA"), including persons with disabilities who lived with their families, were required to submit applications on a household basis;	
		(m) it was more effective to address special needs of persons with disabilities through targetted measures, such as the regularized assistance programmes on "special subsidy

		to persons with severe physical disabilities for renting respiratory support medical equipment" and "special subsidy to persons with severe physical disabilities for purchasing medical consumables related to respiratory support medical equipment";	-
		(n) private charitable funds were complementary to public funds in the provision of financial assistance to non-CSSA persons with disabilities;	
		Community care services	
		(o) regarding the man who became paralyzed after a stroke mentioned by the Forthright Caucus Current Affairs Group, SWD had recently provided him with the Home Care Service for Persons with Severe Disabilities, and exercised discretion to approve his application for CSSA on individual basis to relieve stress of his carer and the financial burden of his family. The Administration would endeavor to enhance community care services to help persons with disabilities living in the community;	
		Surveys	
		(p) there were several limitations of the statistics on persons with disabilities which rendered the Hong Kong Poverty Situation Report on Disability 2013 ("the Report") unable to include data on persons with intellectual disabilities in its analysis. Persons with disabilities who lived in residential care homes and persons with chronic illnesses were also not included according to the definition of disability adopted in the analytical framework. The Administration, however, stressed that it would continue to formulate suitable policies and measures having regard to the special needs of different needy groups, including those not included in the Report;	
		(q) the Census and Statistics Department ("C&SD") had taken a number of measures for conducting the survey on persons with disabilities and chronic diseases in 2013 ("the Survey") to boost up the response rate and enhance the quality of the data collected. However, a certain degree of under-estimation in respect of the number of

		(r) given that the setting of the poverty line took account only of income and the questionnaire of the Survey was rather lengthy which might adversely affect the response rate, the questionnaire did not cover the expenditure patterns of households; and	
		Referral of deputations' views	
		(s) deputations' views would be relayed to the Special Needs Groups Task Force ("SNGTF") and the Community Care Fund ("CCF") under the Commission on Poverty ("CoP") as well as the Rehabilitation Advisory Committee ("RAC") for consideration, as appropriate.	
		Noting the limitations at (p) to (r) above, the Chairman asked the Administration to consider conducting topical surveys to examine the poverty situation of persons with intellectual disabilities and the expenditure patterns of households with members with disabilities.

		The Administration advised that –

		(a) issues relating to the review of DA would be discussed at the meeting of the Panel on Welfare Services in March 2015. The Administration also restated the points set out in (l) and (m) above;	
		(b) according to the Secretary for the Civil Service, the Government compiled statistics on the number of persons with disabilities employed in the Civil Service as at 31 March each year based on the information available to the management of bureaux and departments ("B/Ds"). Currently, the overall percentage was around 2%. Such figure was neither a quota nor a limit for employment of persons with disabilities. The Administration would continue with its efforts in implementing the relevant policy and measures to facilitate the access of persons with disabilities to job opportunities in the Government; and	
		(c) it was intended to start reviewing the Hong Kong Rehabilitation Programme Plan in the current-term Government.	
		For (d), the Administration reiterated its points made at (k) above.

		The Administration advised that HES, which was conducted once every five years, was designed to collect up-to-date information on expenditure patterns of the three broad groups of households covered in the Consumer Price Indices. It was expected that around 6 000 selected households would be successfully enumerated, and the information collected would cover all relevant expenses including those arising from disabilities if applicable. The Administration undertook to
