<u>The Subcommittee</u> deliberated (Index of proceedings attached at **Appendix**).

#### Way forward

Matters relating to the first batch of subsidiary legislation made under the new Companies Ordinance

2. <u>The Chairman</u> concluded that the Subcommittee had completed scrutiny of the first batch of five pieces of subsidiary legislation (L.N. 7 to L.N. 11 of 2013) made under the new Companies Ordinance ("CO"), and the Subcommittee would not move amendments to the subsidiary legislation. <u>The Chairman</u> said that he would make a verbal report on the deliberations of the Subcommittee to the House Committee on 15 March 2013. <u>Members noted</u> that the scrutiny period of the first batch of subsidiary legislation would expire on 27 March 2013, the deadline of giving notice of amendments to the subsidiary regulation was 20 March 2013, and the Secretary for Financial

Services and the Treasury would move resolutions at the meeting of the Legislative Council ("LegCo") of 27 March on the Administration's proposed amendments to Companies (Directors' Report) Regulation and Companies (Summary Financial Reports) Regulation as set out in Annexes A and B to LC Paper No. CB(1)687/12-13(02).

Legislative timetable for the second batch of subsidiary legislation to be made under the new CO

- 3. In reply to the Chairman's enquiry, the Administration advised that the second batch comprising two pieces of subsidiary legislation (i.e. the Companies (Disclosure of Information about Benefits of Directors) Regulation and the Companies (Revision of Financial Statements and Reports) Regulation) to be made under the new CO would be gazetted on 22 March 2013 and tabled at the LegCo meeting of 27 March 2013.
- 4. <u>The Chairman</u> advised that in accordance with the legislative timetable given by the Administration above, the scrutiny period for the second batch of subsidiary legislation would expire on 17 April 2013. In view of the limited time available for scrutiny, <u>members</u> agreed to extend the scrutiny period to 15 May 2013.
