#### Express views on North East New Territories New Development Areas Planning and Engineering Study

The paper CB(1)2207/11-12(03) invites the public to note and express views on the major issues of public concern and the Administration's initial responses. Those issues can be summarized:

- 1. Allegation of "Hong Kong-Shenzhen Unification" and "Selling Out Hong Kong"
- 2. Need or Urgency for the NDAs
- 3. Development Intensity and Public-Private Housing Ratio
- 4. Comments Proposing Specific Amendments to the RODPs
- 5. Implementation Approach and Arrangement of the NDAs Proposal
- 6. Impacts on Existing Residents and Compensation and Rehousing
- 7. Loss of Agricultural Land and Assistance to Displaced Farmers
- 8. Inadequate Public Consultation

Having reviewed most papers of North East New Territories New Development Areas Planning and Engineering Study, our centre staff find that the study adopts concept of sustainable development e.g. long term housing for demand, increase in job opportunities and environmental protection. To satisfy future development, the project (North East New Territories New Development Areas Planning and Engineering Study) is inevitable to face resistances and different voices e.g. Allegation of "Hong Kong-Shenzhen Unification" and "Selling Out Hong Kong", Loss of Agricultural Land and Assistance to Displaced Farmers and etc. From major issues 1-7, our centre has no specific comments. However, major issue 8 seems to be inadequate public consultation, our centre would like to note and comment, even administration initial response in the paper said that different channels had been conducted. A method of convenient sampling via email tested 3 hypotheses (please refer to attached papers) regarding major issue 8.

## Findings and generalization

No one replied with email that the project (North East New Territories New Development Areas Planning and Engineering Study) is known. An adequate public consultation should be known to most HK citizens e.g. previous proposed article 23. It can be concluded that public consultation seems to be inadequate. Under incomprehensive and inadequate consultation, interested stakeholders and someone lead to resistances e.g. Allegation of "Hong Kong-Shenzhen Unification" and "Selling Out Hong Kong", Impacts on Existing Residents and Compensation and Rehousing and etc. In implementation process the finals are disharmonic phenomenon and extreme resistances as a result

#### Recommendation

Based on current social phenomenon, a theoretical concept---Change management---is recommended for consideration to solve coming disharmonic phenomenon and resistances. Change management is an approach to shifting/transitioning individuals, teams, and organizations from a current state to a desired future state. It is a process aimed at helping change stakeholders to accept and embrace changes in their environment. Relevant departments e.g. Planning department, Department bureau and etc establishes funding like Sustainable Development Fund, public environmental education fund etc for different parties e.g. concern groups, to promote the project and educate the public in order to help for minimized resistances and disharmonic phenomenon


