Panel on Education Follow-up to Meeting on 7 February 2013 Pilot Project on Revised School Complaints Handling Arrangements

At the meeting of the Panel on Education held on 7 February 2013, the Administration was requested to provide information on (a) the number of schools involved in complaint cases over the past three years; and (b) among these schools, the number of schools participating in the Pilot Project on Revised School Complaints Handling Arrangements. The information is provided as follows:

In the past three school years (2009/10, 2010/11 and 2011/12), the Education Bureau has handled 413, 311 and 273 filed school complaint cases, which respectively involved 227, 189 and 172 public sector and Direct Subsidy Scheme schools. Amongst these schools, some are participating in the Pilot Project on Revised School Complaints Handling Arrangements. For details, please refer to the attached table.
