Renewal and Monitoring of Private Recreational Leases

Purpose

This paper gives an update on progress with renewing Private Recreational Leases (PRLs) and outlines measures that we will take to improve the monitoring of facilities that operate under such leases.

Background

2. On 13 May 2011 and 8 July 2011, we briefed this Panel on matters relating to the renewal of PRLs.

3. Our policy on PRLs recognises the contribution that private sports clubs and other organisations operating facilities on land granted under PRLs have made to the promotion of sport and the provision of recreational opportunities in Hong Kong. For example –

- Many private sports clubs in particular have invested in facilities and run training programmes for members and non-members alike, without which many sports in Hong Kong would not have had the chance to develop.
- Popular annual sporting events that are enjoyed by various sectors of the community, such as the Rugby 7s (in its initial years), the Cricket 6s, the Hong Kong Golf Open and the International Soccer 7s simply would not exist without the contribution of the host clubs and their members towards the provision of venues and event organisation.
- Regular competitions run by many of Hong Kong's "national sports associations" (NSAs) in sports such as tennis, squash, lawn bowls

and hockey rely heavily upon the facilities provided by PRL lessees, which are made available to members and non-members.

• The sports and recreational facilities operated by lessees cater for a total membership of over 650 000 people. Such facilities help to significantly relieve the pressure on public facilities.

4. To encourage PRL lessees to contribute more to our key policy objectives for sports development - promoting sport in the community; promoting elite sports development; and promoting Hong Kong as a centre for international sports events - we are imposing more stringent requirements in the renewed leases that include requiring lessees -

- (a) To open up their sports facilities to outside bodies¹ for a minimum of 50 hours per month;
- (b) To accept direct requests from outside bodies without the need to go through a "competent authority"²;
- (c) To operate junior membership schemes to allow talented young athletes to join clubs at significantly reduced rates of entry;
- (d) To allow NSAs to use their facilities for training or competition for a minimum of 10 hours per month; and
- (e) Where appropriate, to allow NSAs to use lessees' facilities for hosting international events.

5. In line with our current policy, we are renewing leases for a 15-year term, subject to compliance with conditions including —

- (a) The site not being required for a public purpose;
- (b) There being no significant breach of lease conditions; and
- (c) The lessee having a non-discriminatory membership policy.

Progress with lease renewal

6. Of the 73 PRLs on which we have previously reported, the leases have expired or will expire in three batches – 2011; 2012; and 2013 or after. Two leases³ expired in 2012 have not been renewed due to development plans for the subject sites. Another two leases⁴ in this batch have not been renewed as the facilities at the sites have ceased operation. Currently therefore, the total number of PRLs is 69. (**Annex I**)

7. We have conducted three briefing sessions for lessees on the new lease requirements and we have met individually the lessees of each of the 51 PRLs whose leases expired in 2011 and 2012 to discuss our detailed requirements taking into account the scale and range of facilities available at each lessee's facility. We have also advised lessees explicitly that *there should be no expectation* that their leases would be further renewed when they next expire, and that even if the leases are renewed, they might not be renewed at nominal premium or on the same terms and conditions as before. Our intention is to ensure that we do not prejudice the outcome of the review of the PRL policy (see paragraph 14 below).

Length of term of lease renewal

8. We have considered whether to continue to renew PRLs for 15 years. We have concluded that this is appropriate for the following reasons —

(a) The process of renewing a PRL takes two years or more. New leases take effect retrospectively from the date when the previous lease expired (rather than the date of signing a new lease). If we were to renew leases for a short term of say, three years, we would have to start the process of renewing leases that expired in 2011 and 2012 in 2014 and 2015 respectively. This would conflict with the timescale for and the conduct of the review of PRL policy and give us very little time in which to evaluate properly lessees' compliance with the new lease conditions and the extent to which this has helped further to promote sport and recreational opportunities for the community.

- (b) In our discussions with lessees, the majority have advised that if their leases are renewed for fewer than 15 years, with the implication that following expiry the leases might not be further renewed, they would not be in a position to make any significant investment in the development and maintenance of their facilities or to recruit new members. This would have a deleterious effect on lessees' ability to provide sports and recreational opportunities to their members and the wider community under the enhanced "opening up" arrangements.
- (c) Several of the lessees have a history stretching back over 100 years, have thousands of members and have invested significant amounts in developing facilities. Accordingly, we consider it fair to renew leases for 15 years (from the date of expiry of the current leases) to allow lessees to have sufficient time to prepare for possible major changes (which could include closing down) following the review of the policy on PRLs.
- (d) Reducing significantly the length of the term of lease renewal would be a major policy change. We consider it inadvisable to make such a change as an *ad hoc* decision in isolation without proper justification in the context of a comprehensive review of the PRL policy.

Individual lease renewals

9. All lessees have been required to submit a scheme for opening up their facilities more extensively for use by outside bodies, and lease renewal procedures by the Lands Department have proceeded on the basis of the approved schemes. By the end of May this year, we had approved 47 such schemes and the lease renewal procedures had been completed for seven PRLs. We will renew the remaining leases subject to there being no outstanding breaches of lease conditions.

"Opening up" schemes

10. Notwithstanding the minimum requirement described at paragraph 4(a) above, we have asked lessees to open up their sports facilities more extensively. Following negotiations with individual lessees, we have secured their agreement in most cases to open up their facilities far beyond the minimum of 50 hours per month, as detailed at **Annex II**.

11. As well as providing non-members with a much higher degree of access to their facilities, lessees are required to operate junior membership schemes to allow talented young athletes to join their organisations at greatly reduced levels of entry and subscription. A summary of these schemes, which provide opportunities for young athletes to join sports clubs at significant discounts to ordinary membership fee levels, are at **Annex III**.

Improved publicity and monitoring

12. There has been criticism from several quarters – including a recent report by the Ombudsman – that we have in the past not done enough to publicise the availability to non-members of the sports facilities run by PRL lessees or to monitor lessees' compliance with the relevant lease conditions. We are aware that some outside bodies, especially schools and NSAs regularly use the sports facilities operated by lessees. Nonetheless, we accept that there is scope for enhancing general awareness of the availability of sports facilities, particularly at private sports clubs. Accordingly, we are stepping up publicity on the following fronts —

- (a) We are advertising in the print media (most recently in May this year) the availability of sports facilities at premises operated under PRLs.
- (b) We have asked lessees to provide full information on their "opening up" schemes on their websites.
- (c) The competent authorities have committed to advising outside bodies directly of the availability of sports facilities for hire at lessees' premises.
- (d) We have given detailed information on the "opening up" schemes to eligible outside bodies through the competent authorities. We have also directly informed District Officers and the Sports Federation & Olympic Committee of Hong Kong, China of these arrangements and asked them to pass this information to their stakeholders.

13. As regards monitoring, we have asked all 69 PRL lessees to submit quarterly reports on the utilisation of their sports facilities. We will monitor these submissions and use these as a reference when undertaking the policy review. To improve the monitoring process, we are securing funds to set up

an electronic database. We will conduct random checks on lessees and act on complaints. If we consider that lease enforcement action is justified, we will follow up with the relevant enforcement authority.

Long-term Review

14. We have begun to prepare for a comprehensive review of the PRL policy. We will take account of factors such as sports development needs, land use considerations, the overall utilisation of the sites, the interests of PRL lessees and their members and the wider public interest when formulating the way forward for the policy. We will begin the review in earnest once we have completed the formal renewal process for the PRLs that expired in 2011 and 2012.
