2. Proposed creation of a new permanent post of Chief Regulatory Affairs Manager (D1) under the Office of the Communications Authority

The Administration will brief the Panel on the proposal to create one permanent post of Chief Regulatory Affairs Manager to cope with the additional workload arising from the implementation of the Trade Descriptions (Unfair Trade Practices) (Amendment) Bill 2012 ("TDO Amendment Bill") in 2013-2014. The Administration will seek the ESC's and FC's approval for the proposal afterwards.

3. Licence Fee Reductions for Unified Carrier Licences (UCL), Public Radiocommunications Service Licences and Services-Based Operator Licences Issued under the Telecommunications Ordinance

The Administration and the Communications Authority issued a consultation paper on the proposed licence fee reductions for UCL, Public Radiocommunications Service Licences and Services-Based Operator Licences, with effect from 1 March 2013, on 29 June 2012. The public consultation ended on 30 July 2012. The Administration will brief the Panel on the proposal.

### 15. Spectrum trading

The former Office of the Telecommunications Authority (OFTA) (replaced by the Office of the Communications Authority (OFCA) since 1 April 2012) appointed a consultant to study the feasibility of introducing radio spectrum trading in Hong Kong for facilitating economic and technically efficient use of this scarce public resource. The Administration is examining the recommendations made by the consultant. If it is considered justifiable to pursue the initiative, the Administration will draw up an implementation framework and consult the public, and brief the Panel on the subject accordingly.

## 17. Development of the New Broadcasting House in Tseung Kwan O

At the Panel meeting held on 14 February 2011, the Panel was briefed on the comprehensive package to support the development in the next few years of Radio Television Hong Kong as the public service broadcaster. The Panel agreed that the development of the New Broadcasting House in Tseung Kwan O should be discussed after completion of the relevant feasibility study.

### 18. Review on regulation of person-to-person telemarketing calls

At the Panel meeting on 9 November 2009, the Administration briefed members on the findings of the two opinion surveys commissioned by the former OFTA in respect of person-to-person (P2P) telemarketing calls and the actions to be taken in the light of the information collected from the surveys. Some members doubted whether voluntary self-regulation by the industry by way of the Code of Practice (CoP) would be effective in tackling the problems caused by P2P telemarketing calls and considered it necessary to introduce legislation to regulate such calls.

After consultation with the industry, the former OFTA issued a benchmark CoP with guidelines requesting telemarketers to disclose identity and calling line identification information when making such calls. Telemarketers are also requested to maintain an in-house unsubscribe list for the public to make unsubscribe request.

According to the Administration, industry associations of four business sectors, namely finance, insurance, telecommunications service and call centre, have pledged support for the voluntary self-regulation scheme. The industry associations of insurance companies, banks, restricted licence banks and deposit-taking four major telecommunications operators, two companies, telemarketing industry associations, and major a telecommunications industry association have implemented their The Administration will update the Panel on the progress of the implementation of the voluntary CoP after it has operated for some time.

#### 19. Mobile data charges

In view of the increasing public concern about the rising problem of exorbitant mobile data charges, and the cap on mobile data charges that came into force in the European Union to protect consumers from "bill shock", members suggested that a Panel meeting should be held with the Administration to discuss the matter with a view to drawing up a long-term policy and time-table to regulate mobile data charges. At the Panel's request, the Research Division prepared an information note on the preventive measures of mobile bill shock implemented in the European Union. The information note (IN06/10-11) was circulated to members vide LC Paper No. CB(1)1195/10-11 on 31 January 2011. At the Council meeting on 2 November 2011, Hon Albert CHAN raised a question on complaints about billing of telecommunications services.

The Administration has subsequently advised that mobile operators have implemented various measures to help prevent bill shock, including allowing customers to opt-out of individual services, setting a charge ceiling, setting a usage cap for usage-based mobile services, and alerting the customers through short messages when their pre-determined usage threshold is reached, or when their roaming data usage is triggered. OFCA has also been organizing series of consumer education activities so as to increase consumer awareness on mobile data services. The Administration has further advised that the problem of exorbitant mobile data charges is no longer a major issue of concern. Subject to members' agreement, this item will be deleted from the list.

### 20. Sponsored programme and advertising of a political nature on radio

At the Panel meeting held on 14 June 2010, the Panel was briefed on the current regulatory regime governing advertisement of a political nature and sponsoring of programmes on radio. Subsequent to the former BA's ruling on the sponsorship of a radio programme by a certain political party and a paid radio announcement by a Legislative Council Member, Hon Emily LAU requested that a Panel meeting be held with the Administration, relevant statutory bodies and deputations to discuss the matter.
