Supplementary information on Provision of subsidised residential care places for the elderly and persons with disabilities

Purpose

This paper provides supplementary information in response to Members' requests regarding the provision of subsidised residential care places for the elderly and persons with disabilities.

Background

2. Dr. Hon. Fernando Cheung Chiu-hung and Hon. Tang Ka-piu have separately asked for information related to the provision of subsidised residential care places for the elderly and persons with disabilities vide their letters to the Secretariat of the Legislative Council dated 18 January 2013 (i.e. LC Paper No. $\underline{CB(2)548/12-13(03)}$) and 23 January 2013 (i.e. LC Paper No. $\underline{CB(2)556/12-13(01)}$) respectively.

The Administration's Response

3. Regarding the information requested by Members, the Administration has already provided the projected number of additional residential care places for the elderly, and that for persons with disabilities vide LC Paper No. <u>CB(2)548/12-13(01)</u>. Apart from these additional places, we will continue to seek new resources for increasing

the supply of subsidised residential care places. Separately, we have also provided the number of applicants for subsidised residential care places for the elderly and that for subsidised residential care places for the persons with disabilities, and the respective waiting time as at end-December 2012 in the said paper. As for the other information requested by Members, such is provided in the following paragraphs where available.

(I) The provision of subsidised residential care places

(A)Residential care places for the elderly

4. The number of additional subsidised residential care places which commenced operation from 2007-08 to 2011-12 is provided at <u>Annex 1</u>.

(B)Residential care places for persons with disabilities

5. The number of additional subsidised residential care places which commenced operation from 2007-08 to 2011-12 is provided at <u>Annex 2</u>.

(II) The demand for subsidised residential care places

(A)Residential care places for the elderly

6. Regarding the age profile and type of accommodation of the applicants as at end-December 2012, please refer to <u>Annexes 3 and 4</u>.

7. The number of applicants on the Central Waiting List (CWL), applicants admitted to subsidised residential care places, applicants who withdrew their applications from CWL, and applicants who passed away while waiting for subsidised places in the past five years are tabulated at <u>Annexes 5-8</u> respectively.

(B) Residential care places for persons with disabilities

8. Regarding the age profile of the applicants as at end-December 2012, please refer to <u>Annex 9</u>.

9. The number of admissions and discharges, as well as that of persons on the waiting list for subsidised residential care places for persons with disabilities from 2007-08 to 2011-12 are provided at <u>Annex</u> <u>10</u>.

(III) Identifying sites for residential care homes

(A)Residential Care Home for the Elderly (RCHEs)

10. Among the 11 sites earmarked for the construction of new RCHEs, we expect that the RCHEs at six sites could commence service from 2013-14 to 2017-18. The location and district, nature of the development projects, and the estimated number of available residential care places of these six RCHEs are provided in the table at <u>Annex 11</u>. The number of places to be provided is preliminary estimates and subject to change as we continue to work out the details of the projects.

(B)Residential Care Home for Persons with Disabilities (RCHDs)

11. From 2013-14 to 2017-18, the Social Welfare Department (SWD) has earmarked sites in 14 development projects for the construction of new subsidised RCHDs. The location and district, and nature of development of these 14 development projects, and the estimated number of available residential care places are provided in the table at <u>Annex 12</u>. Given that planned projects in future years are still in the initial planning stage, the type of service and number of places to be provided in each project may change subject to the actual size and design of the premises.

(IV) Residential care homes in Public Rental Housing (PRH)

12. For new PRH development, SWD works closely with the Housing Department (HD) to explore the feasibility of incorporating suitable welfare facilities since the project planning stage. During the feasibility assessment process, SWD will take into account both the local needs and overall demands for subsidised residential care places on the one hand, and consider and balance various factors of the sites and premises in collaboration with HD on the other. Such factors include

the location, allowable area for accommodating welfare facilities, environment such as air quality, transportation and accessibility, conformity to related statutory requirements on fire and building safety, etc.

(A) RCHEs

13. Amongst the six earmarked development project sites as mentioned in paragraph 10 above, two sites are located in PRH estates. Together with the new contract RCHE located at Shek Kip Mei Estate Phase 2, the total number of additional residential care places provided in PRH estates (including both subsidised and non-subsidised places) from 2013-14 to 2017-18 is anticipated to be about 350.

(B)RCHDs

14. Out of the 14 earmarked development projects sites for the construction of new subsidised RCHDs mentioned in paragraph 11 above, 10 sites are located in PRH estates. The total number of additional RCHD places provided in PRH estates from 2013-14 to 2017-18 is anticipated to be about 886.

(V) Progress of the Administration's follow-up on Sites/Premises suggested by the Alliance for the Subvented Residential Care Service

15. A table summarising the status and progress of the Administration's follow-up on the 10 sites/premises put forward by the Alliance for the Subvented Residential Care Service is at <u>Annex 13</u>.

In 2010, a non-governmental organisation made a leasing application to HA for setting up a community learning support centre. The application was eventually approved by HA and the set of premises is not available for welfare use.
3.	Shatin	Site at Kwong Wing Lane near Castello	The subject site is situated on a slope next to an area zoned "Village Type Development" in Tai Lam Liu. In view of the site constraints including the hilly terrain and the lack of proper vehicular access to the site, the Administration currently has no plan to develop the site for welfare use.
