I. Matters arising

(LC Paper No. CB(2)1492/12-13(01))

<u>The Joint Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

2. <u>Members</u> noted the list of follow-up actions required of the Administration and the West Kowloon Cultural District Authority ("WKCDA") arising from the discussions of the Joint Subcommittee at previous meetings.

II. Financial situation of and arrangements for the West Kowloon Cultural District project

(LC Paper Nos. CB(2)1492/12-13(02) and (03), CB(2)1181/12-13(01)-(03) and CB(2)1298/12-13(01))

- 3. <u>Chief Secretary for Administration and Board Chairman of WKCDA</u> ("CS/WKCDA Board C/M") briefed members on the latest financial situation of and the strategy and arrangements to be adopted to implement the West Kowloon Cultural District ("WKCD") project, highlighting the following salient points -
 - (a) the upfront endowment of \$21.6 billion for the WKCD project, less operating and capital expenditures incurred in the past few years, had grown to \$23.6 billion as at March 2013 due to investment returns;
 - (b) WKCDA had made a ballpark estimate of around \$47.1 billion in money-of-the-day prices for the design and construction costs of all facilities. As the WKCD project would span over a long period of time during which fluctuations in costs were inevitable, the ballpark estimate was no more than a mechanical update based on a set of assumptions of cost escalation and was not a revised budget to be adopted for the WKCD project;
 - (c) the increase in the capital costs of the WKCD project was attributed to a number of factors, including high construction cost escalation in Hong Kong in recent years, the inclusion of an integrated basement as an integral part of the approved Development Plan ("DP") of WKCD, enhanced project scope to meet public aspirations reflected during the public engagement exercise on DP, and longer time taken to complete the master planning and planning approval process for WKCD;

- (d) the Administration and WKCDA would adopt a pragmatic approach to implement the WKCD project through rigorous cost containment of individual facilities to a level as close to the recommendations of the Consultative Committee on the Core Arts and Cultural Facilities of WKCD ("CC case") as possible, emphasis on content rather than form of the facilities, and early delivery of the Park as well as some arts and cultural facilities for public enjoyment;
- (e) acknowledging that the integrated basement was an essential feature to meet the statutory minimum requirement for 23 hectares of public open space in WKCD, and that it was not covered in the CC case, the Government planned to fully fund the capital works of the integrated basement as general enabling works to facilitate the development of the whole WKCD project, subject to funding approval by the Legislative Council ("LegCo");
- (f) with a view to optimizing the development potential of the WKCD site and yielding additional gross floor area ("GFA") for various uses, WKCDA was considering to apply for minor relaxation of the GFA and/or building height restrictions (estimated to be around 10-15% of the total GFA of the WKCD site) under section 16 of the Town Planning Ordinance (Cap. 131); and
- (g) despite rising costs, the Administration and WKCDA did not plan to seek additional funding from LegCo to supplement the original upfront endowment in the next few years, until at least completion of the first batch of facilities in WKCD. WKCDA would consult relevant stakeholders on the implementation programme and review in due course the need to seek additional funding in light of any changes in circumstances and WKCDA's continued effort on cost containment.
- 4. At the request of the Chairman, <u>CS/WKCDA Board C/M</u> undertook to provide a copy of her speaking note for the Joint Subcommittee's reference after the meeting.

For instance, LegCo's approval had been sought for providing \$50 million to the Leisure and Cultural Services Department for acquiring and commissioning artworks by local artists. An additional funding of \$150 million had also been earmarked to strengthen the training of arts administrators for five years starting from 2013-2014. 		CS/WKCDA Board C/M advised and explained that -	
		(a) the provision of an integrated basement in WKCD was not contemplated in the recommendations of the Consultative Committee on the Core Arts and Cultural Facilities of WKCD ("CC Case") in 2007, the basis on which LegCo granted the one-off upfront endowment of \$21.6 billion to finance the capital costs of the WKCD project in 2008. The three CPOs for WKCD which featured a basement design were prepared and presented for consultation with the public in 2009-2011, after LegCo's approval of the endowment fund was sought. The basement was an essential feature to meet the statutory minimum requirement for 23 hectares of public open space as specified in the South West Kowloon Outline Zoning Plan;	
		(b) the Financial Advisor engaged by the Government and the Specialist Advisor appointed by LegCo had adopted different financial assumptions to project the estimated costs of the WKCD project back in 2008. The increase in the estimated project costs was mainly attributed to the fact that the macro economic environment (in terms of construction cost escalation, investment returns and inflation rates) in recent years had been very different from the long-term assumptions used in the financial analysis prepared for the CC Case; and	
		(c) instead of granting the naming rights of individual buildings/facilities in WKCD, consideration would be given to making available parts of the facilities (e.g. a gallery or an education facility) for naming with reference to international practice.
